

POLICY DIRECTORS - ACCESS TO DEPARTMENTAL STAFF

1. In order to facilitate the development of policies the Directors will have access to all Departmental Staff as necessary. However, the relevant Regional, District or Service Branch Managers will be advised of the contact as a matter of courtesy.
2. Action proposed from discussions will be initiated through the correct channel i.e. Executive Director to General Manager to Divisional Manager etc.
3. The Policy Directors may arrange a Task Force approach to develop policy or delve into difficult matters, drawing on operational and service branch staff. Appropriate discussion beforehand and continuous briefings of relevant Managers will be undertaken.
4. The Directors will oversee the implementation of proposals before passing responsibility to the Operations Group.

2.2 National Parks

2.2.1 Cape Range National Park

The management of the coastal parts of this Park are integrated with management of Ningaloo Marine Park described below.

Ranger-in-Charge of Cape Range is George Duxbury who is stationed at Exmouth, phone 099 491 428, address P.O. Box 55, Exmouth 6707.

2.2.2 Ningaloo Marine Park

Establishment, planning and initial development are headed by the Director of Nature Conservation, Dr Barry Wilson, and Planning Officer Richard May.

2.3 Proposed Parks and reserves

Proposals for reservation include the Kennedy Ranges and lands and waters in the Shark Bay area.

3. LIAISON WITH ADJACENT REGIONS

The Forest Officers from Karratha (Wally Edgecombe and David McMillan) periodically visit the Exmouth area to provide an advisory service dealing with native trees and shrubs, and to collect seed for Karratha Nursery.

It is possible that sandalwood operations may extend into the Western Gascoyne; maintain liaison with the Regional Manager, Goldfields in this matter.

(ADDENDUM TO INTERIM WORKING ARRANGEMENTS FOR GREENOUGH REGION).

1. INTRODUCTION

1.1 The Management of Gascoyne Region will be shared by Regional Managers, Pilbara and Greenough until such time as Gascoyne regional staff are appointed.

1.2 Areas of responsibility are as follows :-

Regional Manager, Greenough (Western Gascoyne) :
Shires of Carnarvon, Exmouth, Shark Bay, and Upper Gascoyne.

Regional Manager, Pilbara (Eastern Gascoyne) :
Shire of Meekatharra.

2. DEPARTMENTAL LANDS IN THE WEST GASCOYNE

2.1 Nature Reserves

The Nature Reserves in the West Gascoyne are listed by Shires in an attachment to this document.

2.1.1 Cooloomia Nature Reserve

This reserve has been subject to a biological survey reported in Wildlife files. Contacts are Dr Stephen Hooper and Dr Norm McKenzie at Wildlife Research Centre Woodvale.

Past management has consisted largely of inspectorial visits by Wildlife Officer. Contact Wildlife Officer Kingsley Miller (Geraldton) for details.

2.1.2. Shark Bay Islands, and Bernier and Dorre Islands.

Your contact for management recommendations is Research Officer Keith Morris at Karratha.

Transport to the islands can be arranged through the Fisheries Officer based at Denham. Contact in the first instance should be made through Chief Wildlife Officer, David Mell at Como.

2.1.3. For details and locations of other Nature Reserves contact Wildlife Officer, Kingsley Miller and consult Wildlife files in Head Office.
