CONSERVATOR OF WILDLIFE

Attached please find a summary of wildlife officers' comments on the opening of the 1979 duck shooting season. A report from Wildlife Officer Lambert (now on leave) has been mislaid.

The 1 am opening was opposed by all shooters (other than areas which opened at 5 am) even when it was explained that it was generally expected by the Department that shooting would not start until daylight. The more reasonable shooters said that that is what they had interpreted also and they would wait until species were identifiable.

In several areas involving a 1 am opening, by agreement, shooting did not in fact commence before daylight.

In most other areas, shooting commenced at, or just before, 1 am with little or no results. Cloud cover reduced the possibility of shooting in some areas whereas in others, moonlight permitted shooting, but with little ability to identify species or recover birds shot or wounded. Shooting then re-commenced at various hours before and after daylight.

There was a 5 am opening at Wannamal, Coomelberrup and Benger. There was a suggestion by the wildlife officer at Wannamal that the shoot should have started there half an hour after sunrise to eliminate the accidental shooting of protected species. Some shooting started at Benger (private property) at 4.30 am. Most shooting at Benger commenced at 4.45 am. Some persons were apprehended.

At Coomelberrup no shooters were present. No problems.

At Wannamal (5 am opening) one shooter was accidentally shot in the hindquarters without serious complications. No other accidents were reported from any other area where wildlife officers were present.

At all of the three aforementioned areas, shooters expressed dissatisfaction with the bag limits, but after explanation to the Wannamal shooters begrudged acceptance was noticeable. Benger shooters felt that more game species could have been granted because of the "one shoot weekend" when most shooting occurs.

As a general rule, shooters were dissatisfied with the bag limit. This criticism, I feel, was highlighted because many shooters would only get the "one shoot" and to travel long distance with the expense involved for only "3 decent ducks" was unacceptable.

Conservation considered, it was felt that more game species ducks (other than Mountain Duck) could have been included with a consequent shorter season. A shorter season of course would not

be acceptable to all persons, especially residents of country areas who can shoot throughout the season as distinct from the restricted metropolitan shooter.

Another factor affecting the "one shoot for 3 decent ducks" was the \$5.00 license fee for 1979. The combination of these factors produced a lot of criticism.

Others felt that bag limits should be lifted on Mountain Duck and Wood Duck. Many farmers in the South West can destroy these ducks on damage permits because of property and dam pollution. An open bag could have been considered for these. It would also assist those farmers incurring damage. An open bag on Mountain Ducks would probably not mean that any more would be shot, as they are not particularly popular or palatable.

After analysing the wildlife officers' reports it was found that -

- Wildlife Officer recommended a return to a 5 pm Saturday opening.
- Wildlife Officers recommended a return to a 6 pm Saturday opening.
- Wildlife Officers agreed with the 1 am opening because of the conservation of the ducks.
- Wildlife Officers recommended an opening in "daylight hours" either 6 pm Saturday or "daylight" Sunday (to facilitate easier enforcement).
- Wildlife Officer recommended a 5 am opening if the opening occurs again on a Sunday.
- Wildlife Officers had no strong particular preference, but I believe would rather have shooting in "daylight hours".

In my comments at the last meeting of the Bird Committee on December 20, 1978, I said that irrespective of opening times, enforcement would always be a problem.

I now believe that any 1 am opening is not a suitable time and in future seasons the opening times should be restricted to "daylight hours". Whether it be a 5 pm or 6 pm opening on the Saturday evening, or 5 am or daylight opening on the Sunday. The changes in Saturday or Sunday opening will obviously be as a result of aerial surveys and recommendations by the Waterfowl Research team.

Another thought submitted by wildlife officers was that an aerial survey should be carried out just prior to the season so that the distribution of ducks and the lakes which carry the most water could be noted and passed to wildlife officers so that enforcement deployment can be better calculated.

I feel that the question of bag limits will always be difficult to allocate and will obviously depend on good and bad breeding

seasons, which in turn are dependant on good or bad winters.

I do believe, however, that in the cases of bad breeding seasons and if a season is declared, a shorter season with an increase of edible ducks should be considered. Conservation would be served by the reduction of shooting time.

In all, complex questions which arise can only be sorted out annually when surveys and seasons are analysed. However, I cannot see myself agreeing to a l am opening again. Some reasons for this are listed, i.e. -

- 1. Shooters who commenced before 1 am could not be located.
- Terrain and geography of areas, in darkness, difficult to negotiate.
- 3. Easier for shooters to hide total (if any) ducks taken.
- 4. Identification of other protected fauna, rare species and non game species impossible (specifically prohibited to shoot until able to identify).
- 5. Many shooters thought we expected them to start at 1 am rather than our thoughts to wait until daylight.
- 6. When ducks shot or wounded many would be unrecoverable because of darkness. Also, fall flight cannot be accurately determined.
- 7. Moonlight in some areas allowed the shooting to commence at 1 am (or before) and not as anticipated - at first ' light. In other areas darkness limited the 1 am opening.
- Checking of shooters/licenses, difficult for wildlife officers as many arrived after dark and during the night.
- High risk factor evident for all persons present with firearms and alcohol.
- 10. 1 am opening encourages shooters to shoot at "sitting ducks" (specifically prohibited).
- 11. Night shooting generally is discouraged (see Duck Shooter's Guide information to shooters).

Another suggestion by wildlife officers was that duck shooter's licenses not be granted to persons who do not hold a Firearm's License. Some persons believe that possession of a duck shooter's license because of the specific requirement to use a shotgun automatically means they can get a Firearm's License. Fremantle Police have rejected some applicants because of their unsuitability as license holders. A change in regulations should be made to make the applicant for a duck shooter's license produce a current firearm license before the duck shooter's license is issued. I agree with that suggestion.

. Approximately 12 prosecutions are pending involving -

- 1. Exceeding the bag limit.
- 2. Shooting rare ducks.
- 3. Shooting before season opened.
- 4. Shooting other protected fauna

I trust the foregoing comments are satisfactory and suitably explained for your edification.
