

#### INTRODUCTION

This document summarises submissions to the Draft Management Plan (DMP) for Walpole-Nornalup National Park as required under Sections 58-60 of the Conservation and Land Management Act (1984). Comments have been detailed to the section of the DMP to which they refer.

The Walpole-Nornalup National Park DMP was released for public comment on 22 July 1990 by the Minister for the Environment, Hon. Mr R. J. Pearce, MLA. The plan was available for comment for a period of two months to 24 September 1990 and then extended for a further month to 24 October 1990. All submissions have been summarised and changes have been made to the plan where appropriate.

During the compilation of the DMP, input was invited from the public, conservation and recreation groups, organisations and Government departments. In particular, the Karri-D'Entrecasteaux Regional Advisory Committee (with the addition of nine co-opted local people) participated in the workshops and had several meetings to discuss major issues of the plan, including zoning, overall goals, recreation, access and the Wilderness Area. This Committee played a major role in the formulation of the DMP. Other State Government management agencies were also involved.

Following the release of the plan, advertisements were placed in local and statewide newspapers advising that the DMP was available for comment. The DMP was distributed to State Government departments, tertiary institutions, conservation and recreation groups, local authorities, libraries and numerous individuals. Copies of the plan were available for perusal at several libraries and available for purchase from CALM's State Operations Headquarters, Crawley Office and Walpole District Office.

#### ANALYSIS OF PUBLIC SUBMISSIONS

#### **Methods of Analysis**

The public submissions to the Walpole-Nornalup National Park Draft Management Plan were reviewed in three stages:

- Public submissions were summarised to allow analysis (this document);
- The submissions were assessed using the criteria below;
  - 1. Changes were made to the DMP if a submission:
    - a) provided additional information on the physical, biological, geographical or cultural resources of direct relevance to management;
    - b) provided additional information on affected user groups, or on social or economic resources of direct relevance to management;
    - c) indicated a change in, or clarified government legislation, management commitment, or management policy;
    - d) proposed improved, additional, or deletion of recommendations that would better achieve management goals and objectives; or
    - e) indicated omissions, inaccuracies or a lack of clarity in the existing text or recommendations.

- 2. Changes were *not* made to the DMP if:
  - a) a submission clearly supported the draft proposals, or no change was sought;
  - b) a submission addressed issues beyond the scope of the plan;
  - c) a submission made points which were already in the plan, or had been considered during plan preparation;
  - d) existing strategies and recommendations appeared to be the most practical where submissions were strongly polarised or where departmental resources are limited.
- The DMP was reviewed and amended where necessary. Numerous minor editorial changes referred to in the submissions have also been made.

Comments made in submissions have been assessed entirely on the cogency of points raised. No subjective weighting has been given to any submission for reasons of its origin or any other factor which would give cause to elevate the importance of any submission above another.

#### **Number and Origin of Submissions**

Most submissions were 'substantial', with only one petition being received. The number and place of origin of submissions are listed below.
