1. INTRODUCTION

This document describes the Permit System for caving within the Leeuwin Naturaliste National Park (L.N.N.P.). The Introduction of the System was a recommendation of the L.N.N.P. Management Plan approved by the Minister in February 1989. Because no details of the Permit System were available for public comment during the Management Plan, it was released for comment once a Draft was available.

Over 200 copies were posted out to interested individuals and groups. In addition approximately 100 other copies were distributed via public counters. Thirty one submissions were received and have resulted in changes to the original Draft. A separate summary of public submissions is available showing all issues raised and whether they were accepted or rejected.

CALM's objectives in introducing a Cave Permit System for the L.N.N.P. are to:

- Improve Cave Safety All Adventure Caves (A.C.) will have safety information provided on site relevant to caving generally and each cave specifically.
- 2. Conform to the L.N.N.P. Management Plan recommendation which has public endorsement.
- Improve Cave Conservation the new system puts the bulk of the caves into the Restricted Access (R.A.) classification. Access into the caves will require an approved trip leader, (with the exception of Adventure Caves Class I and IV) to ensure trips are undertaken in a responsible manner.
- Educate users on all aspects of caves by;
 - a) Information Signs
 - b) Guided Adventure Cave Tours
 - c) Ensuring Trip Leaders conform to minimum standards.
 - d) Detailed handouts on the New System.
- 5. Raise Revenue on a user pays basis that will be used to rehabilitate/conduct research and monitor caves within the Park.
- Obtain data on numbers of users into the various types of caves by;
 - a) Numbers of permits issued
 - b) Log books at cave entrances
 - c) Monitoring devices within caves
 - d) Returns from commercial concessionaires
 - e) Tourist cave returns

The recommendations and systems outlined in this document will be in place for the period 1991 - 2001. It is however envisaged that as the system develops, caves may be added or deleted from classifications. The trip leader status for Restricted Access Caves has been a most difficult system to put in place. If an improved trip leader approval system becomes available, then the two systems currently in place will be reviewed. Classifications within the Restricted Access Caves may be reviewed earlier than the 10 years.

The leasing of Calgardup on a 12 months trial as a Commercial Adventure Caves was a difficult decision. The sequence of events has not facilitated a public airing of this proposal, but public comments will be sought after the 12 months trial. If the trial is deemed successful all members of the public will be invited to submit an interest in managing the future lease. No additional caves will be considered for lease as commercial Adventure Caves within the life of the plan.

2. <u>CAVE CLASSIFICATIONS</u>

There are three broad cave classifications within the Leeuwin Naturaliste Ridge.

- 1. Tourist Caves
- Adventure Caves
- Restricted Access Caves

Each <u>broad classification</u> has different access guidelines. This plan focuses on Adventure Caves and Restricted Access Caves.

- 1. <u>Tourist Caves</u> These commercial caves are on land vested with the tourist bureau in each of the Shires. They are responsible for the daily Management of Mammoth, Lake, Jewel Caves and Yallingup.
- Adventure Caves Class I These are suitable for inexperienced cavers to undertake a caving experience at their own discretion and pace. Their selection has been based upon the following criteria;
 - 1. Historical usage has been high.
 - 2. Relatively safe cave.
 - 3. Not easy to get lost.
 - 4. No vertical entrances.

Entrance is free provided a users register is signed and safety rules are followed. Donations will be encouraged to assist with maintenance of each cave.

- 3. Adventure Caves Class II These are Non-Vertical Caves requiring a Permit before entry. They offer more of a challenge and require an approved trip leader. There are limits on group sizes for each cave and the number of trips per year.
- 4. Adventure Caves Class III These are Vertical Entry Caves.

 Approved Trip leaders need to be competent guides in roping/laddering techniques. A Permit is required before entry.
- 5. <u>Adventure Caves Class IV</u> This is a Commercially Managed Cave, leased for a fixed term under strict conditions governing acceptable management practices.
- 6. Restricted Access Class I Wild Caves. This class contains the majority of caves. Generally speaking they are poorly documented or cannot readily be classified in other categories. All caves as yet undiscovered will automatically, for an initial period, fall into this category. The Management objective of this category is to promote investigation of all cave values so that any future re-classification is based upon complete resource knowledge.
- 7. Restricted Access Class II Dangerous Caves. These are caves that are known to have extra hazards. They are grouped to protect human life by ensuring visits are only by very skilled persons, infrequently. Some caves could have access banned.
- 8. Restricted Access Class III Reference Caves. This category provides for strict protection of relatively undisturbed caves to provide baseline sites for monitoring. Reference caves will be representative of wider classes of sites.
- 9. Restricted Access Class IV Scientific Caves. Caves in this category are set aside because of their special relevance to science.
- 10. Restricted Access Class V Locked Caves. These are <u>listed</u> separately only because they require special approval to gain access. All locked caves are accessible only if a trip leader is approved by the Caves Access Committee (C.A.C.). Locked caves belong to any of the above classes.

3. ACCESS: ADVENTURE CAVES

Adventure Cave Class I

Objectives:

- # to facilitate aesthetic appreciation and physical recreation
- # to select a limited number of caves for inexperienced persons to enjoy
- # focus beginners into these caves least likely to get them lost or hurt.
- # encourage the use of all safety equipment and practices
- # facilitate access into a cave of relatively large groups
 (maximum of 20)

Access:

Any number of the public will have freedom of entry without payment

Management:

- # safety will be emphasised by displaying safety standards at all entrances
- # rules will be displayed at the entrance
- # impacts will be monitored to detect any deterioration of the caves
- # a donation box will raise revenue for cave maintenance
- # caves may be withdrawn or added to

Objectives:

- # to facilitate aesthetic appreciation and physical recreation
- # to facilitate access to caves with greater degrees of difficulty than Adventure Caves Class I
- # to raise revenue to enable ongoing cave maintenance
- # to control numbers of users

Access:


- # a booking system has been established through the Margaret River Tourist Bureau
- # all trips need to have an <u>authorised trip leader</u> (see appendix VI for details on how to get trip leader status) and get a permit
- # all trips <u>must</u> be paid for through the Margaret River Tourist Bureau prior to entry
- # fees are \$2.00 per head per cave on the day or at the reduced rate of \$1.00 per head per cave if booking is done two weeks in advance to ensure the availability of a particular cave

Management:

- # the Margaret River Tourist Bureau administers the cave permit system on behalf of C.A.L.M. Any complaints should initially be brought to the bureaux attention. The District Manager of Busselton's CALM office will adjudicate on any large problems
- # once a trip leader for AC II or III is approved it is valid for 2 years
- # there is no fee to attain trip leader status at this stage
- # a notice at the entrance of all AC II and III will remind people that a permit is required prior to entry
- # a review of all caves in this category will be periodically undertaken as information is gathered

ADVENTURE CAVE CLASS IV

Objectives:

- * Provide opportunity for physical recreation and athletic appreciation in a controlled group.
- * To raise revenue for cave rehabilitation.
- * To provide better protection to an existing heavily used adventure cave.
- Increase user awareness of the value of caves.

Access:

- * Any individuals or groups will be able to enjoy a caving experience under the guidance of the lessee.
- * A fee will need to be paid to the lessee.

Management:

- * The leased cave will provide another recreation opportunity while raising funds to rehabilitate Calgardup and other caves.
- * Lease will be evaluated before a lease is re-negotiated. Evaluation will be based upon;
 - a) Positive and negative impacts on Calgardup.
 - b) Any negative impacts on other caves as a result of Calgardup not being freely available.
 - c) Public response to the leasing of caves.

4. ACCESS: RESTRICTED ACCESS CAVES CLASS I - V

Objectives:

- * The majority of caves are classified into the Restricted Access (R.A.) category to ensure that visitation is under the Leadership of experienced speologists.
- * Restricted Access Caves have various categories to highlight their purpose and consequential management practices. (See Section 3).

Access:

There are two broad types locked and unlocked, both will require a Permit from C.A.L.M. at no cost currently.

Management:

A. Locked Caves:

These caves have the best formation within the park (generally speaking) and have been locked for a variety of reasons largely by speological clubs. The existing system for access has not changed. Access to locked caves requires an application to the Cave Access Committee (C.A.C.) with a trip proposal. The trip leader needs to lodge \$5 with the C.A.C. upon application to cover costs. The C.A.C. recommend to C.A.L.M. that a Permit be issued or not issued.

Membership of the C.A.C. is as follows (see Appendix II).

- * Two representatives of each A.S.F. affiliated speolo club in W.A. (4 people)
- * One C.A.L.M. representative.

An approved trip is one where at least three representatives approve of the proposed trip. The trip leader is effectively evaluated by his peers based on their knowledge of his experience ability to organise a trip, and whether the trip satisfies the purpose for which the cave has been allocated.

Access into locked caves is very low as shown in Appendix V. Records of all trips undertaken are kept by C.A.L.M. as the permit is issued. Details of why the trip was undertaken and any results are also held by C.A.L.M.

Locked caves cover all categories and are indicated by an asterisk on any listings. The Cave Advisory Committee for the L.N.N.P. is to put together a policy for C.A.L.M.'s endorsement on when a cave should be locked. Historically caves have been locked on an opportunistic basis and all locked caves will be reviewed.

B. Unlocked Caves:

Unlocked restricted access caves are available to any groups that have an approved trip leader.

An approved trip leader is a person who:-

- a) is a member of a W.A. Speological Club affiliated to Australian Speological Federation (A.S.F.) OR
- b) is an associate member of A.S.F.
- c) has successfully completed a written and practical course set up by C.A.L.M. through the Cave Advisory Committee.

A trip leader will be a person with experience, interested in taking groups through a cave for a specific purpose.

Trip Leader Testing:

Theory:

Applicants will be asked to complete one of four alternative papers designed to test the depth of knowledge, safety, etc. Theory tests will be run by CALM three times a year. Guidelines on what is covered in the tests will be available on request.

Practical:

Persons who successfully complete the theory paper will need to complete practical tasks before an examining panel, drawn from a wide source of experienced W.A. cavers. The Examining Panel will be rotated periodically but selected by the Cave Advisory Committee for the L.N.N.P. on behalf of C.A.L.M.


Persons under 18 years old will not be granted trip leader status. Approved trip leaders for R.A. category need to apply to the Margaret River Tourist Bureau for access. No fee is applicable currently.



- 1. Maximum and minimum numbers to be observed.

 Maximum numbers vary (see below) but minimum number is three.
- 2. A minimum of one light source and one candle per person.
- 3. Clothing and footwear should be robust, Helmets are to be worn.
- 4. Cave formations must not be handled.
- 5. Any damage in the cave should be reported to the Busselton CALM Office. Telephone 097 521677 or the Margaret River Tourist Bureau. Telephone 097 572911.
- 6. Follow obvious or marked trails at all times..
- 7. Trip leaders are responsible for ensuring fees are paid for all members in the party and the group conduct their trip in a responsible manner.

APPENDIX IX

FINDERS RIGHTS

Finders Rights were queried in several of the public submissions received. The Cave Advisory Committee thought the issue important enough to include it in an appendice.

Finders Rights cover both the finding of a New Cave or finding a new extension to a known cave.

"Rights" have been extended to finders in the hope they will impart the knowledge to CALM as the Managing Authority as soon as the discovery is made. There can be NO legal claim to discoverers but CALM will acknowledge finders rights and abide by the following guidelines.

- 1. Finders will be given adequate time to fully explore new sites before the cave/extension is placed into the Restricted Access $Class\ I$ category.
- 2. Finders are asked to minimize cave impacts by ensuring:-
 - 2.1 Initial entry is made only if the correct gear and personnel are present.
 - 2.2 The exploratory party is kept small. (4 people max.)
 - 2.3 Correct equipment and personnel.
 - 2.4 Mapping must be done concurrently with exploration and track marking.

Finders are reminded that all impacts will be solely attributed to them!
