## INTRODUCTION

This document is an analysis of public submissions to the draft strategic plan for the Shark Bay World Heritage Property 2006-2020. Comments have been detailed to the section of the draft strategic plan to which they refer.

The Shark Bay World Heritage Property draft strategic plan was released for public comment for a period of two months with submissions closing on 15 December 2006. A total of 21 public submissions were received. All submissions have been summarised and changes have been made to the plan where appropriate.

Following the release of the draft plan, advertisements were placed in local, regional and Statewide newspapers, advising that the draft strategic plan was available for comment. The draft plan was distributed to State Government departments, local government authorities, tertiary institutions, recreation, tourism and conservation groups, libraries, neighbouring property land holders, tourism operators, and numerous individuals who expressed interest during the preparation of the draft plan. Copies of the draft plan were available for perusal at Department and local libraries and local government offices.

## ANALYSIS OF PUBLIC SUBMISSIONS


#### **Method of Analysis**

The public submissions to the Shark Bay World Heritage Property draft Strategic Plan were analysed according to the process depicted in the flow chart (see Figure 1). More specifically:

- \* All comments were collated according to the section of the draft plan they addressed.
- \* Each comment was assessed using the following criteria:
- 1. The draft plan *was* amended if the submission:
  - a. provides additional resource information of direct relevance to management;
  - b. provides additional information on affected user groups of direct relevance to management;
  - c. indicates a change in (or clarifies) Government legislation, management commitment or management policy;
  - d. proposes strategies that would better achieve management goals and objectives; or
  - e. indicates omissions, inaccuracies or a lack of clarity.
- 2. The draft plan will *not* be amended if:
  - a. there is clear support for the draft proposals;
  - b. a neutral statement is offered or no change is sought;
  - c. a submission addresses issues beyond the scope of the plan;
  - d. a submission makes points which are already in the plan or were considered the best option;
  - e. a submission is one amongst several widely divergent viewpoints received on the topic and the recommendation of the draft plan is still considered the best option;
  - f. a submission contributes options which are not feasible, generally due to conflict with existing legislation, Government or Departmental policy;
  - g. was based on incorrect information; or
  - h. involved details that are not appropriate or necessary for inclusion in a document aimed at providing management direction over the long-term.
