Tamra Chapman emailed Alan Hill and Diane Fry on 04 Jan 2008 alerting them that the recovery plan was open to public comment and suggesting that they might consider a note in the <i>WA Fruit Grower</i> . One public submission was received by DEC on 15 Feb 2008 and a response was prepared and forwarded to DEWHA on 19 Feb 2008. Tamra responded to comments and queries by the TSSC on 23 April 2008.
Aim	To stop further decline in the breeding populations of Baudin's Cockatoo and the Forest Red-tailed Black Cockatoo and to ensure their persistence throughout their range in the south-west of Western Australia.
