#### Module 13 Group Project

#### **Rehabilitation Project - DEC Regional Parks**

DEC has obtained funding from Coastwest to remove Victorian Tea-tree and plant local native species within Woodman Point Regional Park.

The funding will enable DEC to almost completely eradicate this serious environmental weed from the regional park and provide opportunities for the **community and in particular local Friends groups** to develop skills and experience with restoration projects whilst fostering local ownership of the park.

The project focuses on both:

- removal of the Tea-tree and
- restoration of the native plant community, being Tuart and Callitris preissii (TEC species).

Over the past few years DEC has been working to:

- re-establish Tuart and Callitris woodlands within the park, as they
  provide important habitat for local fauna including Quenda, local
  reptiles and bird species. Bat species are also known to roost in the
  larger Tuart trees.
- The grant is subject to a significant in-kind contribution from the community and represents an opportunity for DEC to engage with local groups to achieve on ground conservation outcomes within a regional park.

Funding is available for 1 year after which time DEC will fund ongoing works.

The project should include **a monitoring and evaluation component**, which the community could engage in.

A written outline of how to go about this project is required. Your plan should be delivered to the group on Thursday's group feedback session.
