Areas at this date not calculated yet but, includes one property of 18000ha of which 5000ha is *LFW* sites, so will be reaching 30,000ha.

### NOTE for discussion:

- These property owners will be considering biodiversity in ALL areas of land management, not just the remveg
- as an EG, the State Winners of the National Landcare Awards, PRIMARY PRODUCER section, are *Land for Wildlifers*. Their very considerable biodiversity efforts do not detract from their being, this year, the State's top primary producers.
- "Remveg" includes areas of secondary salinity, and also smallish areas of (usually unfenced) remveg which is not specifically called *LFW*, but often has value – especially on a seasonal basis.
- Most properties have large areas of REVEG, which are not included in these totals.

You could therefore infer, that the actual area over which biodiversity conservation is at least being considered, is the total property area, some 200,000 ha.

**Also of interest – extension activities**

Aug/Sept/Oct LFW staff will be either organising (8) or giving talks at (24) Field Days, Workshops, Seminars etc. This is getting the biodiversity message across to other advisers, in particular.
