An Act to amend certain Verbal Errors in various Acts of Parliament and for other purposes.

[16th December 1886.]

WHEREAS certain verbal clerical and typographical errors have been from time to time discovered in various Acts of Parliament, and whereas it is expedient that the same should be corrected, and whereas certain verbal alterations have been necessitated in various Acts of Parliament by subsequent legislation, and whereas it is expedient that the same should be made: Be it therefore enacted by the Queen's Most Excellent Majesty by and with the advice and consent of the Legislative Council and the Legislative Assembly of Victoria in this present Parliament assembled and by the authority of the same as follows (that is to say):—

- 1. This Act may for all purposes be cited as "The Statute Short title. Law Revision Act 1886."
- 2. The amendments specified in the Schedule hereto shall be made Amendments in in the several Acts opposite to the numbers of which such amendments are respectively shown, and the said Acts shall be read and construed accordingly. SCHEDULE.
