# A CALL FOR EXPRESSIONS OF INTEREST IN THE PURCHASE OF HARDWOOD SPECIALITY LOGS

#### INITIATIVE

The Timber Strategy approved by the Government in 1988 made a commitment that an assured supply of speciality logs suitable for processing into furniture grade material would be made available. Quoting from page 61 of the Timber Strategy:

"To ensure supply does not inhibit development of value added industry, up to 30 000 cubic metres per annum of speciality logs will be made available as the situation demands.

A major criterion for the allocation of this resource will be the capacity of the company selected to produce an assured supply of high grade seasoned hardwood."

The concept of value adding is seen as a key strategy to increase the socioeconomic value of the timber industry to the State.

This offer to sell speciality logs is designed to create opportunities which will provide resources for value added wood manufacturing.

The Government is anxious to foster new technology in the processing of hardwood logs. It wishes to build on the research findings of the Public Interest Project being carried out at the Harvey Wood Utilisation Research Centre. This project, funded in equal proportions by the Commonwealth and State Governments and the timber industry, has now demonstrated that significant advantages can be achieved using new technology.

For example, the VALWOOD concept has been developed. It is a process designed to convert small diameter hardwoods commercially into dry value-added products. The products from this revolutionary sawing, seasoning and gluing process have been given the registered trade name "VALWOOD". This process is available for consideration by people wishing to register their interest. Demonstrations of the process can be arranged by appointment.

# LOG RESOURCE

The speciality log resource is diversified both in type and geographic distribution. This situation will have a bearing on the location and size of new processing equipment and the degree of integration with existing facilities. For this reason CALM wishes to receive and discuss with industry its processing proposals.

The log resource for the proposal will initially come from harvesting the new categories of logs using contractors operating in integrated logging operations in all CALM forest regions. Depending on the scope of the proposal(s) accepted by the Department, it may be necessary to carry out harvesting of the logs in a modified form. Existing Contracts negotiated in accordance with the Timber Strategy will not be compromised by any allocation of resource which may result from this call for expressions of interest.

The log products will include:

- · premium jarrah, karri and marri
- · short jarrah and karri
- small diameter jarrah, karri and marri
- minor species such as sheoak and feature wood pieces such as burls.

#### PREMIUM SAWLOGS

Logs will be straight

**Ouality:** 

A maximum of 15% by volume of defective wood is permissible, as assessed on the worst end face, provided the defective wood is confined to the centre or heart of the log.

No other defect is permissible.

General:

Logs must be delivered to mill landing for water spray

storage within 5 days of felling.

#### **REGROWTH SAWLOGS**

Proposals including minimum diameters less than 200 mm will be considered.

Shape:

10% of the small end.

General:

Logs will generally be supplied in bole lengths and must be delivered to mill landing for water spray storage within 5

days of felling.

A maximum of 15% by volume of defective wood is permissible, as assessed on the worst end face, provided the defective wood is confined to the centre or heart of the log, or to a single portion of a half log or slab. No other defect is

permissible.

General:

Feature logs include whole or part logs with rare and valued features such as "birds eye", "pencilling", curly grain or spiral grain. Logs must be delivered to mill within 5 days of felling.

### PRICING

Pricing of the logs will be subject to negotiation. Premium quality logs will however, be expected to attract a price significantly greater than the present first grade target royalty. The additional costs of processing non-conventional sizes will be a consideration in the final determination. However, pricing is expected to be commensurate with the value of the products produced.

Proposals will be received from individuals or companies, singly or jointly, for all or part of the offered resource.
