ACTION

Transfer of Reserve 2184 to the Conservation Commission of Western Australia.

Total Area: 40.4686ha

REASON FOR ACTION

The Department of Water has undertaken a review of all their water reserves and are seeking to rationalisation their management responsibilities. As part of this process Reserves 7128 and 2184 were identified as surplus to their department's requirements.

DEC expressed an interest in accepting management of Reserve 7128 and 2184 for addition to the conservation estate. Reserve 2184 contains a unique swamp system, known as Ngopitchup Swamp. Reserve 2184 is linked to Reserve 7128 by a vegetated road reserve. These two reserves are the largest vegetated reserves in the surrounding area.

On the 27 July 2011 Reserve 2184's management was transferred to the Conservation Commission.
