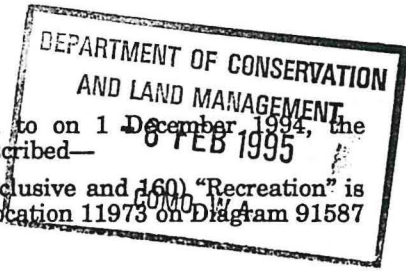

CLAUSE 14

Reserve No. 9228 (Moonijin Nature Reserve)

14. Reserve No. 9228 (Moonijin Nature Reserve), classified as of Class A is amended —

15

- (a) by revoking the current vesting of that reserve in the Minister for Water Resources; and
- (b) by changing the purpose of the reserve from “ Water and Protection of Flora and Fauna” to “Conservation of Flora and Fauna”.

CLAUSE 14

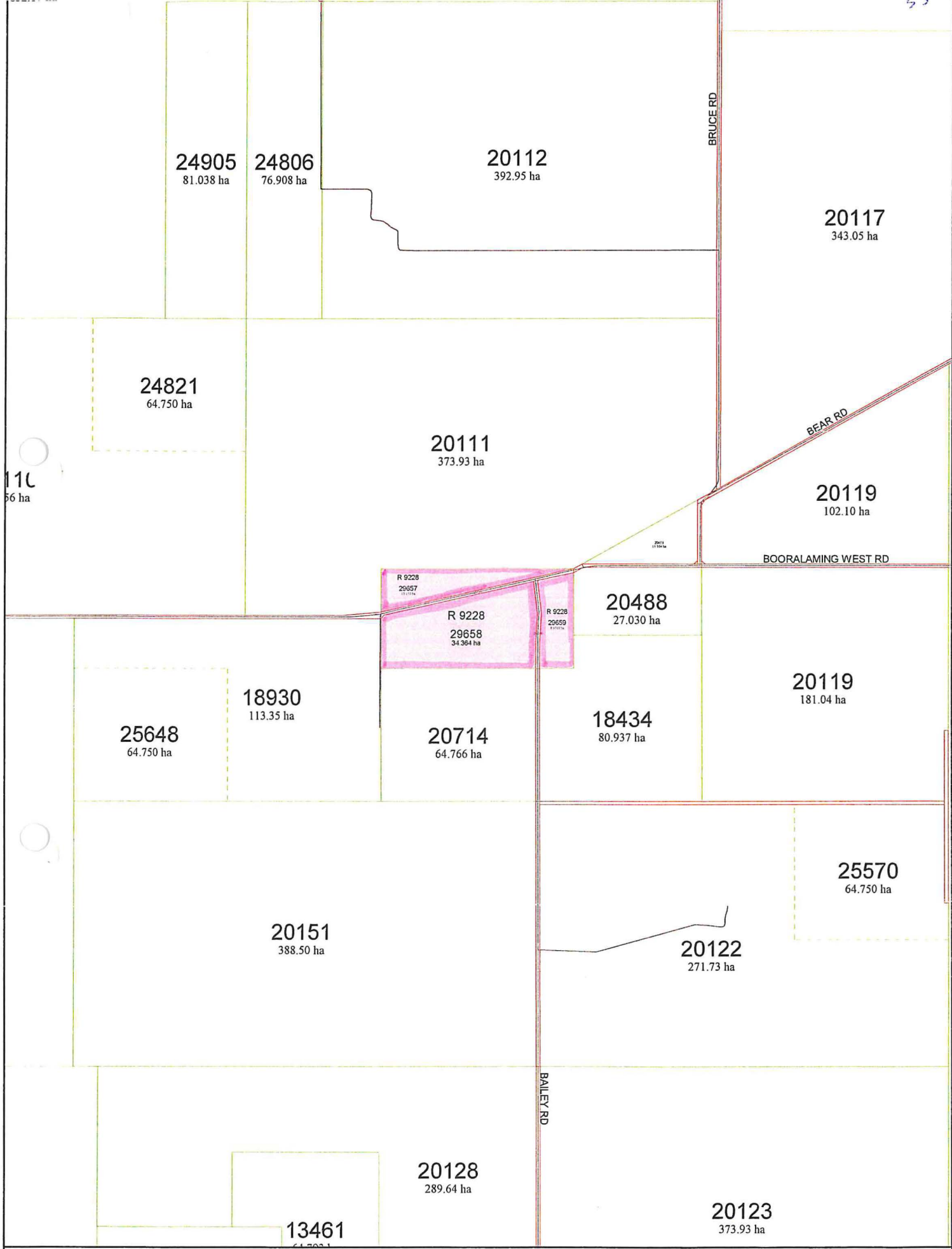
Class "A" Reserve 9228 is set apart for the purpose "Water and Protection of Flora and Fauna" and is vested in the former Minister for Water Supply Sewerage and Drainage. The reserve is situated on Booralaming West Road about 35 kilometres NNE of Dowerin Townsite and is one of a few small scattered nature reserves in this area.

The Water Authority of WA has advised that it has no further interest in this reserve and CALM has requested a change in purpose to "Conservation of Flora and Fauna" with vesting in the National Parks and Nature Conservation Authority.

DOLA has no objection to the change and the Dowerin Shire Council and Department of Minerals and Energy also agree with the proposal.

As the reserve has Class "A" status it is a statutory requirement that both Houses of Parliament endorse the change in purpose.
