RESERVE 11310 (GRAVEL)

I refer to your memo of May 13, 1986 and advise for your information that the Executive Council has:-

1. approved of:-
  - a) the amendment of Reserve No. 11310 (Swan District) "Gravel" to comprise Swan Location 10769 and of its area remaining unaltered.
  - b) the purpose of Reserve No. 11310 (Swan Location 10769) being changed from "Gravel" to "Conservation of Flora and Fauna".
2. issued a Proclamation, classifying as of Class "A", Reserve No. 11310 (Swan Location 10769) "Conservation of Flora and Fauna".
3. issued an Order in Council directing that Class "A" Reserve No. 11310 (Swan Location 10769) shall vest in and be held by the National Parks and Nature Conservation Authority in trust for the purpose of "Conservation of Flora and Fauna".

Notice to this effect was published in the Government Gazette of May 30, 1986 and I enclose a print showing the said reserve and the relevant Vesting Order.

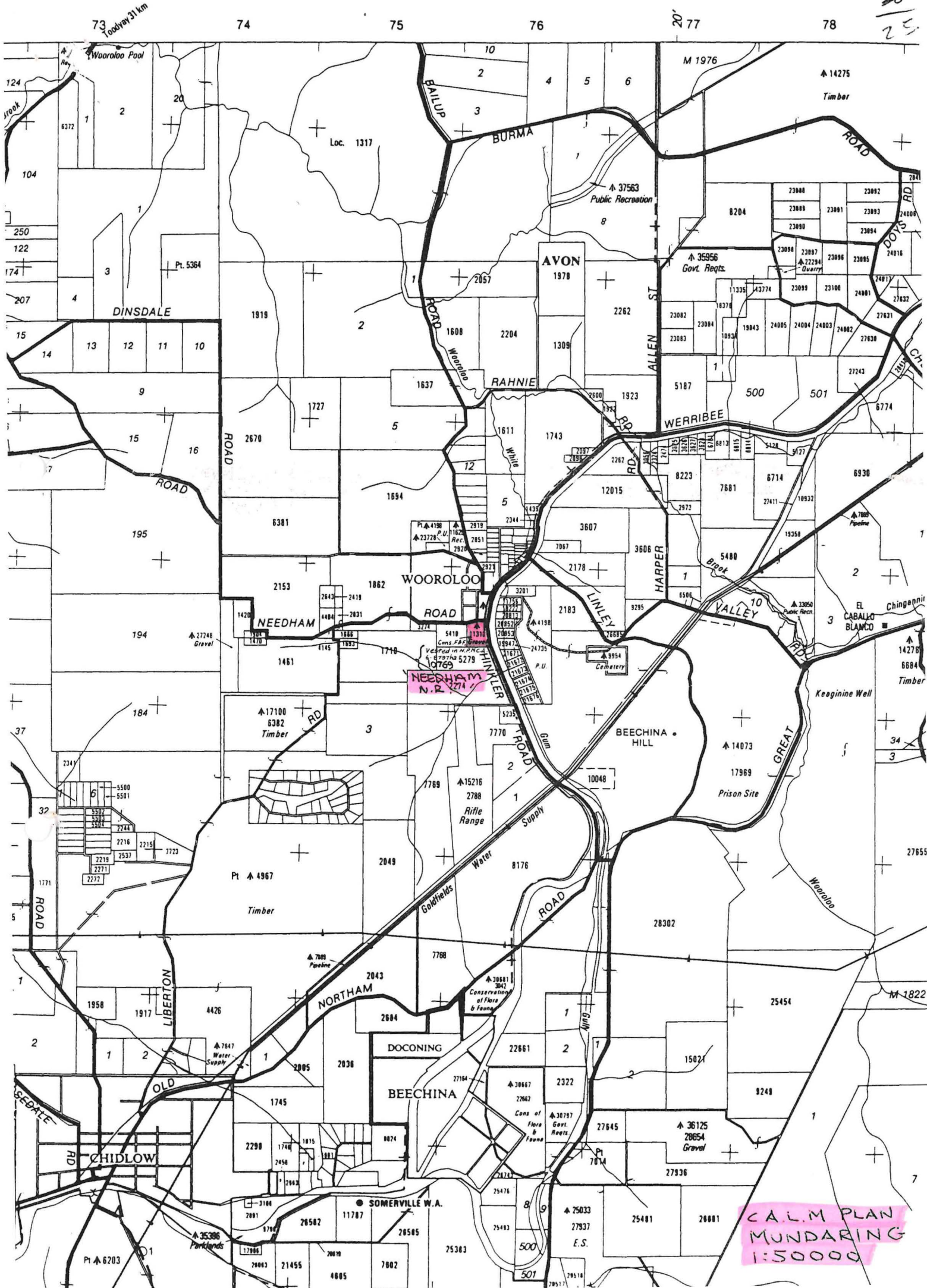
