- 1) approved of the amendment of Reserve No. 12381 (Nelson District) "Townsite" to comprise Nelson Location 13263 and of its area being reduced to 74.8198 hectares.
- 2) approved of the purpose of Reserve No. 12381 (Nelson Location 13263) being changed from "Townsite" to "Conservation of Flora and Fauna" and issued an Order in Council directing that Reserve No. 12381 shall vest in and be held by the National Parks and Nature Conservation Authority in trust for the purpose of "Conservation of Flora and Fauna".

Notice to this effect will be published in the Government Gazette of November 22, 1985 and I enclose a print showing the said amendment, and the relevant Vesting Order.
