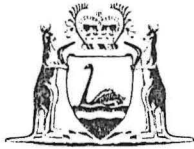

I refer to your memo of September 5, 1984 and advise for your information that Executive Council has:-

1) approved of:-

- a) the cancellation of Reserve No. 9281 (Cowcowing Agricultural Area Lot 131) "Conservation of Flora".
- b) the amendment of Reserve No. 16040 (Cowcowing Agricultural Area Lot 268) "Conservation of Flora" to include Cowcowing Agricultural Area Lot 131 and of its area being increased to 278.6767 hectares.

2) approved of the purpose of Reserve No. 16040 (Cowcowing Agricultural Area Lots 131 and 268) being changed from "Conservation of Flora" to "Conservation of Flora and Fauna" and issued an Order in Council directing that Reserve No. 16040 (Cowcowing Agricultural Area Lots 131 and 268) shall vest in and be held by the National Parks and Nature Conservation Authority in trust for the purpose of "Conservation of Flora and Fauna".

Notice to this effect was published in the Government Gazette of July 12, 1985 and I enclose a print showing the said amendment and the relevant Vesting Order.

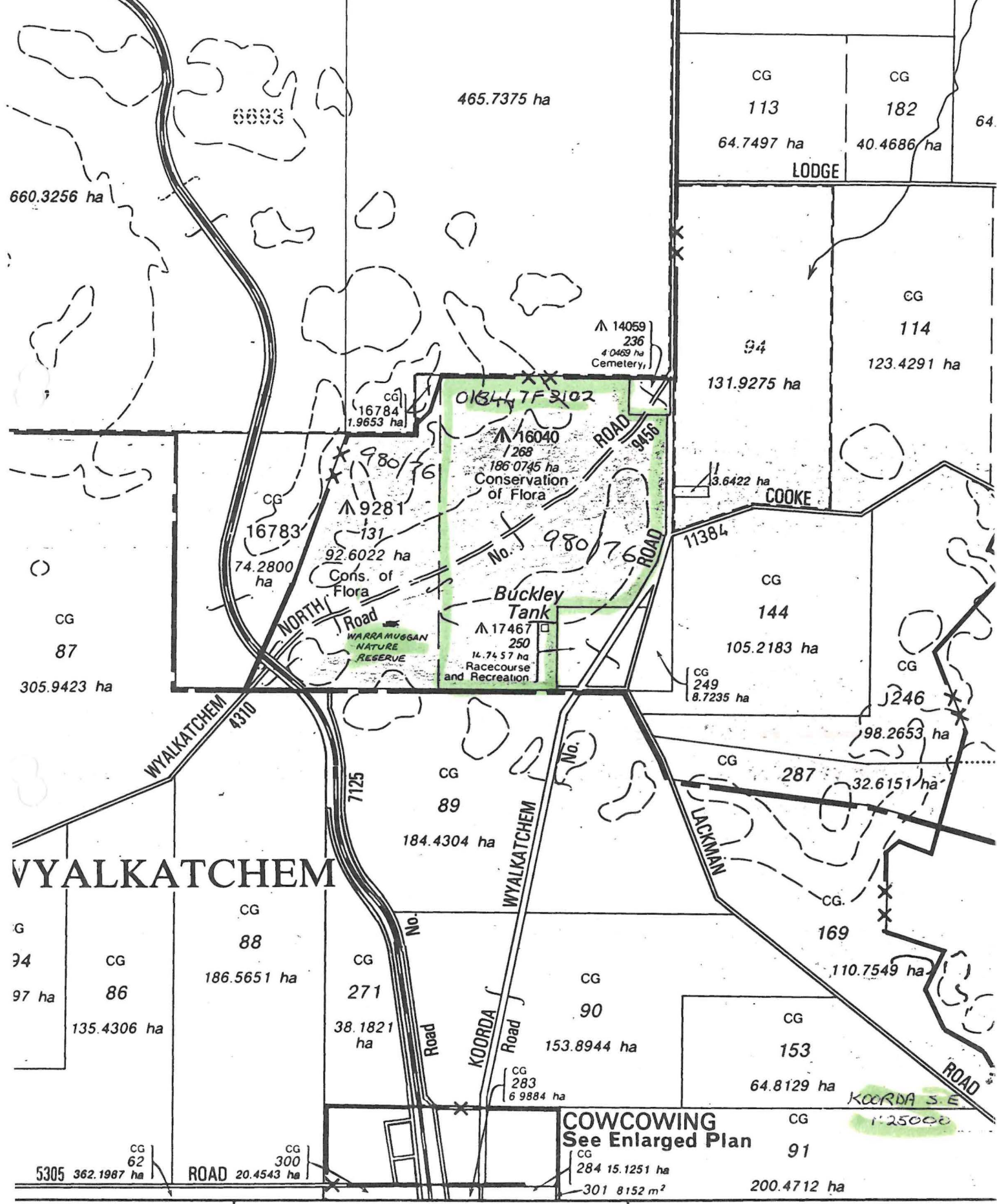

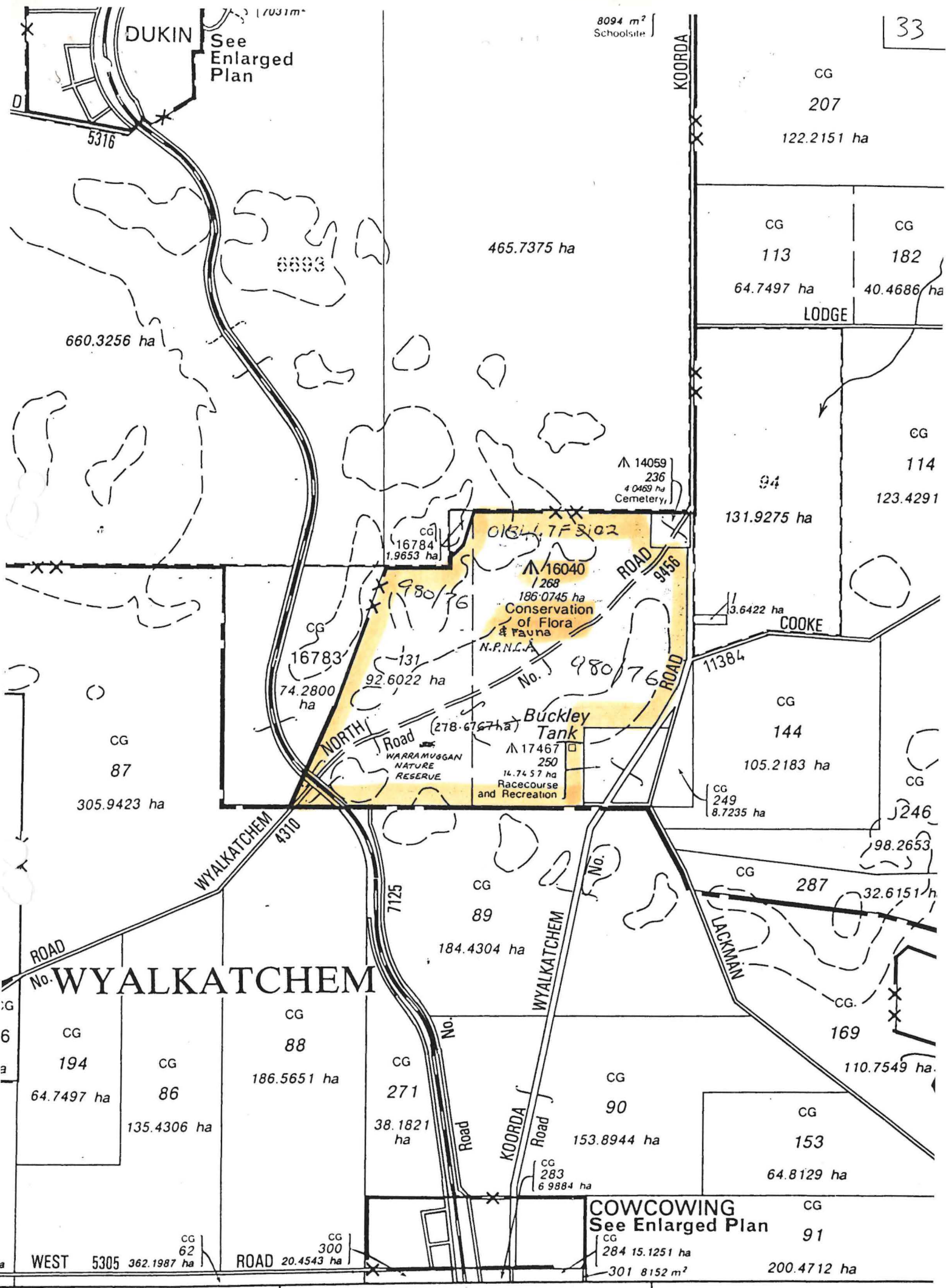

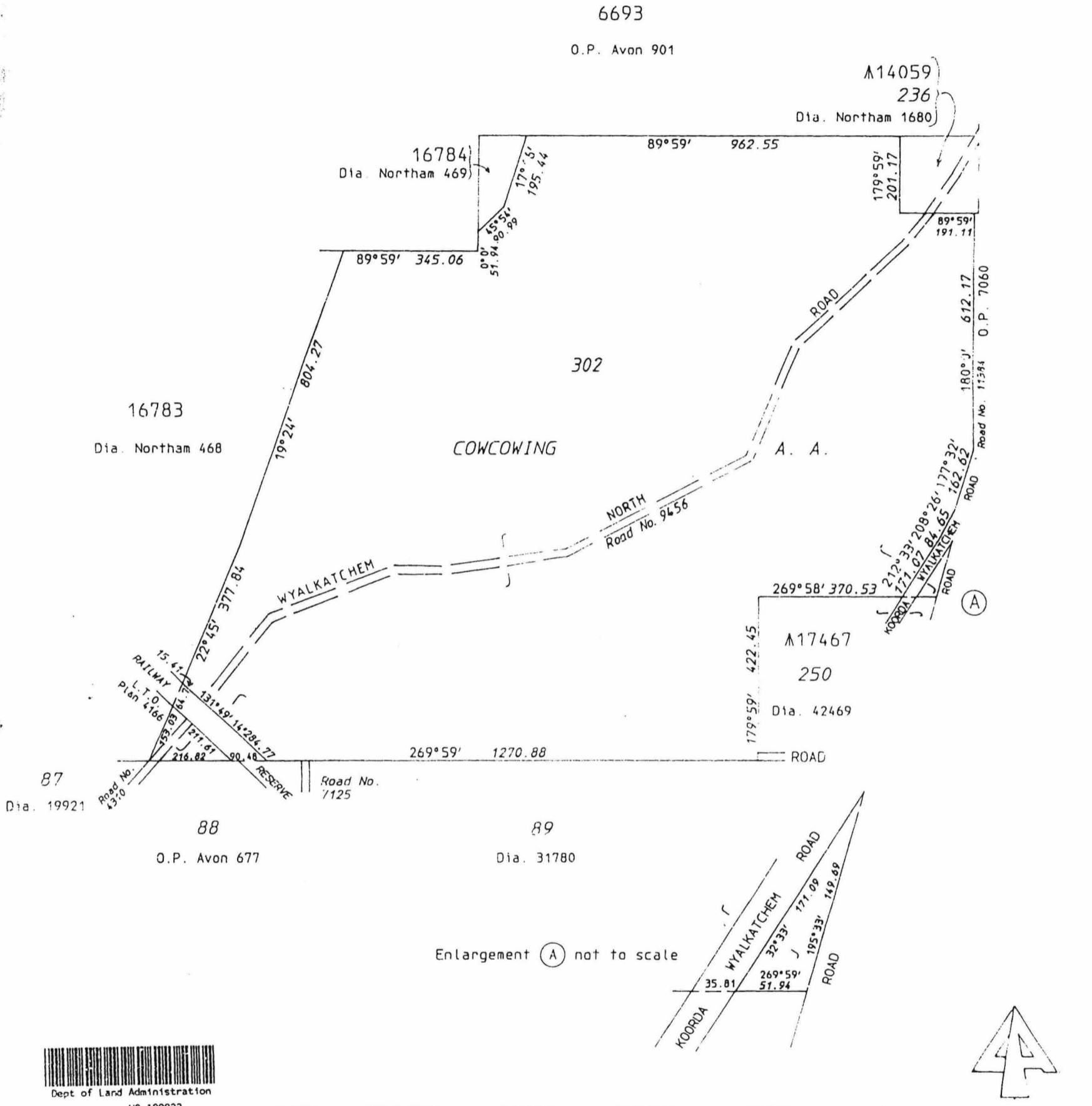
