- Addition to the estate of a class 'C' nature reserve vested in the NPNCA for the purpose of "Conservation of Flora and Fauna". Area: 80.9371 ha
- Reserve was previously unvested, with the purpose "Public Utility". It is largely surrounded by cleared land and is located in a forest-woodland transition zone. It contains a wide variety of vegetation and provides habitat for a number of mammals and birds. It is undisturbed and occurs in a region with limited conservation estate.

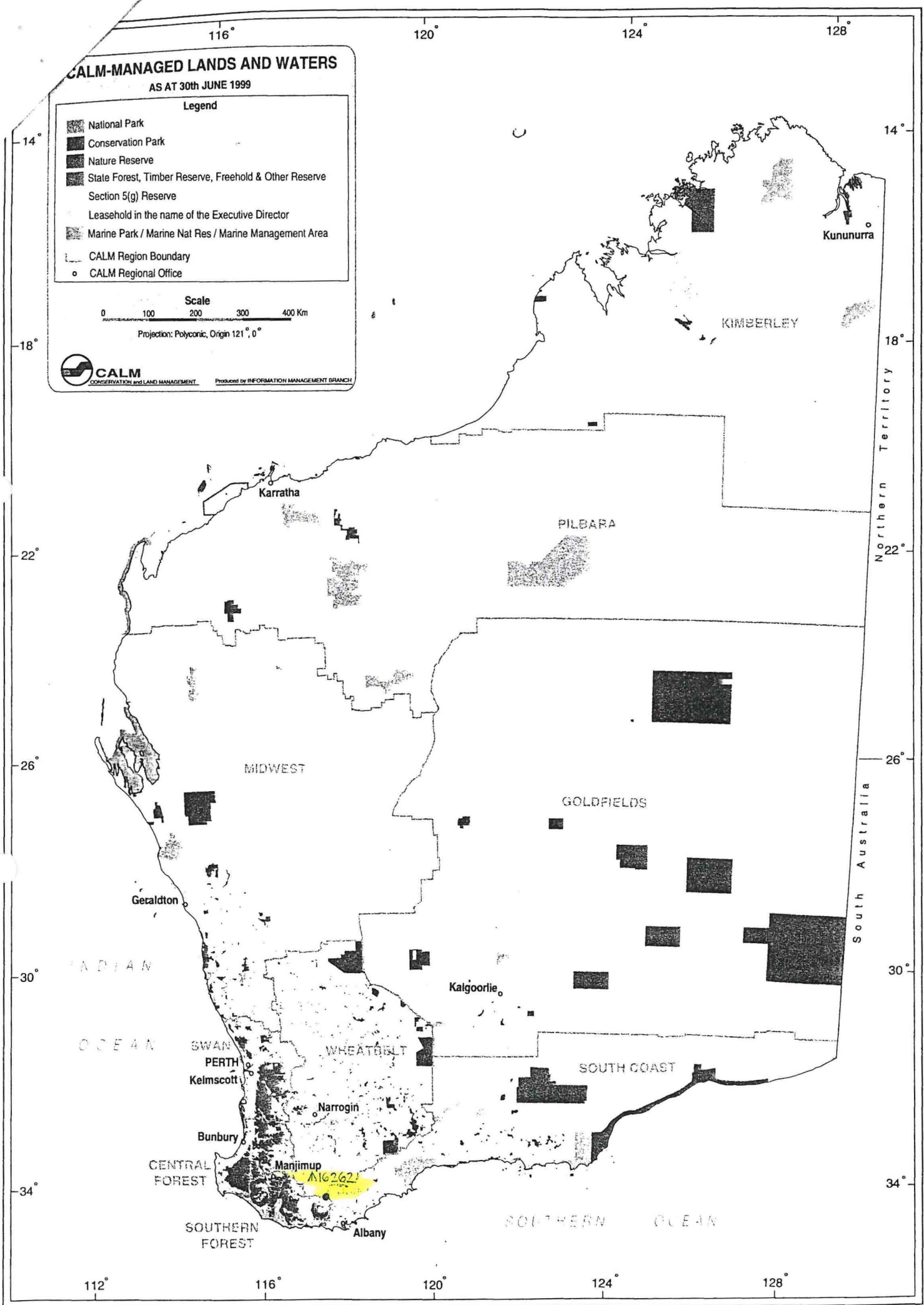
