### **ACTION**

Transfer of Reserve 16379 from the Water Corporation to the Conservation and Parks Commission.

**Total Area:** 1370 hectares

### **REASON FOR ACTION:**

Buntine Nature Reserve (A26837), located 28 kilometres north of Dalwallinu, is 1919 hectares in area and contains know populations of threatened flora and fauna. Buntine Nature Reserve has been managed for conservation since 1963. Adjacent to Buntine Nature Reserve is Reserve 16379, also known as Buntine Nature Reserve but managed by the Water Corporation for 'Water and Conservation of Flora and Fauna'.

Reserve 16379 has an area of 1370 hectares and contains vegetation is a similar condition to the adjacent CALM Act nature reserve. To recognise the conservation values of the reserve and rationalise management of the area DBCA sought management of Reserve 16379. The Water Corporation supported the transfer on the condition that 'water' was retained as a purpose of the reserve.

The transfer of Reserve 16379, purpose of 'Water and Conservation of Flora and Fauna' to the Conservation and Park Commission was completed by the Department of Planning, Lands and Heritage on 28 January 2020.

Reserve 16379 has not been added to the adjacent Buntine Nature Reserve because the reserves are managed for different purposes. When support is gained from the Water Corporation DBCA will seek to change the purpose of Reserve 16379 so that it may be added to the adjacent Buntine Nature Reserve.
