PURPOSE: Conservation and Seed Orchard

VESTING: Conservation Commission

ACTION

Transfer of Reserve 17911, being Lot 21805 on Plan 146079, to the Conservation Commission and amend the purpose from 'Water' to 'Conservation and Seed Orchard'.

Total Area: 10.752ha

REASON FOR ACTION

In January 2002 DEC sought to acquire management of Reserve 17911 for the purpose of 'Conservation and Experimental Site'. Reserve 17911 was composed of Lots 14111 and 14112 on Plan 233561 and Lot 21805 on Plan 146079. Lots 14111, 14112 and part Lot 21805 were historically cleared and it was proposed that DEC would undertake revegetation trials on this land.

A subsequent site inspection in 2009 recommended that the cleared portions not be revegetated and instead sold to the adjacent land owners.

Since the revegetation trials could not be implemented the Wheatbelt region proposed the purpose of Reserve 17911 was to be changed to 'Conservation and Seed Orchard'.

The amended Reserve 17911 was vested in the Conservation Commission on the 22 January 2010.

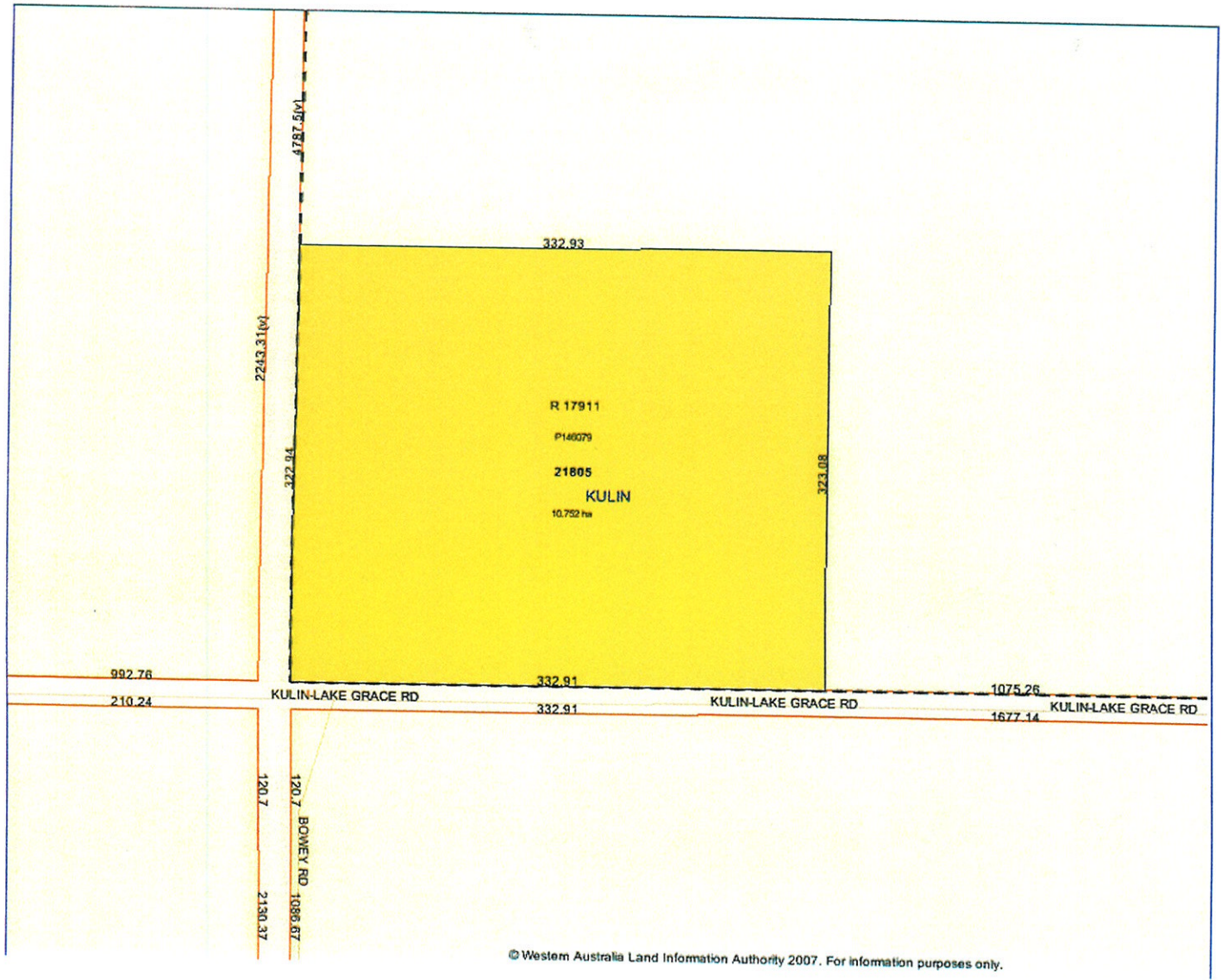
