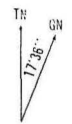

GRID CONVERGENCE AT SHEET CENTRE

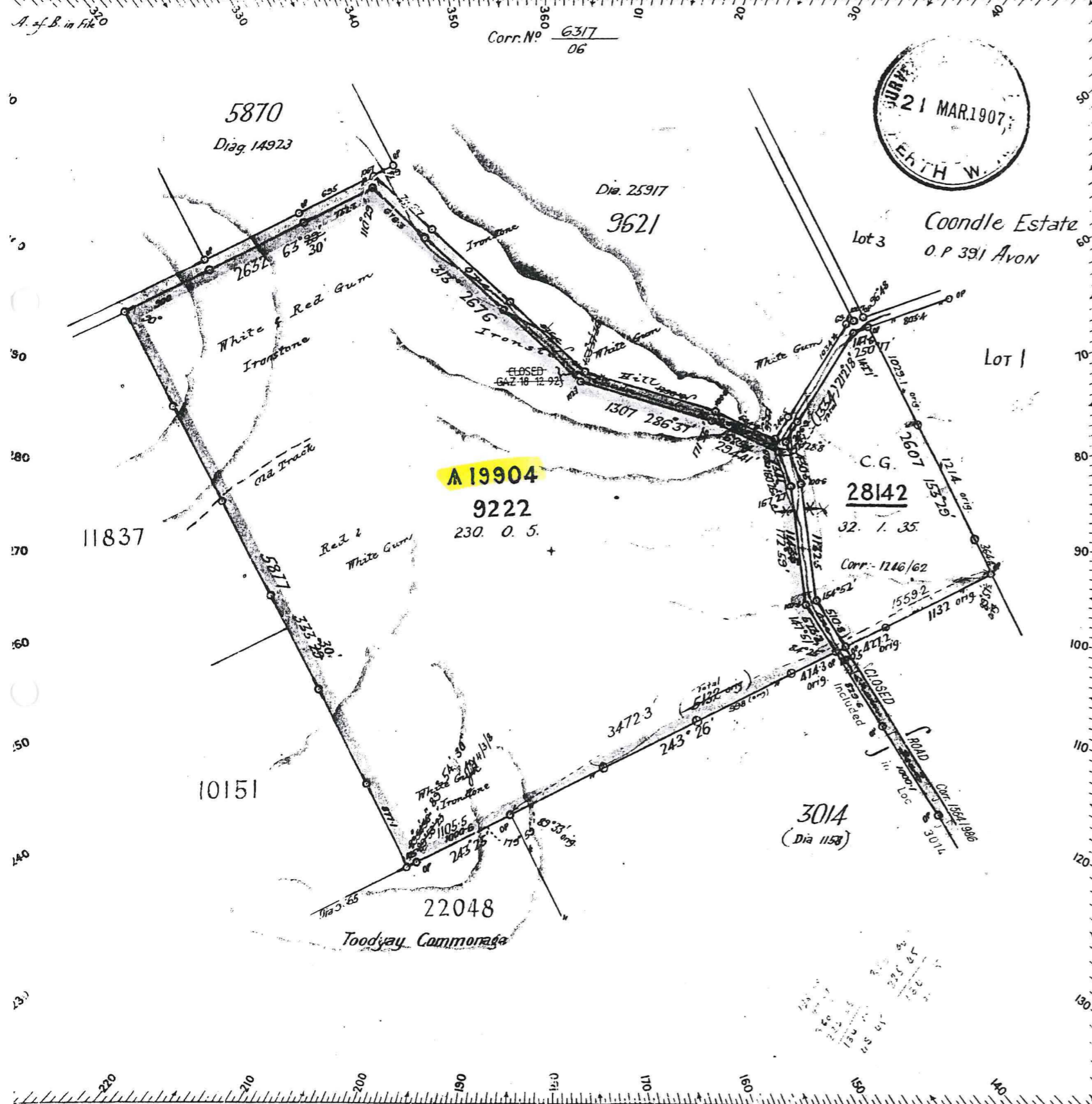
