**PURPOSE:** Recreation

**ACTION:** Reserve comprises lots 3091 and 3092 on Deposited Plan 415367, there was an excision of 0.28 hectares.

**REASON FOR ACTION:** Canning Dam Road and McNess Drive were constructed without creation of a dedicated road reserve and run through Midgegooroo National Park and Reserve 21569. To rationalise management of Canning Dam Road and McNess Drive, it was proposed to excise the existing constructed roads from the parks. The dedicated road reserve was created over the constructed alignment and the City of Armadale now have management over the maintenance of the roads.

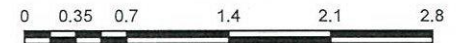
# Canning Dam Road / McNess Drive Locality Map

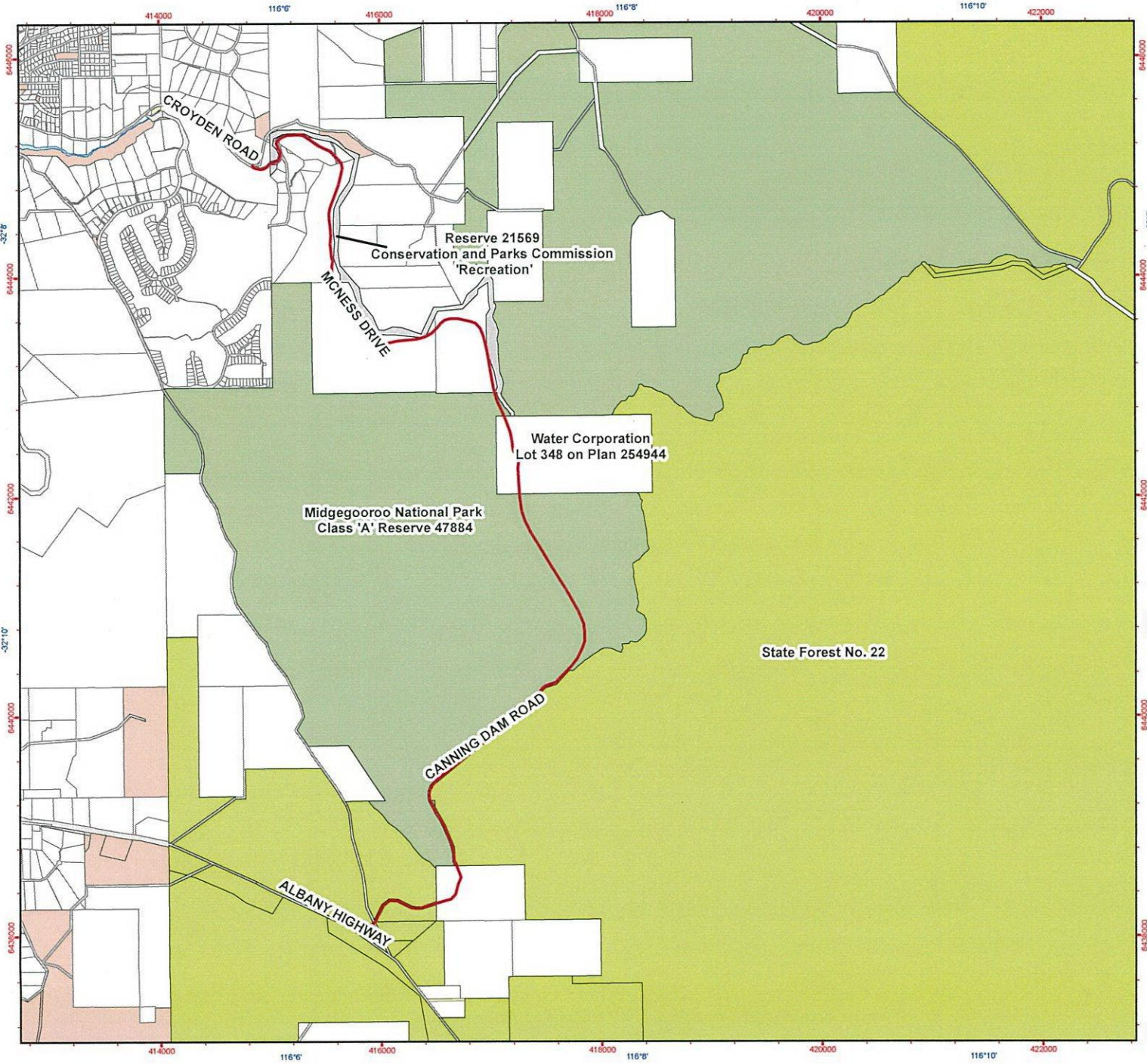
