REASON FOR ACTION

Reserve 21751 was transfer to DEC on 24 January 2012 to rationalise management of native vegetation surrounding Leeuwin Naturaliste National Park.

The land is proposed to be added to Leeuwin Naturaliste National Park in future. Reserve 21751 was not added directly to the national park due to stakeholder objections. These objections will be addressed and the reserve added to the national park in the future.

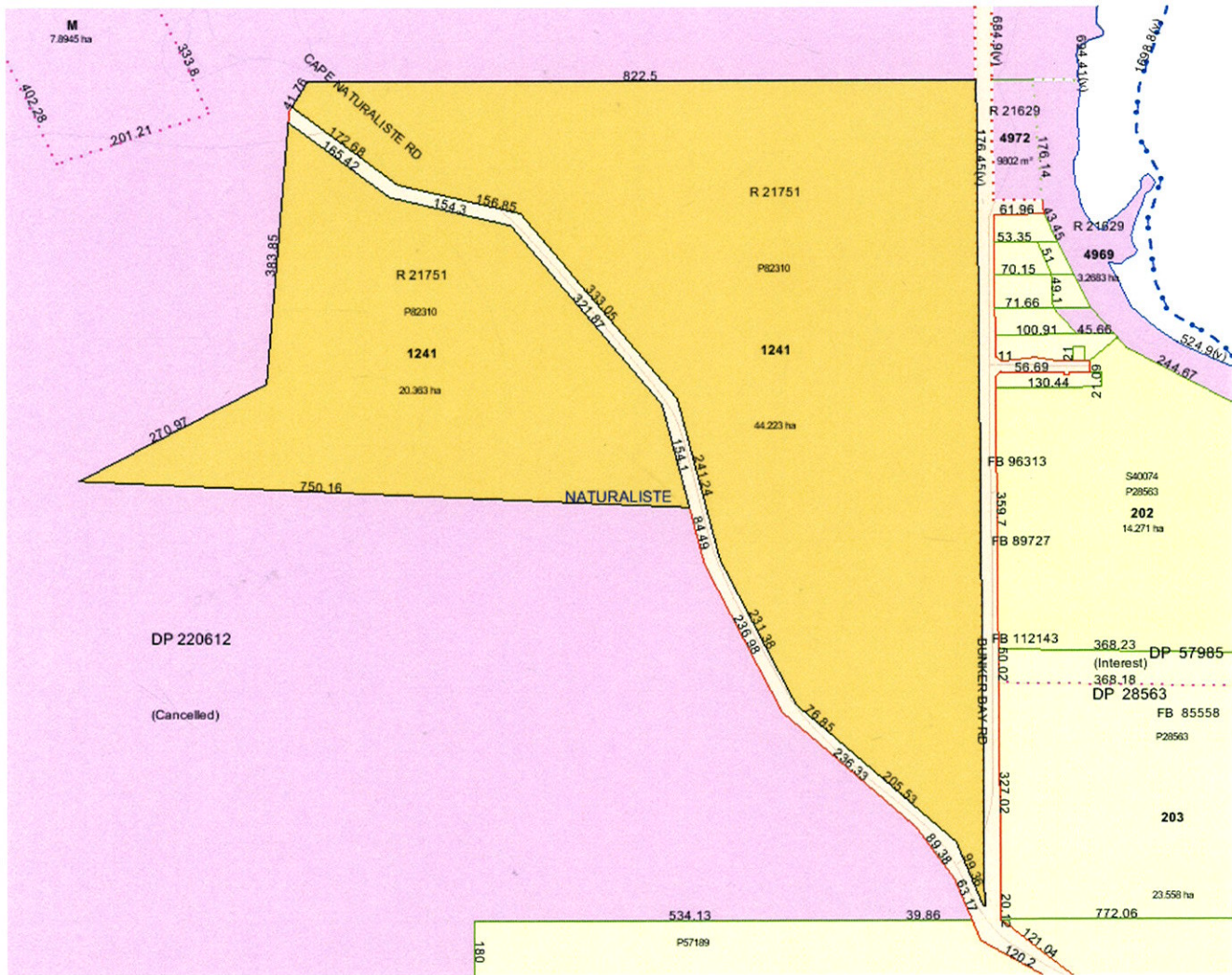

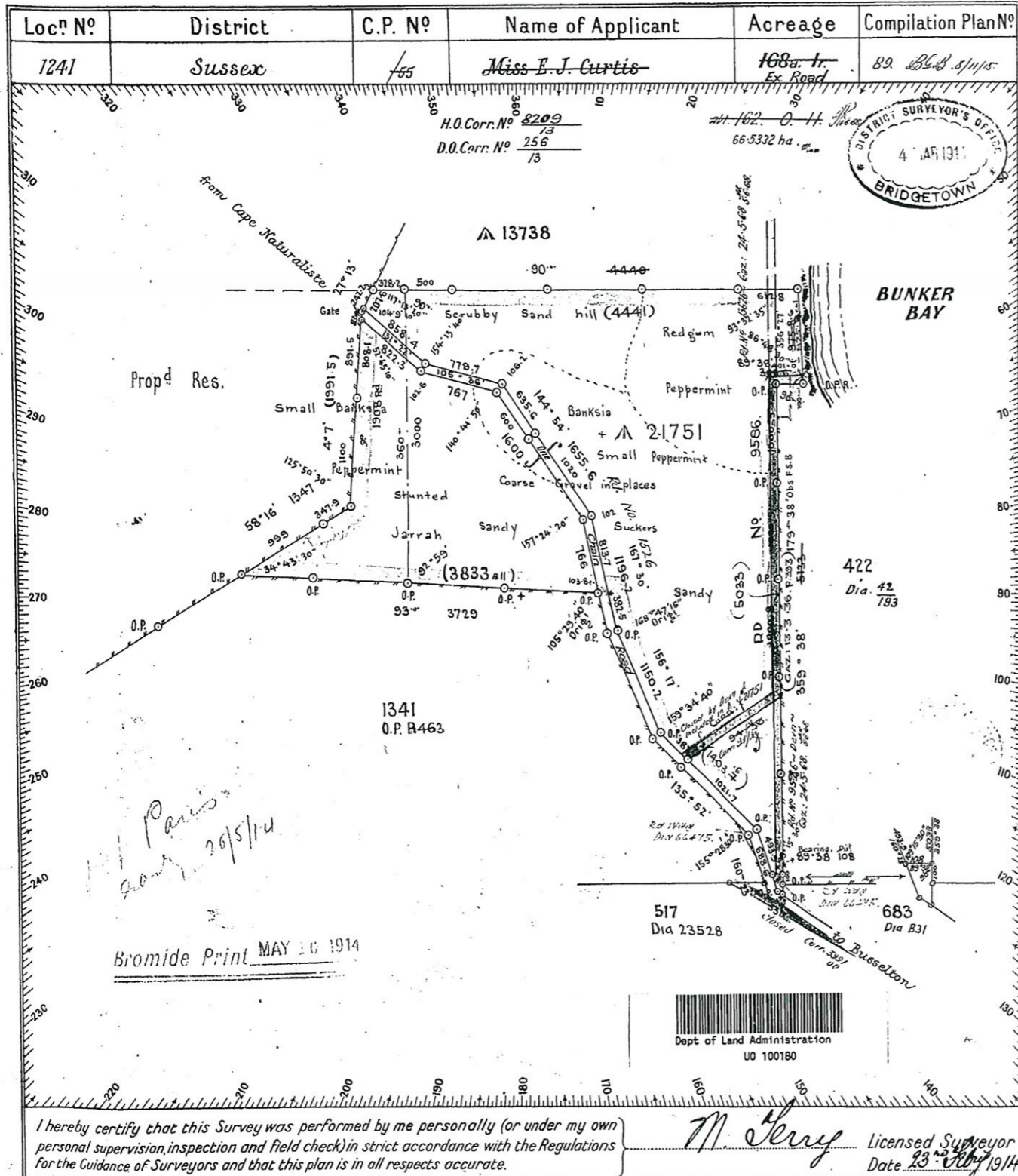
