

## RESERVE ACTION SHEET: CONSERVATION RESERVES

**RESERVE No.** 23012

**LOCAL GOVERNMENT:** Shire of Serpentine-Jarradale

**NAME :** Watkins Road Nature Reserve

**PURPOSE:** Conservation of Flora & Fauna **VESTING:** Conservation Commission of W.A.

**ACTION**

Reserve's area increased from 27.4177 ha to 53.7442 ha (an increase of 26.3265 ha) and a change of purpose from 'Conservation of Flora' to 'Conservation of Flora and Fauna.'

**Total Area:** 53.7442 hectares

**REASON FOR ACTION**

Of the increase of 26.3265 ha to the reserve's area, most of it (25.7982 ha from Lot 4396) resulted from the Department of Health's disposal of surplus land parcels from the Whitby Falls Hostel Site, Mundijong.

The remaining increase, of 0.5283 ha, resulted from the rationalisation of the boundaries of Reserve 23012 and the adjoining Reserve 23011 (Sanitary Site) after they were dissected by a railway.

With its previous purpose of 'Conservation of Flora', and its vesting in the Conservation Commission, Reserve 23012 was a nature reserve. The reserve's purpose was changed to 'Conservation of Flora and Fauna' since that is the standard purpose for a nature reserve.

Reserve 23012 and Lot 4396 are part of Bush Forever Site 360. The condition of the remnant vegetation within Lot 4396 is very similar to that found within Watkins Road Nature Reserve and Lot 4396 is a valuable addition to the conservation reserve system. The landscape of Bush Forever Site 360 features vegetated wetland and vegetated upland, which support significant flora, *Tetraria australiensis* (Rare) and significant mammal species, Quenda.

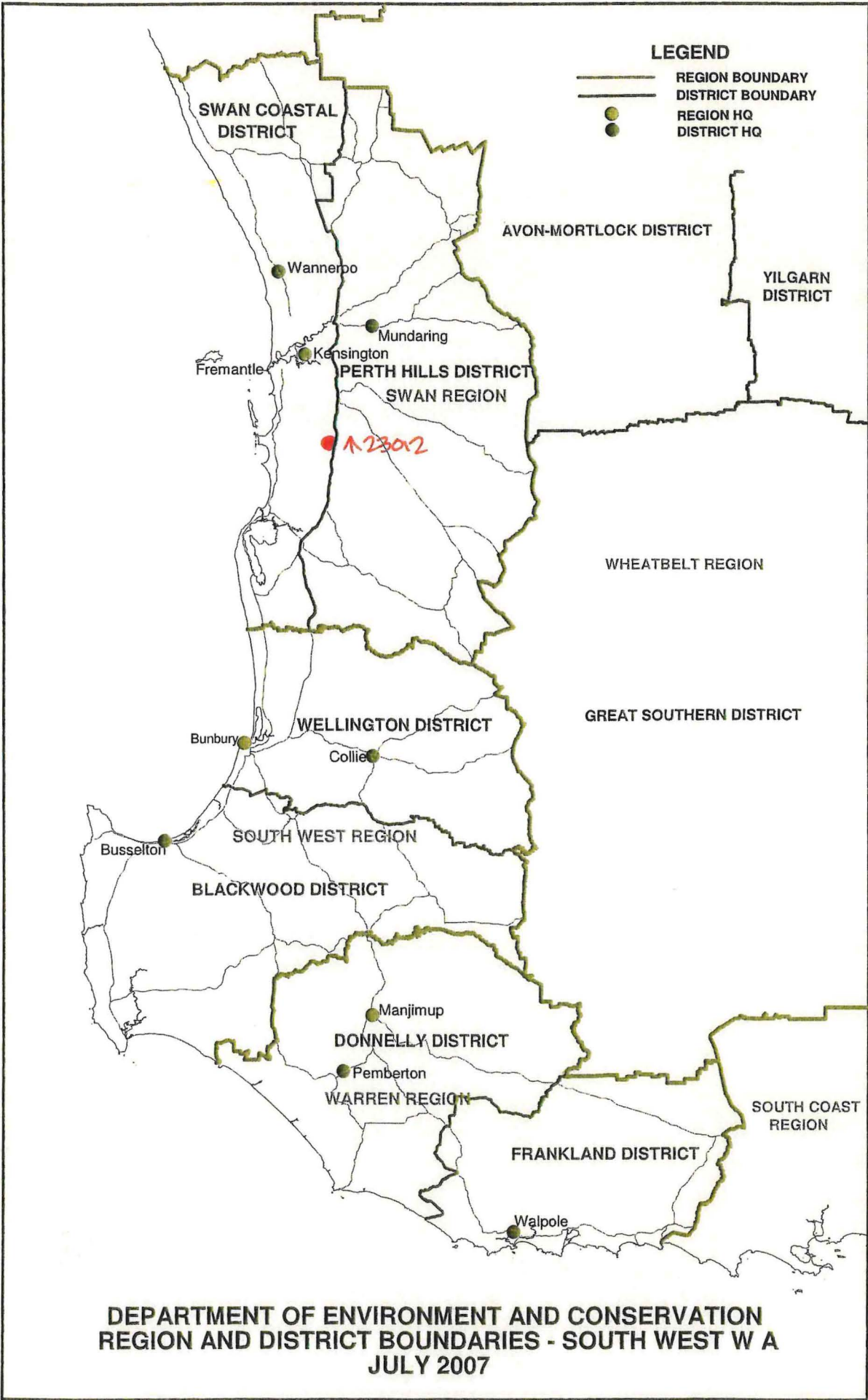

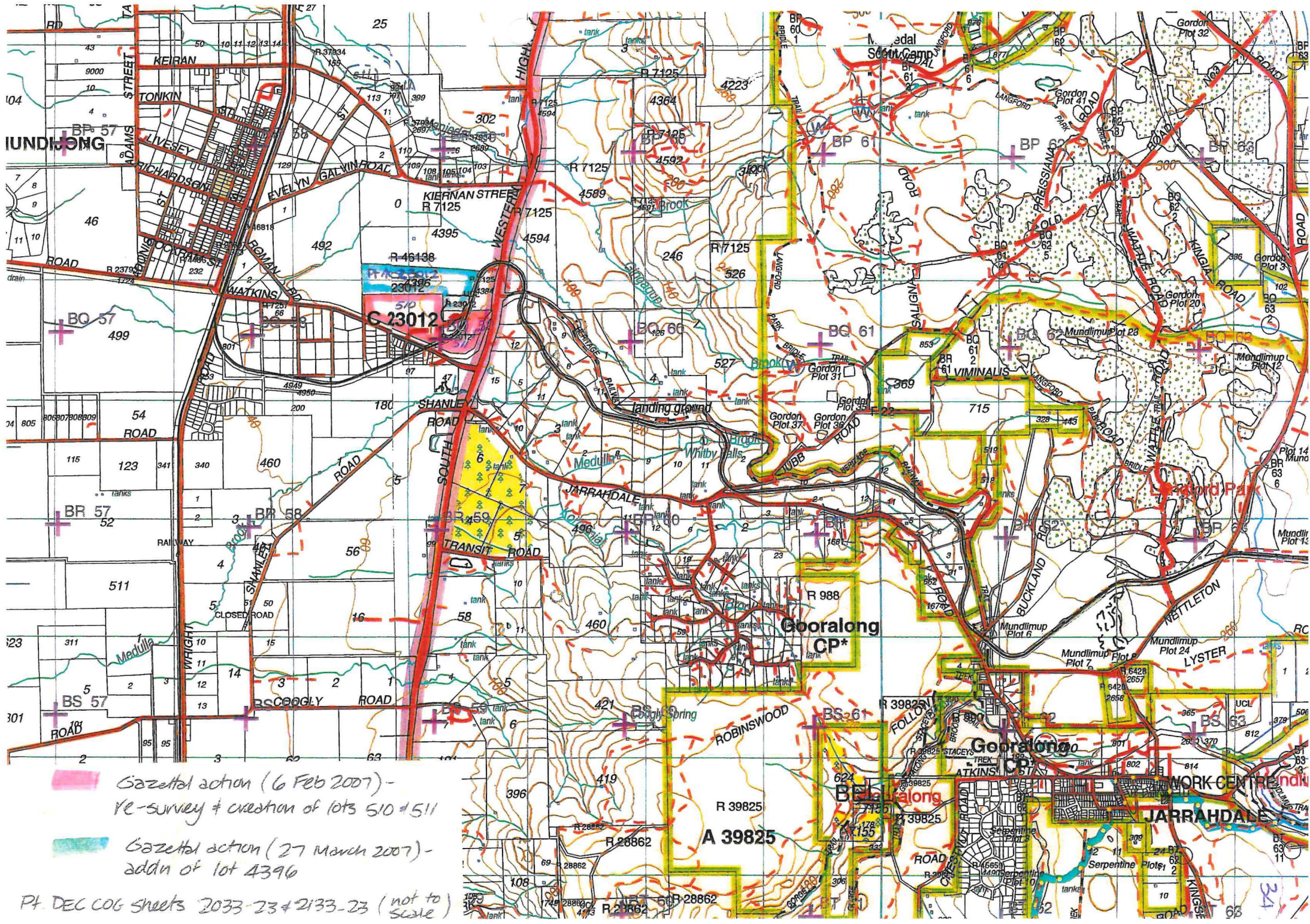

Native title is extinguished over the existing area of Reserve 23012 due to previous vesting (Ward High Court decision). Lot 4396 has been a vested reserve since 1976, and Reserve 23011 was vested in the Shire of Serpentine-Jarradale in 1982.
