It is hereby notified that pursuant to the above Act assented to on 22 April 1994, the undermentioned reserves have been dealt with in the manner described—

RESERVE C23157 - "WATER"

Recent Reserves Bill action resulted in the cancellation of the above reserve and amalgamation into adjoining nature reserve A23156 "Conservation of Flora and Fauna". Attached for your information is a copy of the relevant extracts from the Reserves Act 1994 and subsequent gazettal action of 15 July 1994.

Records indicate an anomaly exists with respect to the area of Reserve 23156. The area of 313.1734 hectares quoted in the Reserves Act 1994 prior to the addition of cancelled Reserve 23157 (24.25 hectares) appears to be understated. The correct area should be 343.1734 hectares. The total area including the addition of cancelled Reserve 23157 should be 367.4318 hectares.

Could you please investigate the matter and forward advice accordingly.

CLAUSE 12

Class "C" Reserve 23157 is set aside for the purpose "Water" and is not vested. It is situated on Ward Road about 33 kilometres north of Dowerin.

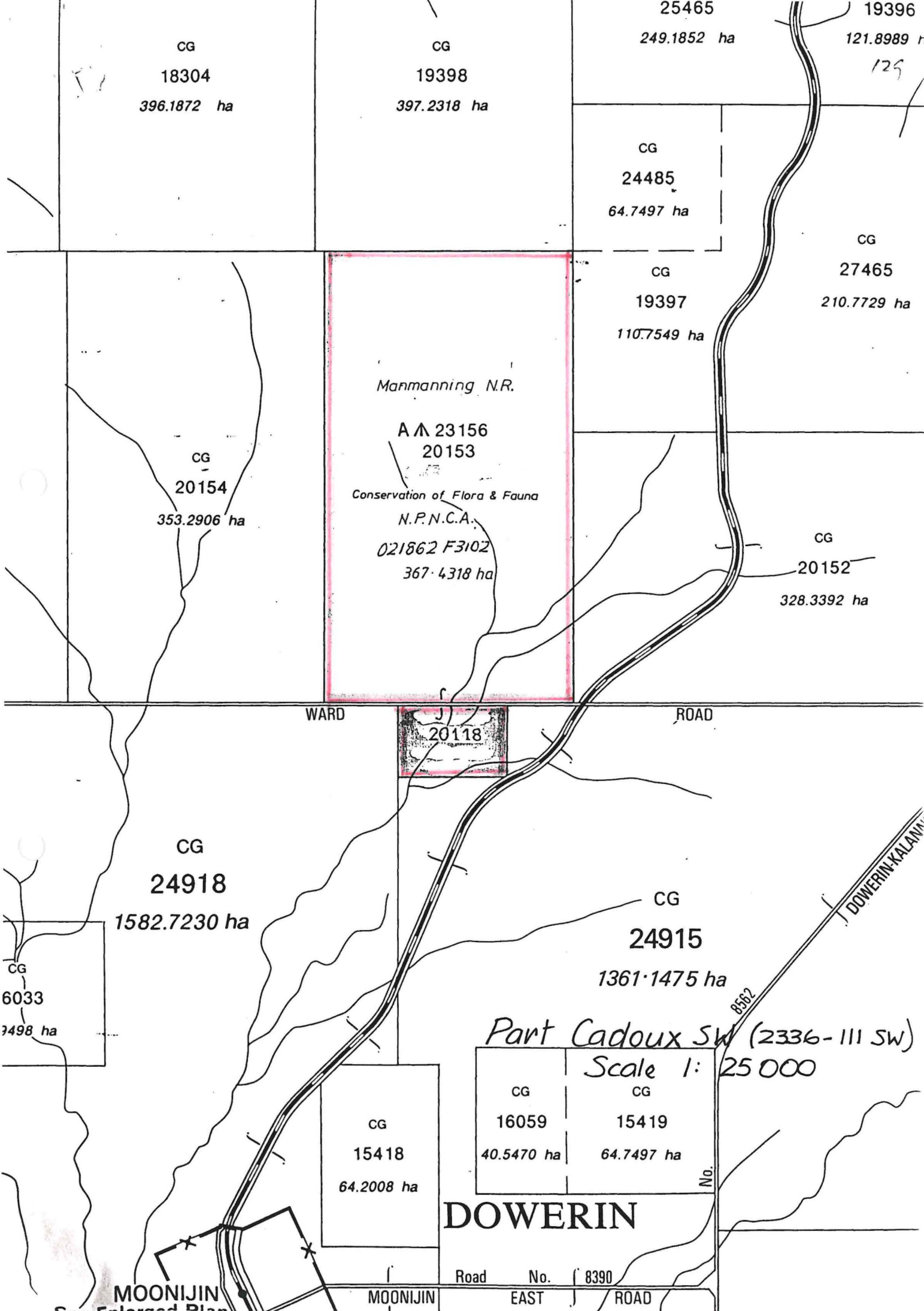
Following advice from the Water Authority of Western Australia that it had no further requirement for the land. The Department of Conservation and Land Management inspected this reserve and applied to DOLA to have it cancelled and included within adjoining Class "A" "Conservation of Flora and Fauna" Reserve 23156.

CALM considers Reserve 23157 to be in good condition with no visible signs of recent human usage and its inclusion would add several different types of vegetation to the main nature reserve.

Both the Shire of Dowerin and Department of Minerals and Energy have no objection to the proposal and DOLA also supports the change.

As Reserve 23156 has Class "A" status it will be necessary for both Houses of Parliament to consent to the addition.

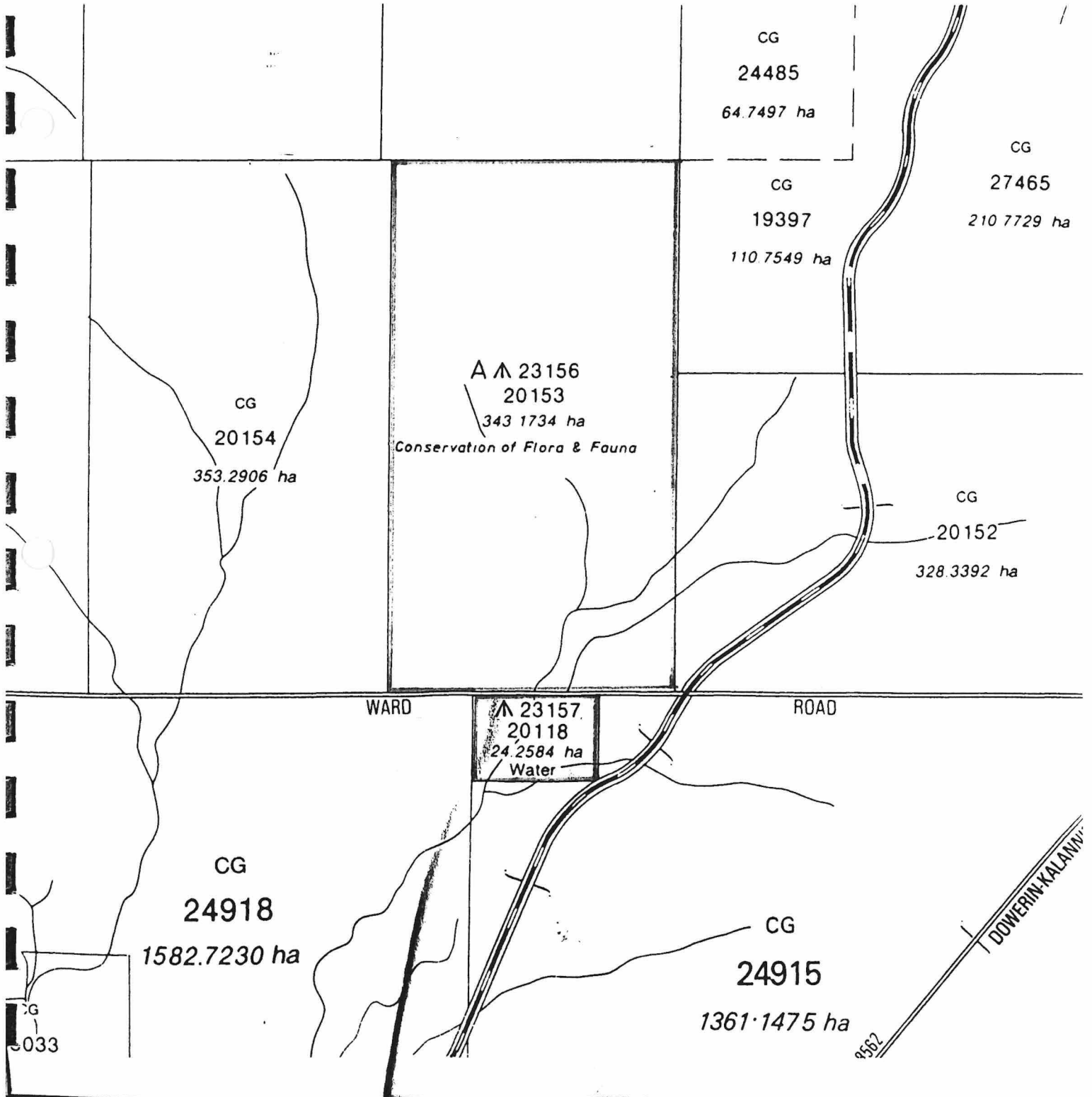
