## RESERVES ACT 1994

It is hereby notified that pursuant to the above Act assented to on 22 April 1994, the undermentioned reserves have been dealt with in the manner described—

1. The purpose of Class "A" Reserve 23850 (Plantagenet Location 6023) is changed to "Conservation of Flora and Fauna" with its area being recalculated to contain 362.8515 hectares. Reserve 23850 is automatically vested in the National Parks and Nature Conservation Authority pursuant to the CALM Act 1984.

2. The purpose of Class "A" Reserve 15214 (Hay Location 2238) is changed to "Conservation of Flora and Fauna". Reserve 15214 is automatically vested in the National Parks and Nature Conservation Authority pursuant to the CALM Act 1984.

**PART 2 — ALTERATIONS TO AND CANCELLATIONS OF RESERVES**

**Reserve No. 23850 in the Shire of Albany**

5. (1) The purpose of Reserve No. 23850, classified as of Class A, formerly described as containing 348.029 7 hectares or thereabouts, but found on recalculation to contain 362.851 5 hectares, being Plantagenet Location 6023 on Diagram 90559, and set apart for "Recreation, Camping and Water" is changed to "Conservation of Flora and Fauna".

(2) Reserve No. 23850 is vested in the Authority.

**Closure of roads and amendment to Reserve No. 27107 in the Shire of Albany**

6. (1) Reserve No. 26169, classified as of Class C, containing 4426 square metres and set apart for "Public Utility", is cancelled.

(2) All those portions of road shown coloured blue on Original Plan No. 17980, comprising 9901 square metres, are hereby closed and all rights of way over them shall hereby cease.

(3) The land contained in the portions of road closed by the operation of subsection (2) is constituted Crown land within the meaning of that expression in the *Land Act 1933*.

(4) Reserve No. 27107, classified as of Class A, containing 2 131.649 2 hectares or thereabouts and set apart for "National Park" is amended —

(a) by excising areas totalling 1.326 3 hectares as shown coloured dark brown on Original Plan No. 17980;

## CLAUSE 5

### Reserve No. 23850 in the Shire of Albany

5. (1) The purpose of Reserve No. 23850, classified as of Class A, formerly described as containing 348.029 7 hectares or thereabouts, but found on recalculation to contain 362.851 5 hectares, being Plantagenet Location 6023 on Diagram 90559, and set apart for "Recreation, Camping and Water" is changed to "Conservation of Flora and Fauna".
- 10 (2) Reserve No. 23850 is vested in the Authority.

CLAUSE 5

Plantagenet Location 6023 is set apart as Reserve No. 23850 for the purpose of "Recreation, Camping and Water" and is not vested. The reserve was created in 1953 and was classified Class "A" at that time.

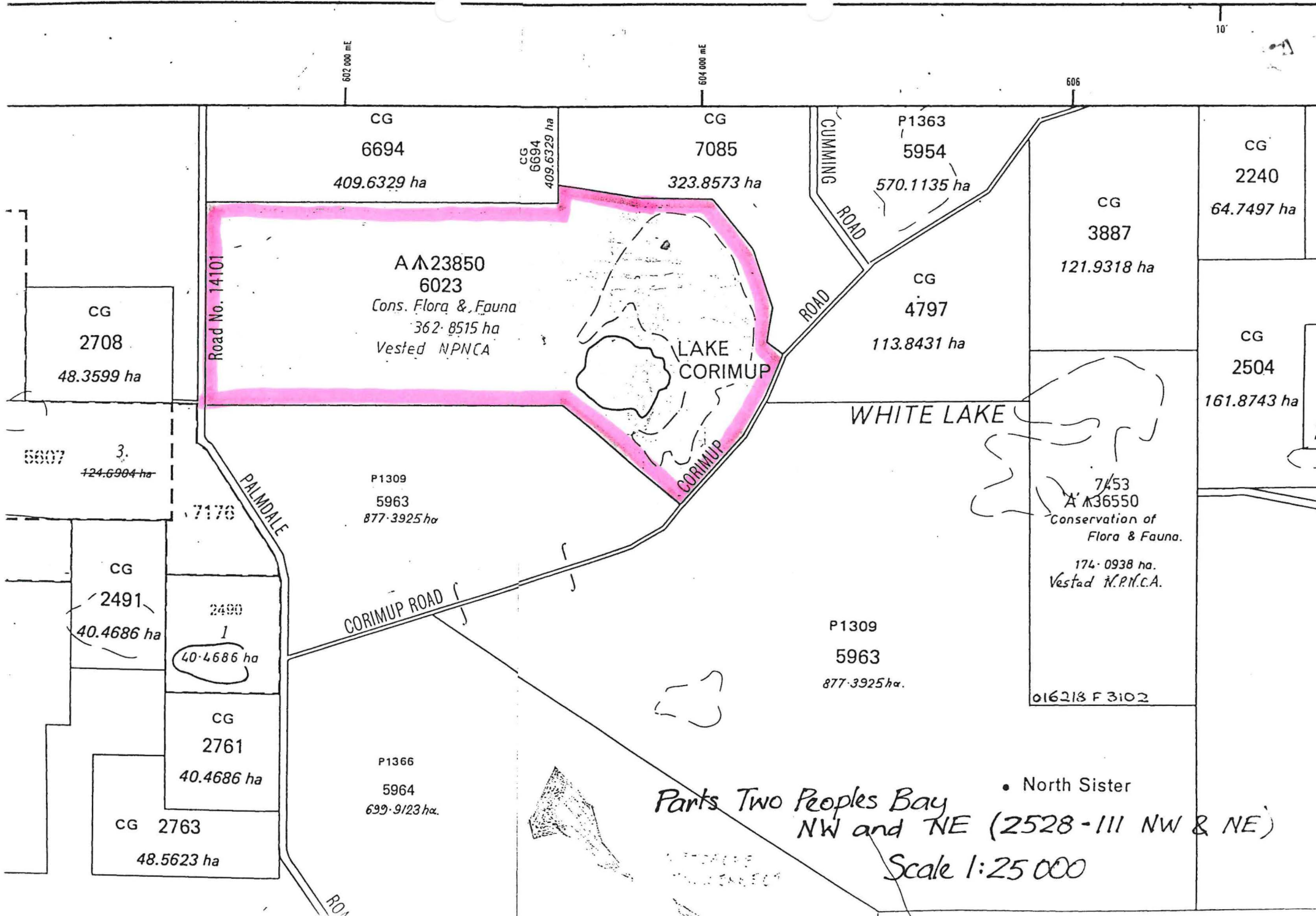
The Department of Conservation and Land Management's South Coast Region Management Plan has proposed that the purpose of Class "A" Reserve 23850 be changed to "Conservation of Flora and Fauna" and that it be vested in the National Parks and Nature Conservation Authority.

CALM has advised that the reserve provides protection for the wetlands of Lake Corimup and is in excellent condition.

The Albany Shire Council, Department of Minerals and Energy and Water Authority of Western Australia have no objection to the change.

It is considered the land will make a valuable nature reserve but as it has Class "A" status it will be necessary for both Houses of Parliament to endorse the change of purpose. It is also proposed that the reserve be redescribed on new survey Diagram 90559 and that its area be adjusted at the same time (an increase of 14.8218 hectares due to more precise definition).

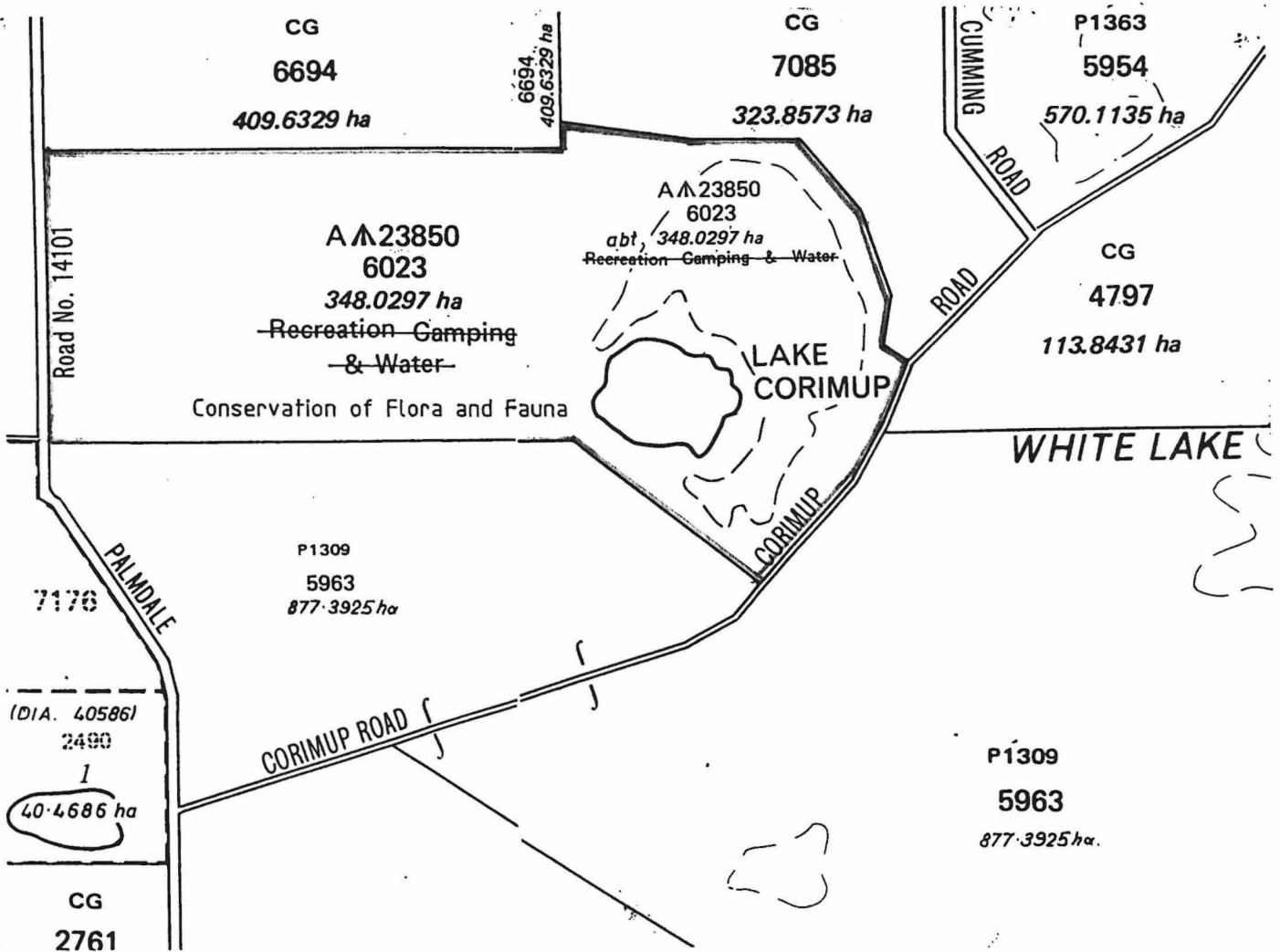

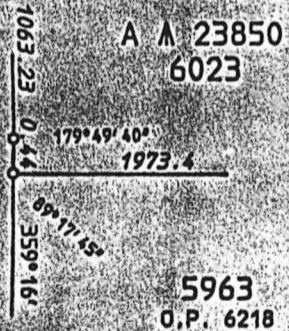
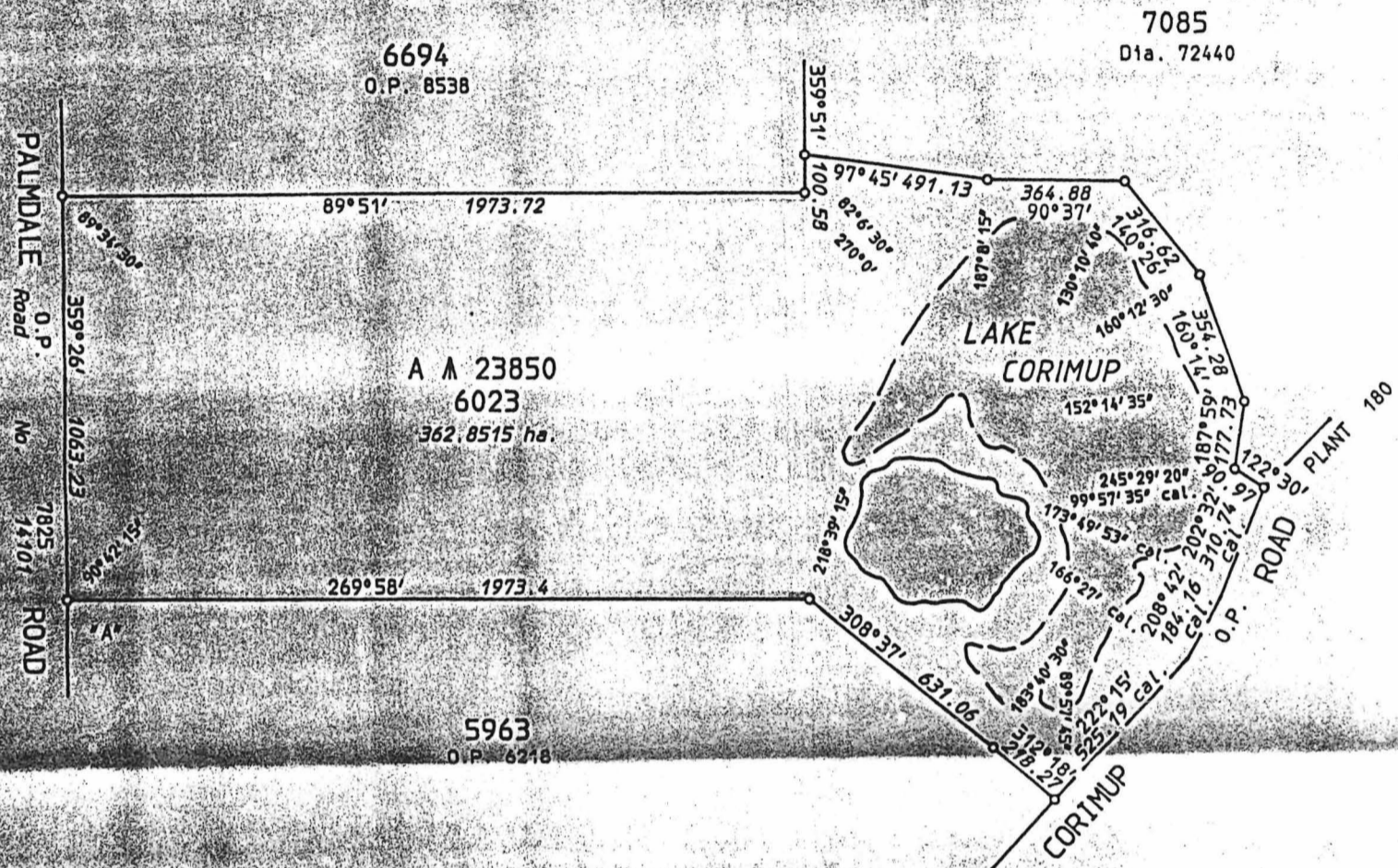
