7. Reserve No. 16412, classified as of Class A, containing 60.702 8 hectares or thereabouts, set apart for "Conservation of Flora and Fauna" and vested in the Authority, is amended by including an area of 4.782 9 hectares or thereabouts, being portions of closed road on the north-west boundary of the reserve, so that the reserve is comprised of an area of 65.485 7 hectares being Avon Location 29067 as shown bordered pink on Diagram No. 90711.

Reserve No. 21380 in the Shire of Bruce Rock

8. Reserve No. 21380, classified as of Class A, containing 4024 square metres, set apart for "Recreation" and vested in the Shire of Bruce Rock, is cancelled.

Reserve No. 24869 in the Shire of Carnarvon

9. Reserve No. 24869, classified as of Class A, containing 9 719.959 5 hectares or thereabouts, set apart for "Conservation of Flora and Fauna" and vested in the Authority, is amended —

- (a) by excising an area of 820 square metres being that area of the reserve included in Gascoyne Location 402 on Diagram No. 88936; and
- (b) by excising an area of 663 square metres being that area of the reserve included in Gascoyne Location 403 on Diagram No. 89015,

so that the reserve is comprised of an area of 9 719.811 2 hectares or thereabouts.

CLAUSE 9

Reserve No. 24869 in the Shire of Carnarvon

9. Reserve No. 24869, classified as of Class A, containing 9 719.959 5 hectares or thereabouts, set apart for "Conservation of Flora and Fauna" and vested in the Authority, is amended —
- 10 (a) by excising an area of 820 square metres being that area of the reserve included in Gascoyne Location 402 on Diagram No. 88936; and
- 15 (b) by excising an area of 663 square metres being that area of the reserve included in Gascoyne Location 403 on Diagram No. 89015,

so that the reserve is comprised of an area of 9 719.811 2 hectares or thereabouts.

CLAUSE 9

Cape St Cricq Lighthouse is situated on the southern extremity of Dorre Island westward of Carnarvon on Class "C" "Lighthouse" Reserve 37338.

The Australian Maritime Safety Authority recently surveyed all existing improvements on the site and it has been determined that Reserve 37338 will require enlarging.

The surrounding land is Class "A" "Conservation of Flora and Fauna" Reserve 24869 which is vested in the National Parks and Nature Conservation Authority.

It is proposed to excise an area of 820 square metres from Reserve 24869 and CALM has agreed to the adjustment.

The new site comprises Gascoyne Location 402 with an area of 1225 square metres as surveyed on Diagram 88936.

Similarly, Lighthouse Reserve C 37383 situated near Cape Ronsard on the other major portion of Class "A" Reserve 24869 (Bernier Island) requires land added to encompass all improvements.

An area of 663 square metres needs to be excised and the new site is now surveyed as Location 403 on Diagram 89015.

As Reserve 24869 has "A" Class status, the approval of both Houses of Parliament is required to excise the land.
