Further to my memo of September 11, 1985, I advise for your information that Executive Council has approved of the purpose of Reserve No 25506 (Nelson Locations 332 and 350) being changed from "Timber (Settlers Requirements)" to "Conservation of Flora and Fauna" and issued an Order in Council directing that Reserve No. 25506 shall vest in and be held by the National Parks and Nature Conservation Authority in trust for the purpose of "Conservation of Flora and Fauna".
