- This action is a recommendation of the *Draft Busseton Wetlands Strategy*. The final version of the Strategy is being documented by various State and Local Government authorities. It recognises that reserve 25836 exhibits very high values for nature conservation, especially given that it is located near the Vasse River.

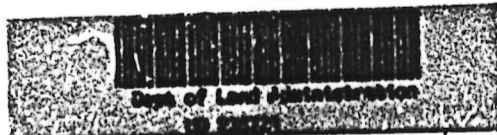
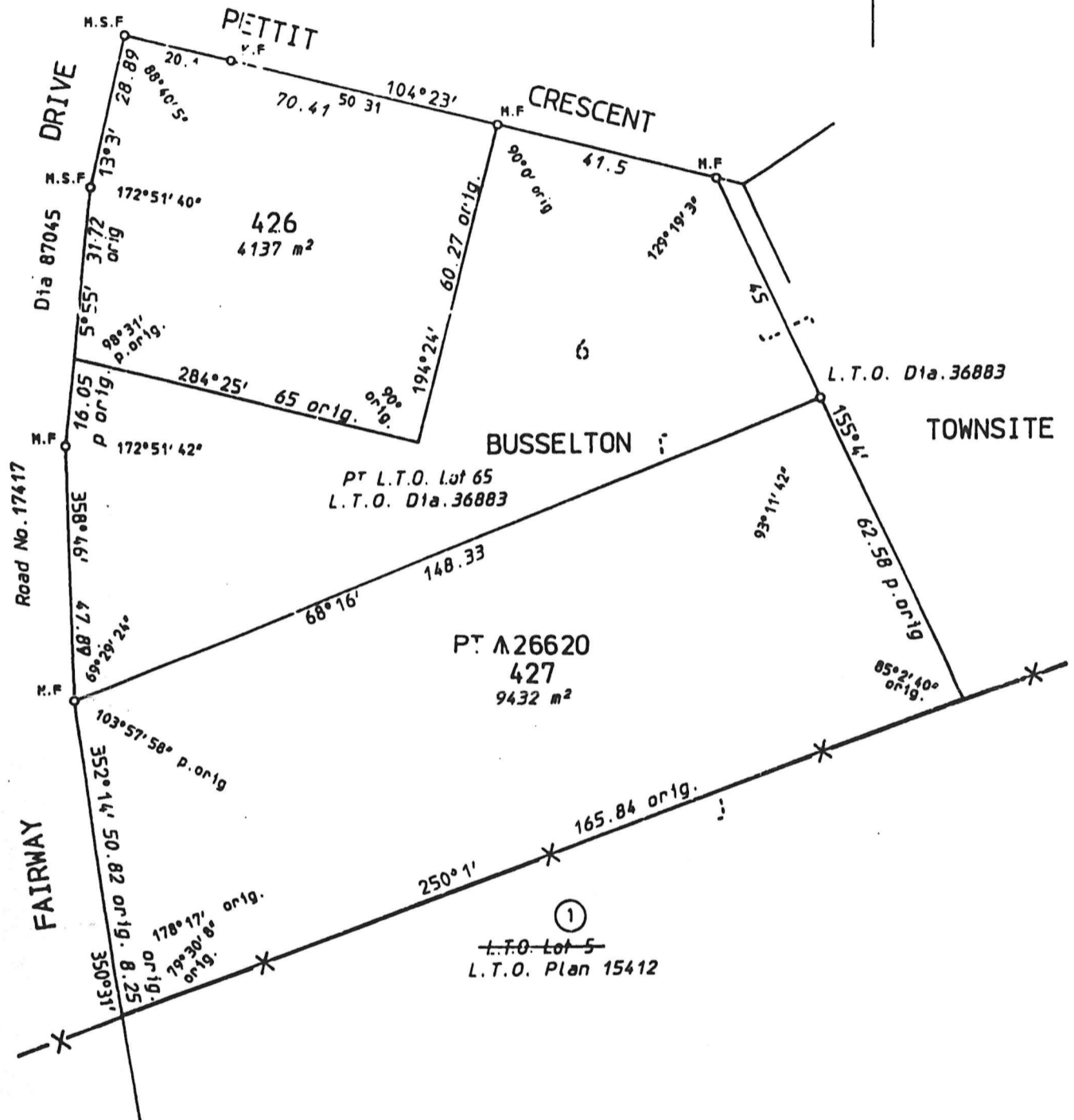




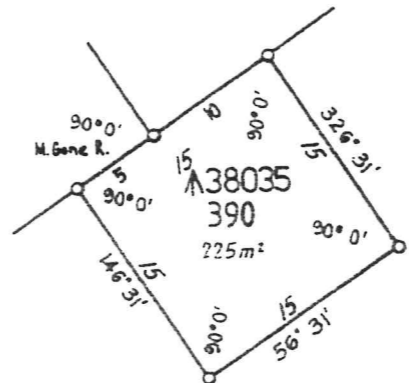
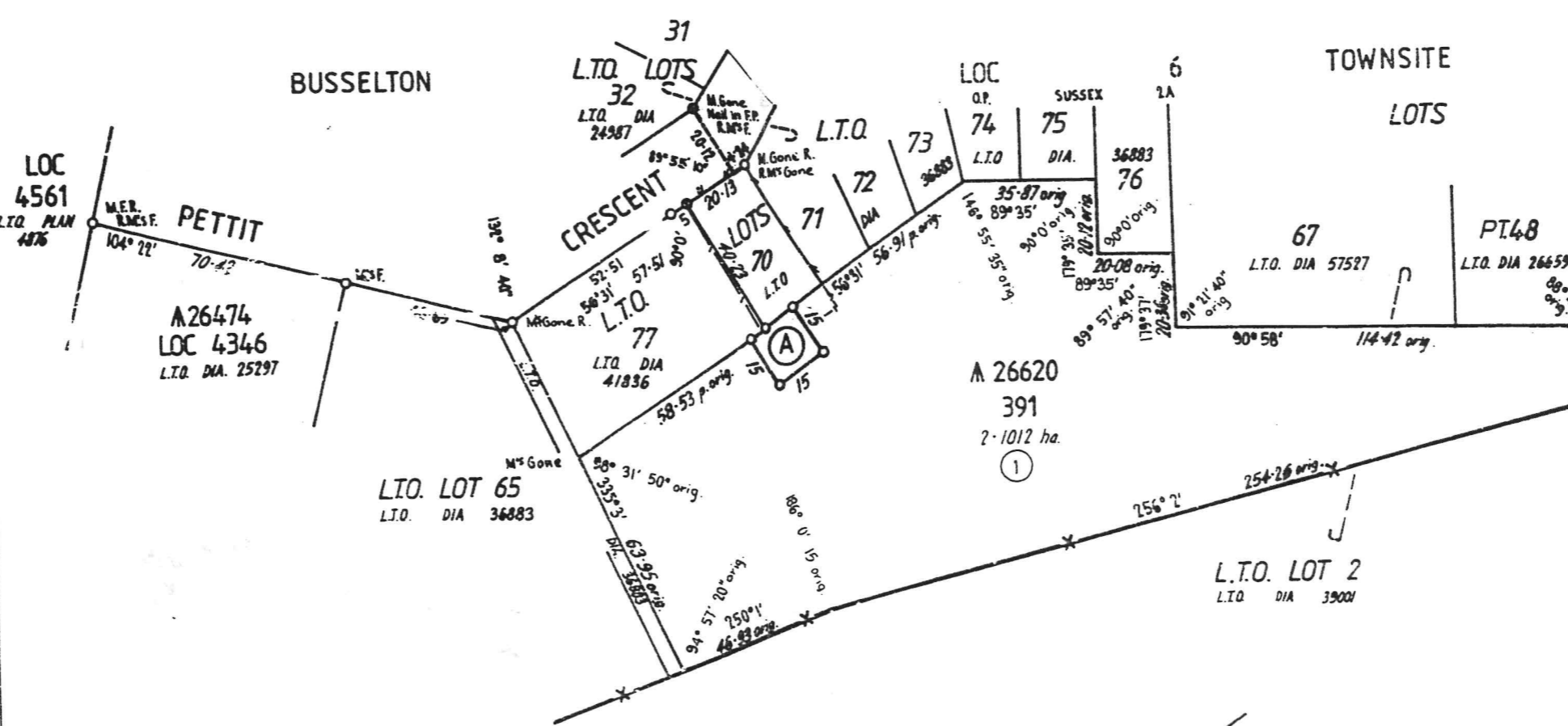
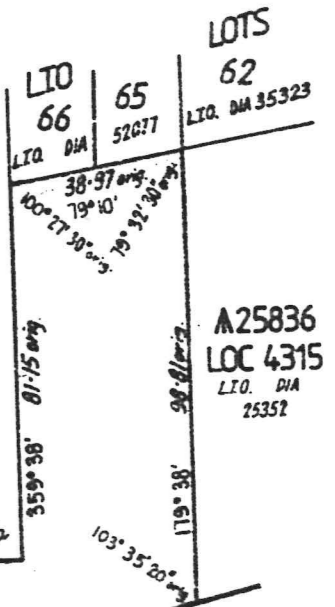
Part of the Plan of the Bosseton Townsite BC 2012/23/35

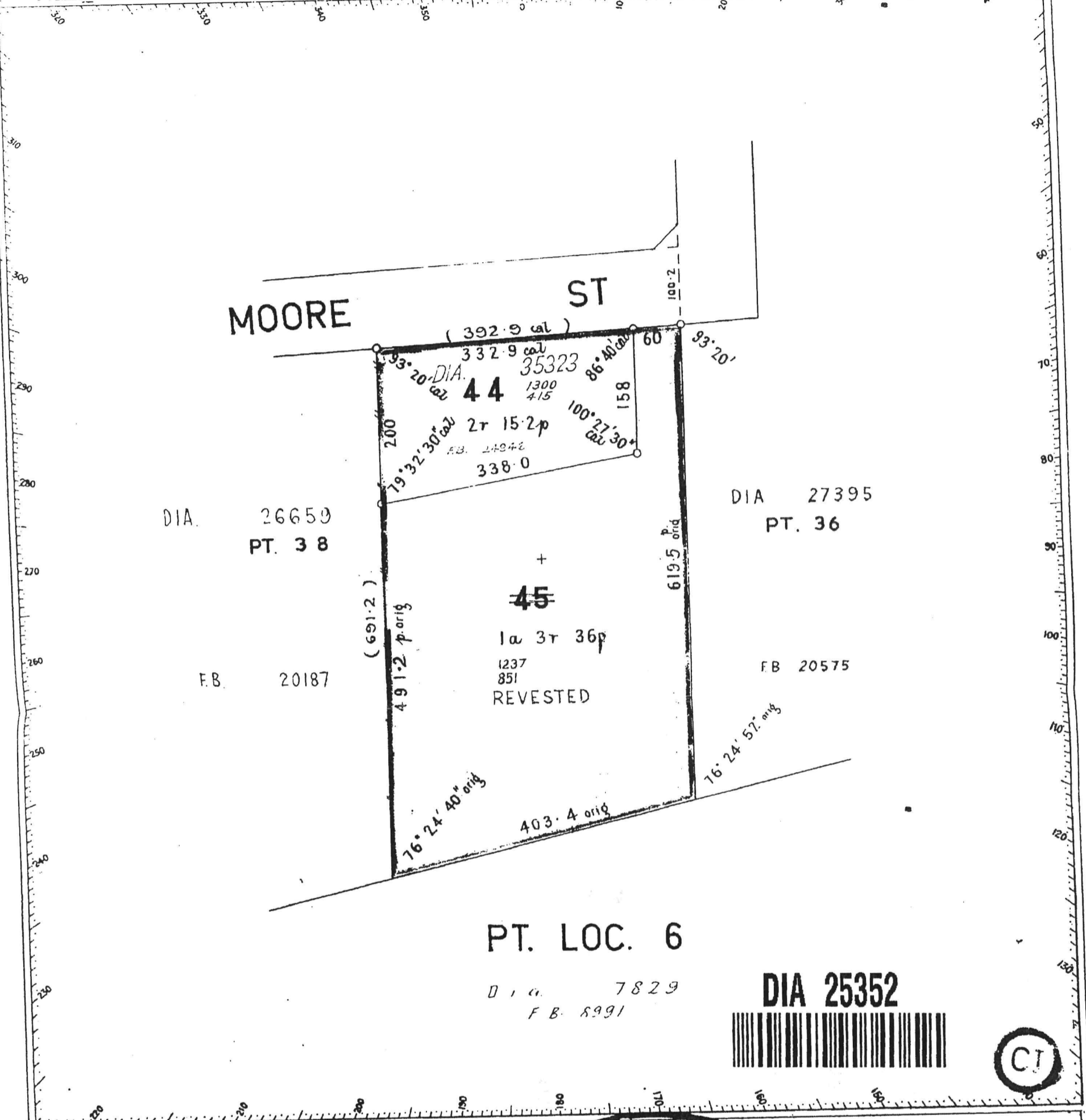
