In 2009 the Department of Environment and Conservation was approached to accept management over reserve 26810 "Camping Boy Scouts" which was no longer required by the Scout Association of Australia. Scouts Australia advised that the reserve had not been developed as a campsite and there were no plans to develop the site. On 29 April 2011 the addition was finalised and as a result the boundaries of the reserve have been amended to include Lot 27991 on Deposited Plan 64855 and Lot 27992 on Deposited Plan 208597.

**Total Area:** 8.09 to 116.11ha

**REASON FOR ACTION**

The addition of reserve 26810 to Un-named Nature Reserve 26809 was required for boundary rationalisation and improved management of remnant bushland.
