WHEREAS it is enacted by subsection (2) of Section 15 and Subsection (2) and (3) of Section 152 of the Petroleum Act, 1967-81 that notwithstanding the Land Act, 1933 or any other Act the Governor, by proclamation, may declare that any land of the Crown or part thereof reserved for or dedicated to any public purpose under any Act and howsoever classified that:

- (a) is not Crown Land within the meaning of that expression in Section 5 of the Act; and
- (b) is specified in the proclamation, is Crown Land for the purposes of the Petroleum Act, 1967-81 and is land to which that Act applies, so long as the proclamation remains in force:

1. Fire 2. Lands

Now, therefore, I the Governor acting with the advice and consent of the Executive Council and in the exercise of the powers under Subsection (2) of Section 15 of the Petroleum Act, 1967-81, do hereby declare that the land of the Crown comprising Reserve Nos 24275, 24437, 35593 & 35594 classified as Class "C" and set apart for the purposes of Education, Water and Camping, a Gravel Pit and the Conservation of Flora respectively pursuant to the provisions of the Land Act, 1933 is Crown Land for the purpose of the Petroleum Act, 1967-81 and is land to which the Petroleum Act, 1967-81 applies so long as this proclamation remains in force, subject to—

The proposed petroleum operations being undertaken in accordance with appropriate conditions determined in consultation with the authorities in which the reserves are vested.

AT a meeting of the Executive Council held in the Executive Council Chambers at Perth on 4 April 1989, the following Orders in Council were authorised to be issued—

Land Act 1933

ORDERS IN COUNCIL

WHEREAS by Section 33 of the Land Act 1933, it is made lawful for the Governor to direct that any Reserve shall vest in and be held by any person or persons to be named in the Order, in trust for any purpose specified in such Order and with power of leasing: And whereas it is deemed expedient as follows—

File No. 1244/60—That Reserve No. 25665 (Cue Lots 315, 461 to 470 inclusive, 483, 566, 567, 568 and 575) should vest in and be held by the Shire of Cue in trust for the purpose of "Caravan Park".

File No. 8351/904 V4—That Reserve No. 32745 (Avon Locations 28446 and 28647) should vest in and be held by the Shire of Beverley in trust for the purpose of Aerial Landing Ground.

Now, therefore His Excellency the Governor, by and with the advice and consent of the Executive Council, does hereby direct that the beforementioned Reserves shall vest in and be held by the abovementioned bodies in trust for with power to the said purposes aforesaid subject to the approval in writing of the Minister for Lands to each and every lease or assignment of lease being first obtained, to lease the whole or any portion thereof for any term not exceeding twenty one (21) years from the date of the lease, subject nevertheless to the powers reserved to me by section 37 of the said Act; provided that no such lease or assignment of lease shall be valid or operative until the approval of the Minister for Lands or an officer authorised in that behalf by the Minister, has been endorsed on the Lease Instrument, or Deed to Assignment, as the case may be.
