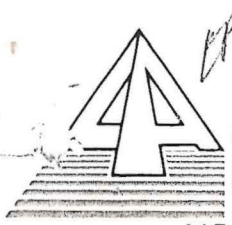

I advise for your information that Executive Council has:

1. Issued an Order in Council revoking the Order in Council dated February 20, 1980 whereby Reserve No. 36519 was vested in the Western Australian Wildlife Authority in trust for the purpose of "Conservation of Flora and Fauna" and approve the cancellation of the relevant Vesting Order accordingly.
2. Approved of the amendment of Reserve No. 36519 (Avon Locations 7019, 7612 and 26016) "Conservation of Flora and Fauna" to include Location 28956 and of its area being increased accordingly.

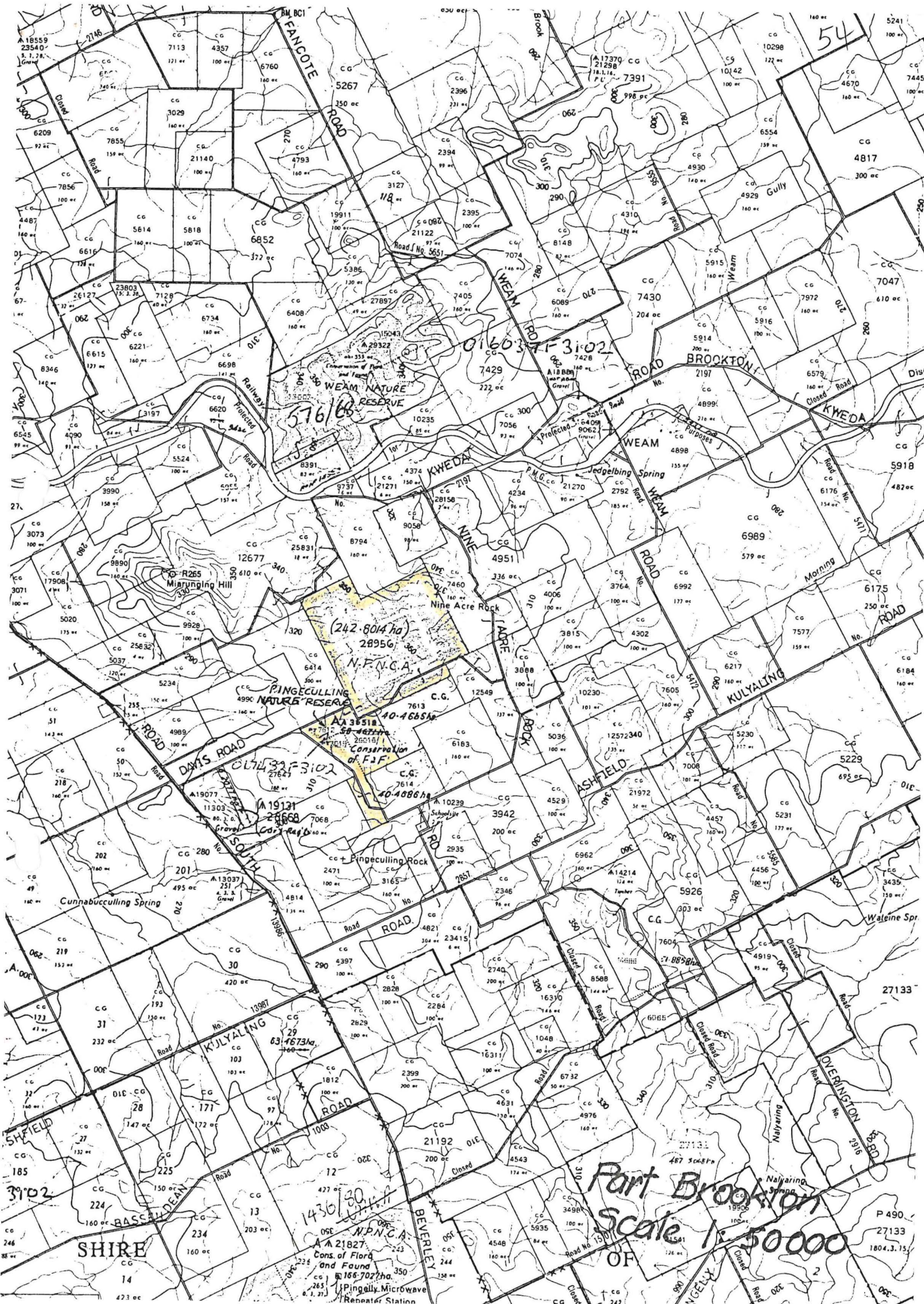
