COLLEGES ACT 1978

COLLEGE OF CUSTOMISED TRAINING STATUTE

Pursuant to section 26 of the Colleges Act 1978 the Interim Council of the College of Customised Training hereby makes the Statute set out hereunder and authorises the affixing of the Common Seal of the College thereto.

Statute 1

1.0 Interpretation

1.1 In this statute unless the contrary intention appears—

- "Chairman" means the Chairman of the Council appointed pursuant to section 20 of the Act, or elected under section 16 of the Act.
- "College" means the College of Customised Training established under the Act.
- "Council" means the Council of the College and includes the Interim Council of the College appointed under section 20 of the Act.
- "Managing Director" means the person appointed or seconded to be the Chief Executive Officer of the College pursuant to section 30 of the Act and includes a person appointed as Acting Managing Director.
- "Member" means a member of the Council.
- "Minister" means the responsible Minister.
- "Rule" means any rule or by-law made under a statute pursuant to section 26 (7) of the Act.
- "Sealed" means sealed with the Seal.
- "Section" means a section of the Statute in which the word is used.
- "Statute" means a Statute of the College made pursuant to section 26 of the Act.
- "The Act" means the Colleges Act 1978.
- "The Seal" means the Common Seal of the College.

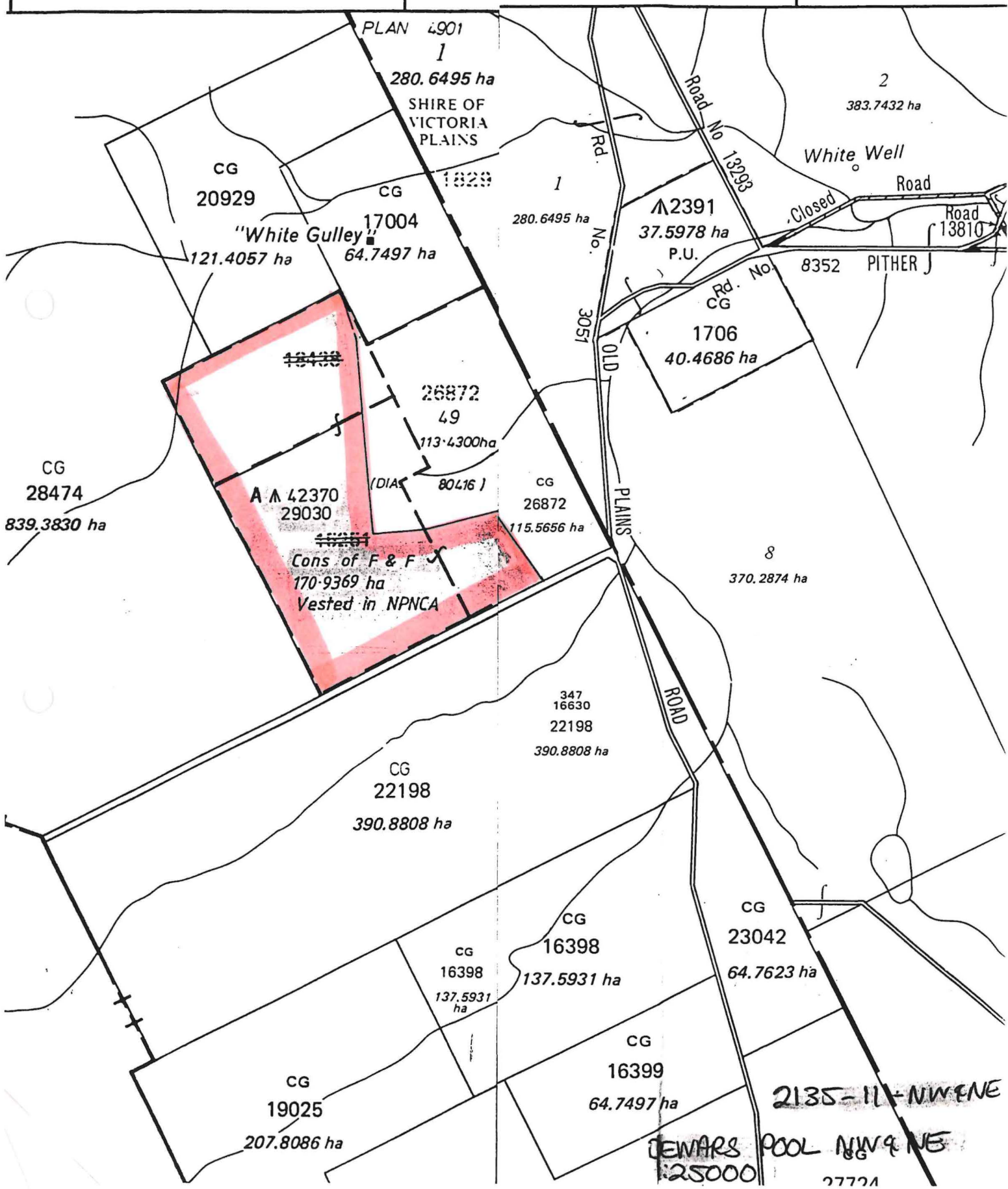

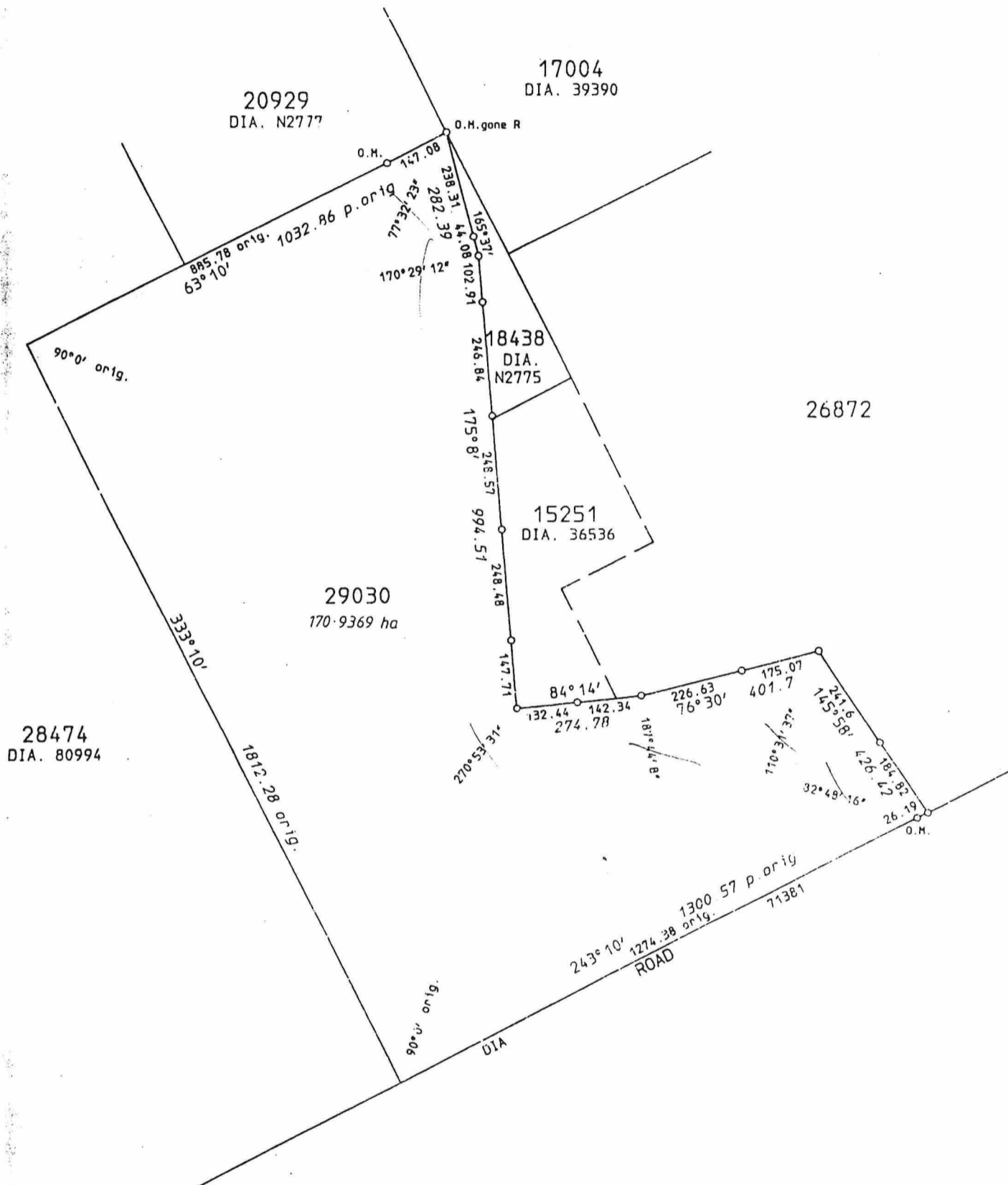
