  - (a) the cancellation of:-
    - (i) Reserve No. 28004 (Yilgarn Locations 707 and 1332) "Conservation of Flora and Fauna".
    - (ii) Reserve No. 28233 (Yilgarn Location 1442) "Government Requirements".
  - (b) the amendment of Reserve No. 22710 (Yilgarn Location 1364) "Government Purposes (State Alunite Industry)" to exclude that portion now comprised in Locations 1574 and 1575 and of its area being reduced accordingly.


