SOIL AND LAND CONSERVATION (RAVENSTHORPE LAND CONSERVATION DISTRICT)
AMENDMENT ORDER 1994

Made by His Excellency the Governor in Executive Council under section 23 (2d) of the *Soil and Land Conservation Act 1945* on the recommendation of the Minister for Primary Industry.

Citation

1. This order may be cited as the *Soil and Land Conservation Act (Ravensthorpe Land Conservation District) Amendment Order 1994*.

Principle order

2. This order may be cited as the *Soil and Land Conservation Act (Ravensthorpe Land Conservation District) Order 1986** is referred to as the principle order.
