- Creation of a class 'A' nature reserve vested in the National Parks and Nature Conservation Authority for the purpose of *Conservation of Flora and Fauna* . Area: 6.1235 ha.
- Reserve created as the result of purchase of private property, Swan Location 1718 and portion Swan Location 2358 from W and RD Kolb. The block was purchased under the National Reserve System Co-operative Program.
- The land is an example of the unique plant community associated with the unique geology of the Muchea limestone occurrence. It has been identified as a threatened ecological community.

REASON FOR ACTION

- Addition of Swan Location 2585 (purchased land) to class A reserve 45035 for the purpose "Conservation of Flora and Fauna", with a Management Order issued to the Conservation Commission. This resulted in the area of A↑45035 being increased by 64.7 hectares.
- Area: 70.8 hectares.
- Swan Location 2585 is of high value for conservation as it supports a critically endangered plant community unique to the geology of the Muchea limestone soils: tall heathland or shrubland with a well-developed ground layer of seasonal herbs.

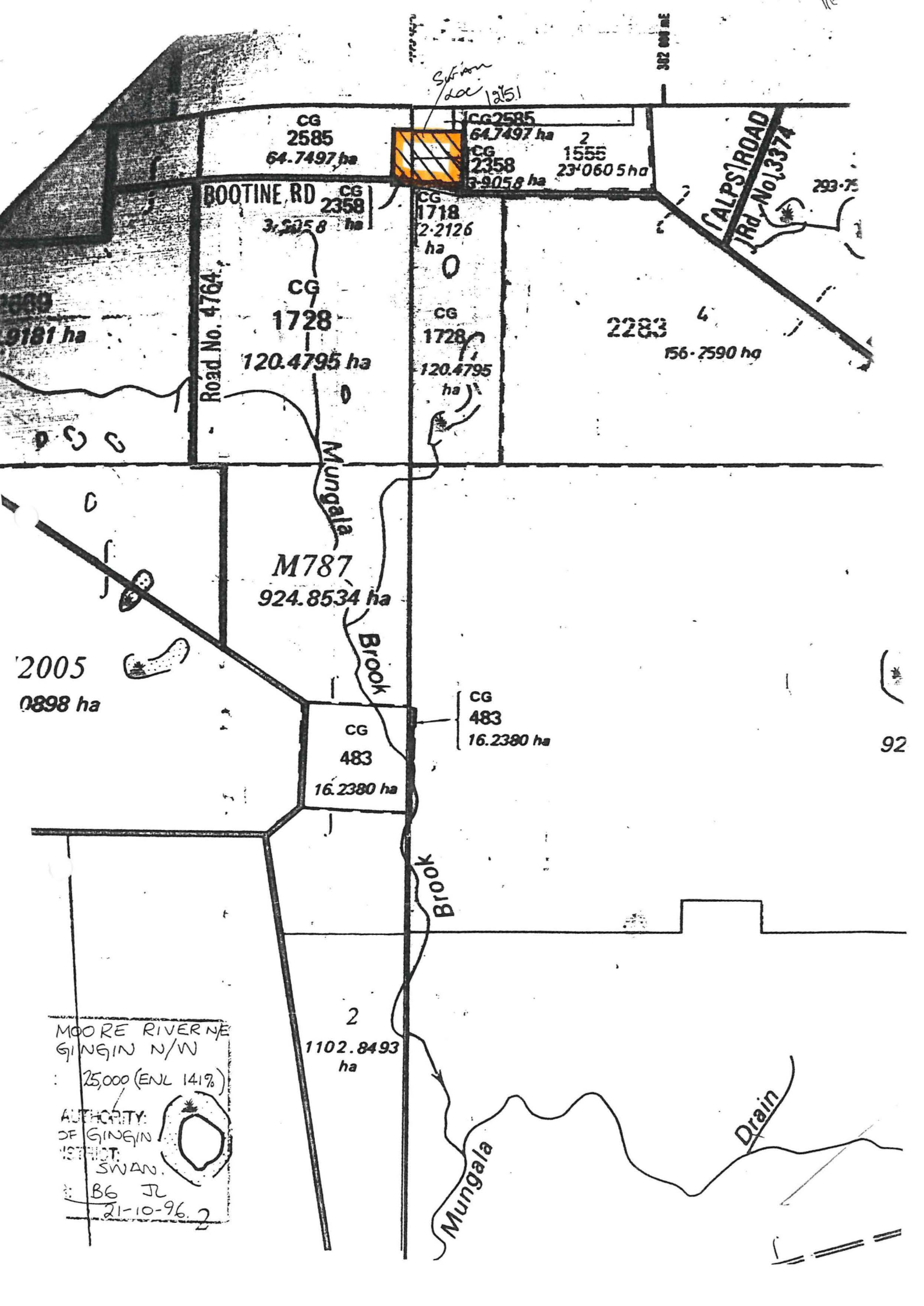
PART DOA PLANS:

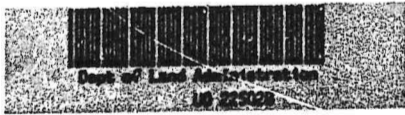
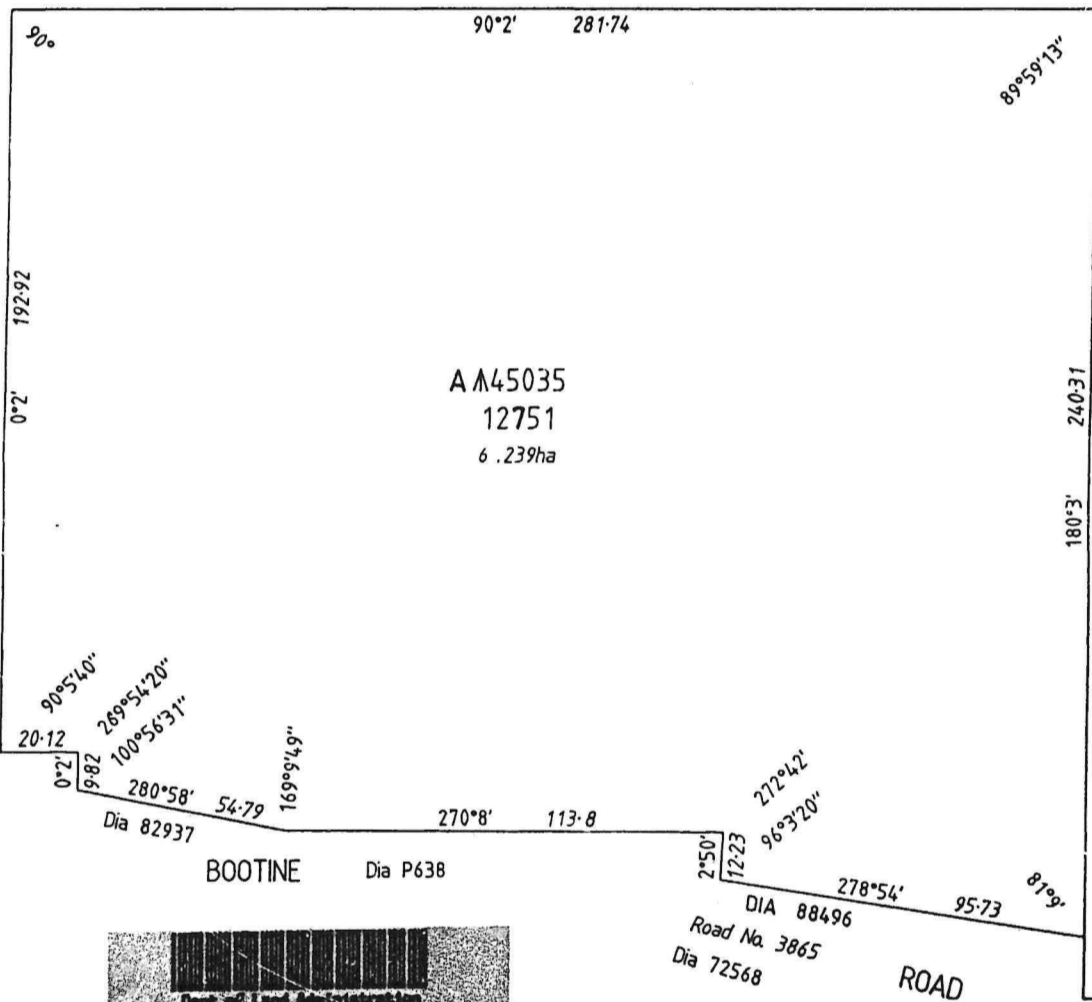

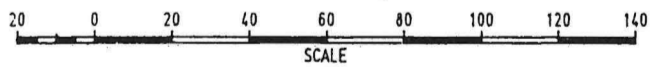
