LOCATION BOUNDARY IS 10 METRES INWARD FROM CENTRELINE OF UNDEDICATED ROADS

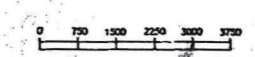
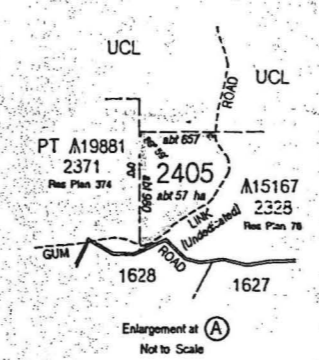
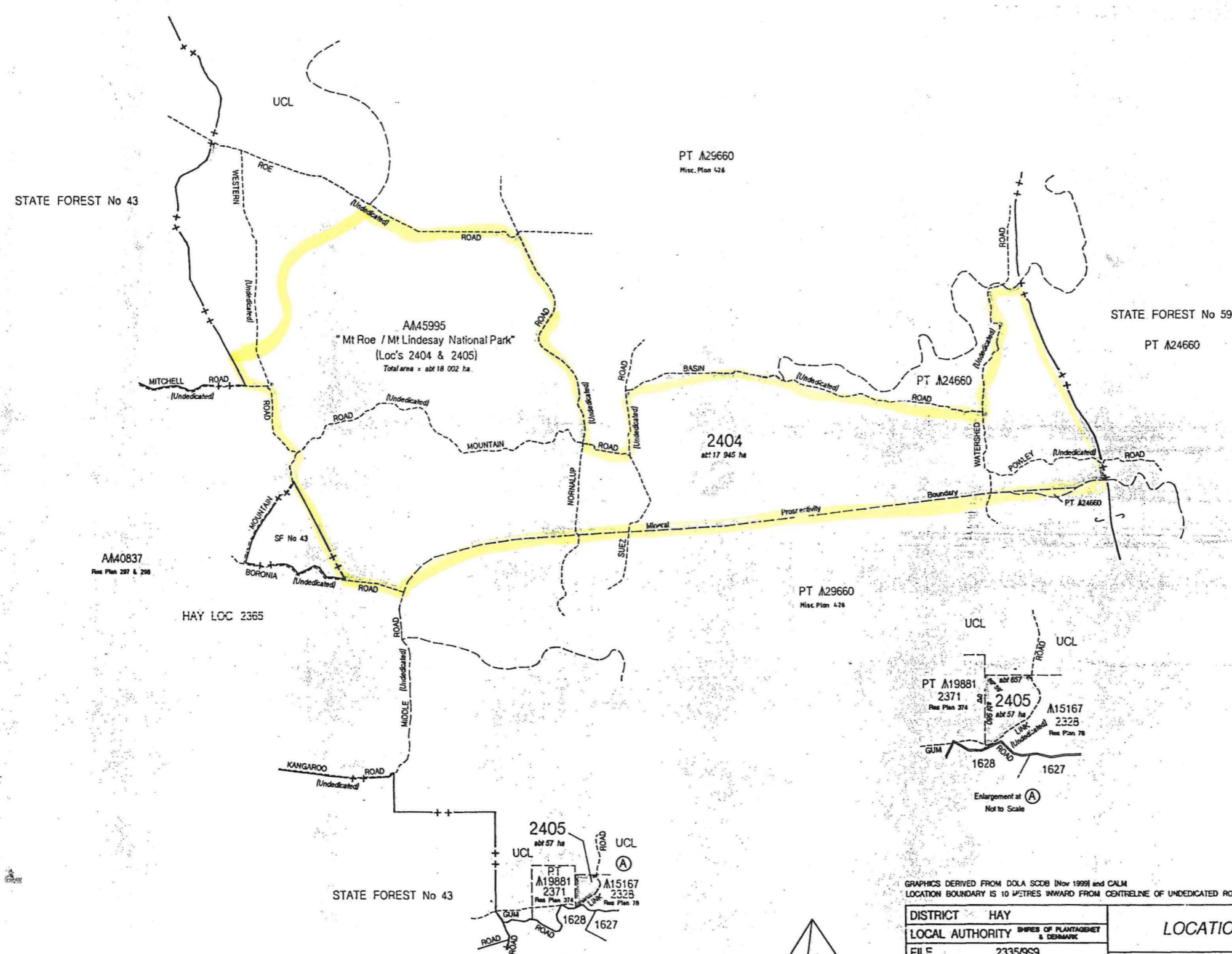
