RESERVE 46713: SHIRE OF COOROW

REASON FOR ACTION

Reserve 46713 was created following the purchase of Part Victoria Location 10825 in May 2000. The purchase was funded under the State's Salinity Strategy and the National Reserve System Program of the Natural Heritage Trust. The class C reserve is vested in the Conservation Commission of WA for the purpose "Conservation of Flora and Fauna".

Area (C↑46713): 286.811 ha

The reserve is located on the corner of Brand Highway and Coorow-Greenhead Rd, about 30 km south of Eneabba. This remnant of vegetation is located midway between four major conservation reserves: South Eneabba Nature Reserve, Alexander Morrison National Park, Coomallo Nature Reserve and Lesueur National Park. Its location between these reserves is important as part of a biological corridor and stepping stone for fauna movement within a highly fragmented and altered agricultural landscape

The reserve contains a number of vegetation communities and plant species poorly represented in the area. This includes four species of Declared Rare Flora: *Eucalyptus suberea*, *E. lateritica*, *E. johnsoniana* and *Hakea megalosperma* and two species of Priority flora: *Arnocrinum gracillimum* and *Verticordia rutilastra*.

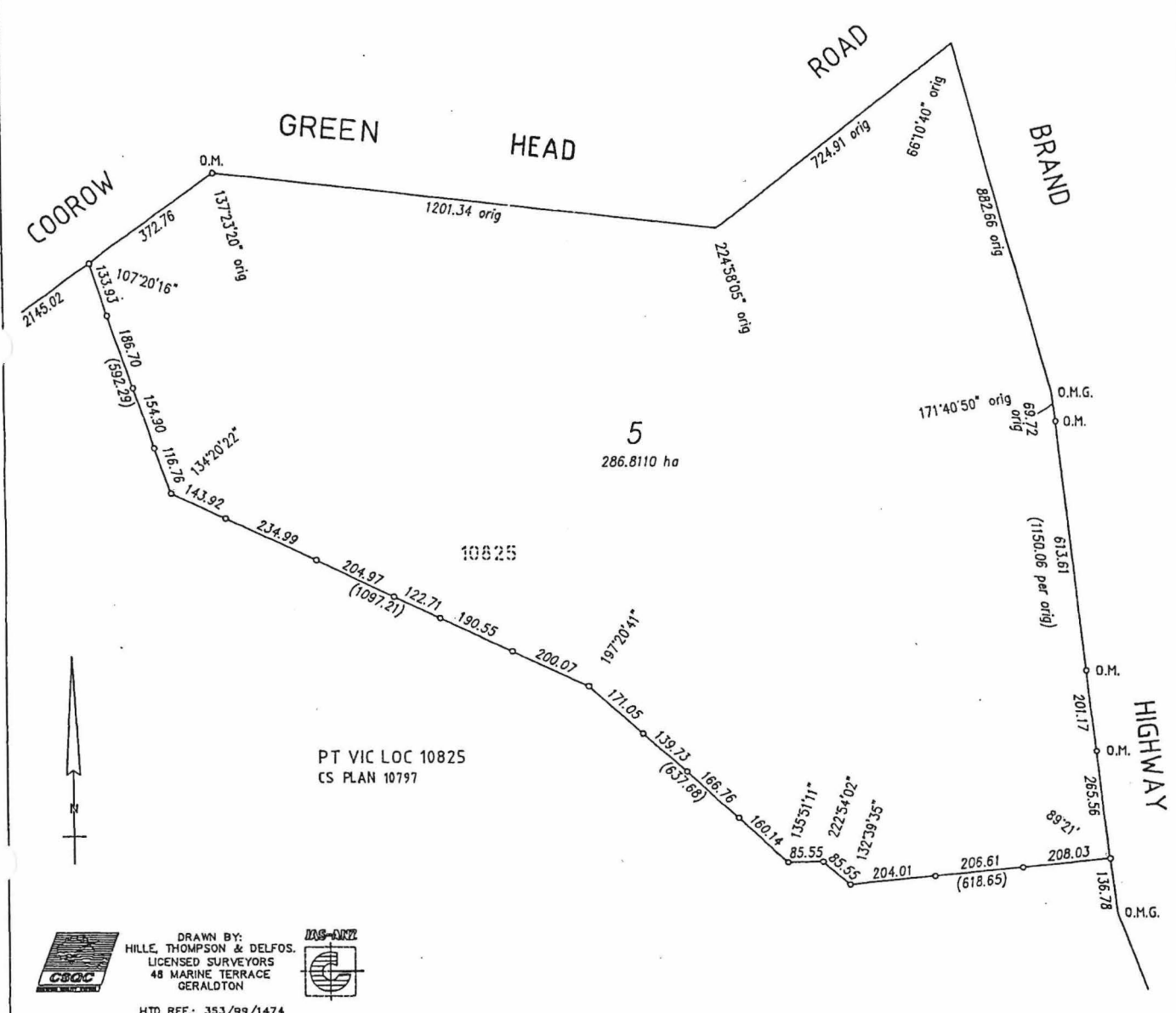


