**Total Area:** 151.1765 hectares

**REASON FOR ACTION**

In 2009 the Department purchased Lot 3 on Deposited Plan 64325 to protect the hydrology of nearby Lake Toolibin, a large freshwater lake and a listed RAMSAR site which is under threat from salinity. A reserve was created over the purchased Lot 3 and Reserve 19686 (Lot 14345) as part of the recovery plan. The Department is proposing to revegetate salt affected areas of Reserve 52018 and provide upstream protection to Lake Toolibin.
