**Total Area:** 10114 ha

**REASON FOR ACTION:** This reserve was identified as a part of the proposed Dundas Road reserve within the Strategic Assessment of Perth and Peel Regions project (SAPPR).

This reserve is not an immediate priority within the SAPPR project, however it was created as a result of a subdivision by Main Roads to dedicate their road requirement and to create a further reserve for the DBNGP corridor requirement from the original lot 30.

There are further portions of adjacent land to be consolidated to form other new reserves, which is currently being carried out by DPLH. Once completed, these new reserves will be amalgamated to form a new class A reserve.
