Creation of reserve over Lots 499 and 501 on Plan 413357.

**Total Area:** 262.9814 hectares

**REASON FOR ACTION:**

In 2011 Reserve 14522 was identified as surplus to requirements by its management body and the Department was invited to accept management of a portion of the reserve.

The northern portion of the reserve is 262 hectares in area and contains native vegetation in good condition, with two recorded populations of threatened flora. Historical records indicate that the reserve is an important wildlife refuge and breeding area for Carnaby Cockatoos.

The southern portion of the reserve is 13.73 hectares in area and contains a dam and water catchment. The southern portion has been vested in the Shire of Kent for 'Water Supply'.

The transfer of the new conservation reserve was completed by the Department of Planning, Lands and Heritage on 28 June 2018.

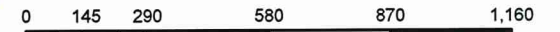
