COMMENCEMENT AND APPLICATION 1.

- This Management Plan shall apply to Reserve 15385 as of the date of its endorsement by the Minister for Lands.
- The Management Plan shall apply to the total area of the Reserve, as at the time of its endorsement by the Minister for Lands, irrespective of any subsequent cancellation, subdivision, excision or amalgamation, until such time as:
 - The Minister for Lands replaces it with another Management Plan, or i)
 - The Minister for Lands cancels the Management Plan. ii)

INTERPRETATION 2.

Approved purpose shall mean a Purpose endorsed by Council, in consultation with the Reserve Management Advisory Committee, as being consistent with the purpose of the Reserve and the Management Goals of the Management Plan

Committee means the Reserve Management Advisory Committee.

Council means the council of the Municipality, constituted under the Local Government Act 1995, in which the Reserve is vested.

Fauna means fauna within the meaning of the term in the Wildlife Conservation Act

Firewood includes parts of trees of all species made up into bundles, billets, or loads, or cut up in the manner it is usual to cut wood for burning, and residue wood

Flora means any plant (including wildflower, palm, shrub, tree, creeper or vine) which is:

- Native to Western Australia: or
- Declared to be flora pursuant to Section 6(4)(a) of the Wildlife Conservation Act and includes any part of the flora and all seeds and spores thereof.

Land includes:

- Tidal land
- Tidal waters in any inlet, estuary, lagoon, river, stream, or creek; and
- The waters of any inlet, estuary, lake, lagoon or swamp or of any river, stream or creek whether flowing continuously or intermittently.

Licence, in relation to either flora or fauna, shall mean a license issued pursuant to the

Management Plan means the Management Plan constituted under Section 34(A) of the *Land Act 1933* and applying to the Reserve.

Management Goals means those goals listed under Section 3 of the Management Plan.

Management guideline means any Bylaw, or documented policies, guidelines, or operational plans, or any other document adopted by Council, in consultation with the Committee, that describes how the Reserve and the resources it contains may or may not be used.

Reserve Management Advisory Committee means the Committee, described in Section 4 of the Management Plan, formed pursuant to the Local Government Act.

Reserve shall mean the Crown Reserve detailed in Section 1(a) of the Management Plan.

To take, in relation to the flora, includes to gather, pluck, cut, pull up, destroy, dig up, remove or injure the flora or to cause or permit the same to be done by any means.

3. MANAGEMENT GOALS

The Management Goals for the Reserve are:

- a) to conserve the indigenous species of plants and animals, the aesthetic values and the natural environmental process occurring on the reserve;
- b) to preserve the landscape amenity provided by the reserve: and
- c) to facilitate the public enjoyment of the natural attributes of the reserve, by providing for passive recreational activities in a manner that does not compromise the conservation, landscape protection and other management objectives.

4. ADVISORY COMMITTEE

- (a) A Reserve Management Advisory Committee will be established pursuant to Section 5.8 of the Local Government Act 1995.
- (b) The role of this Committee shall be to advise Council on the forms of integrated management that are necessary to achieve the Management Plan's Management Goals.
- (c) The committee will consist of not less than:
 - i) Two (2) representatives of the Kulin Shire Council,

- Two (2) representatives from the residents of the Kulin Shire (not being elected representatives of the Kulin Shire Council), and
- iii) Two (2) representatives of interested parties (not being elected representatives of the Kulin Shire Council).
- (d) The Committee shall meet to discuss matters of relevance, with a quorum of not less than three quarters its full compliment, not less than once per year.
- (e) The committee will be encouraged to access advice from State and Federal Authorities and other organisations on relevant matters.

5. RESPONSIBILITY FOR MANAGEMENT

The management of the Reserve shall be carried out by Council:

- (a) In accordance with the terms and conditions stated in this Management Plan where the matters are covered by Sections 1, 2, 3, 4, 5, and 6 and Schedule One of this Management Plan; and
- (b) for actions not listed in Sections 1, 2, 3, 4, 5, and 6 and Schedule One of this Management Plan:
 - (i) in accordance with management guidelines given in Section 7 and Schedule One, and amendments to these and other specific decisions adopted by Council after consultation with the Reserve Management Advisory Committee; or
 - (ii) in emergency situations, where compliance with section 5(a) is not feasible, in such a manner as to protect persons, property, land, and natural or recreational attributes.

6. PROHIBITED ACTIVITIES

Council shall not, in relation to the Reserve, approve any person to:

- (a) mine, extract, winnow or quarry sand, soil, gravel, rock, stone or any other basic raw material.
- (b) in any way disturb, interfere with, frighten, drive, molest or take any fauna, whether by noise or any other means, in the reserve unless -
 - (i) the person is licensed by CALM to undertake fauna research; or
 - (ii) a damage license has been issued by CALM for the taking of a fauna species from the reserve.

- cut, pick, pull, break, remove, injure, poison, strip or destroy any tree, shrub, herb, grass or other plant or part thereof, whether living or dead, for any commercial purpose, including grazing;
- (d) deposit or leave any offal, refuse, rubbish or litter of any kind in the reserve or break any bottle, glass or cup, suffer such to remain in the reserve.

7. RESTRICTIONS

In respect of the reserve, Council shall not, except as allowed under Section 5 (b) of this Management Plan, approve any person to:

- cut, pick, pull, break, remove, injure, poison, strip or destroy any tree, shrub, herb, grass or other plant or part thereof, whether living or dead, except as part of an activity organised and approved by the Council and the Reserve Management Advisory Council;
- (b) post, stick, stamp, stencil, paint, draw or otherwise affix any mark, lettering, notice, advertisement, sign or document of any description, or have in his possession on the reserve any material of any description capable of being used for such purpose;
- (c) cut or make any tracks, parking area, or resting area for any vehicle, helicopter or Hovercraft, or use, operate or park such a vehicle, helicopter or Hovercraft other than in a place lawfully set aside for that purpose;
- interfere in any manner with any watercourse, drainage flow, water hole, or dam, whether natural or artificial;
- drive, tow or operate any vehicle of any description except on a road or track lawfully set aside, reserved or provided for that purpose;
- take, carry, operate, fire or use any firearm, throw or discharge any missile or explosives;
- (g) take, ride or drive, graze or agist any dog, cat, fox, horse, cattle, sheep, goat, camel, donkey, mule, pig, fowl, or other exotic bird or other animal, or suffer or allow any such exotic bird or animal to remain on the reserve;
- (h) lay any telephone line, electric light or power line, water pipe line, gas pipe line, oil pipe line or carry out any other works or drain or clear or prepare any part of the reserve for any purpose;
- light any fire, other than in an authorised fireplace, or burn or clear by any
 means whatsoever any tree, shrub, grass or other plant, whether living or dead;
- introduce, place, drop, pour, spray, fog, mist or otherwise use or discharge any dangerous, poisonous or noxious substance;

- (k) do or take anything which may interfere in any manner with the natural environment;
- camp or erect tents on the reserve, expect on bare ground contained within areas designed by Council, for the purpose of camping;
- (m) build, erect or transport any shed, outhouse, cottage, building, fence, or any structure whatsoever in the reserve.

8. ENFORCEMENT

Council shall take the necessary steps to enforce the provisions of Sections 6 and 7 of the Management Plan $\,$

SCHEDULE ONE

MANAGEMENT GUIDELINES

Priority Listed flora and an outlying population of Jarrah (Eucalyptus marginata)
occur on the Reserve and have significant conservation values. At present the Jarrah
population has been visibly degraded over at least the last thirty years. The major
cause of this degradation is probably compaction of the soil around the root zone,
resulting in reduced recruitment to the population and decreased vigour of the
remaining trees. This compaction appears to be the result of an uncontrolled access to
a recreation site set amongst the Jarrah.

To ensure the survival of the Jarrah population, the recreation site is to be redesigned as indicated in the recreation plan previously developed for the site by CALM. Recreation facilities such as barbeques and parking areas are to be provided within the rationalised site. The removal of the existing barbecue from the immediate vicinity of the Jarrah into the designated recreation site is more consistent with a planned recreation site able to accommodate greater numbers of visitors.

The Council will take action to ensure the survival of the Jarrah and Priority Listed species that occur on the Reserve. The Priority Listed species currently known to occur on the Reserve are listed in Appendix One.

- Wildfire control is considered a priority by Council and the community. An effective volunteer Bush Fire Brigade will be maintained by Council. In addition, a low fuel zone, in the form of a 3 metre wide firebreak, will be maintained around the external perimeter of the Reserve by Council. The removal of the barbecue from the immediate vicinity of the Jarrah, and the prohibition on lighting fires except in the recreation zone within designated fireplaces, will further lower the risk of wildfire starting in the Reserve.
- Sites of significance to Nyoongah people are known to occur within the Reserve. It is
 necessary that these sites be preserved from disturbance. Prior to any works being
 conducted on the Reserve, the Shire will consult with Nyoongah elders from the area.

FUTURE MANAGEMENT OF RESERVE NUMBER 15385 JILAKIN.

On the 2 January 1996 the Water Authority wrote to the Narrogin District office requesting CALM to provide a recommendation for the future management of reserve number 15385.

A search of the Narrogin District files for previous reserve inspections and other relevant information concerning this reserve was undertaken. A field inspection of the reserve was also undertaken and a Reserve Assessment Form was completed, (see attached). This assessment revealed the reserve has a

In addition to the high conservation value, the reserve has a high recreational value. There is a strong desire by the Shire of Kulin and the local community to continue with, and increase the level of, recreational activity occurring on the reserve, especially in the vicinity of the Jilakin Rock.

Therefore, given the conflicting values that exist on the reserve, it is essential that the agency who is best able to manage the reserve gains vesting.

The following outlines possible future management options for this reserve

Leave the reserve vested with the Water Corporation. 1.

FOR:

Nil.

AGAINST:

Water Corporation wish to relinquish the Reserve. Therefore, this is not a

desired option.

Vest with National Parks and Nature Conservation Authority (NPNCA) as a Nature Reserve

FOR:

Increased protection of the flora, fauna and landscape values of the reserve,

particularly the Eucalyptus marginata population.

AGAINST:

Costs to CALM for developing recreation area.

Possibly antagonising CALM's relationships with the Shire and locals.

Current high recreation usage at odds with conservation values.

Costs to CALM to rehabilitate gravel pits.

 Vest with Shire of Kulin with a dual purpose of Landscape Protection and Recreation, with the completion of a Management Plan under section 33A of the Land Act.

FOR:

The recreational development is managed by the shire and local community. The nature conservation values remain protected through establishment of a management plan.

CALM will still have input into the protection of the *Eucalyptus marginata* population, as well as other environmental protection issues.

AGAINST:

CALM not directly involved in the management of the flora, fauna and

landscape values.

The preferred option for the future management of reserve number 15385 is option 3. For CALM to insist on the reserve becoming a nature reserve would be unwise considering the desire by shire to manage the area and the local level of interest in developing the recreational potential of the reserve. The protection of the existing flora, fauna, and landscape values will be adequately protected with the inclusion of a landscape protection purpose and the completion of a Land Act Management Plan.

Therefore, I recommend for the future management of this reserve the following be undertaken:

- The completion of a Management Plan, by the Shire of Kulin, as described under section 33A of the Land Act.
- When the Management Plan is completed, comment and approval be sought from the relevant authorities, including CALM.
- 3. When the Management Plan is approved, reserve number 15385 to become vested in the Shire of Kulin, with a purpose of *Landscape Protection and Recreation*.

The Water Corporation have been advised of my recommendation. You may soon receive correspondence from DOLA concerning the future management of this reserve.

FUTURE MANAGEMENT OF RESERVE 15385 - JILAKIN

In reply to your letter 02 January 1996, the following comments and recommendations are made concerning the future management of reserve number 15385.

The reserve has been assessed as having a number of nature conservation values. These include, Jilakin Rock which is large granite rock, the vegetation types associated with the rock, and the Jarrah (Eucalyptus marginata) population. This stand of jarrah is unique and represents the eastern most occurrence of this species.

The Shire of Kulin, and some members of the Kulin community are aware of these reserve values. I believe the Shire and the community are keen to protect these values.

The use of the reserve for recreational purposes will increase particularly with the promotion of the area, by the shire, as a prime recreational site. This increased human usage will place pressure on the existing natural values.

Therefore, considering the Water Corporation's wish to relinquish this reserve, and the Shire of Kulin's desire to obtain future vesting, I recommend the following steps be undertaken:

- The completion of a Management Plan, by the Shire of Kulin, as described under section 33A of the Land Act, prior to any vesting changes.



I refer to your memo of 16 June 1999 in which you requested this Department's comments on the above reserves.


My memo to you of 24 March 1999 refers (copy attached). Since then a memo regarding Reserve No. 17911 was sent to your Department on 10 May 1999.

WATER RESERVES IN THE SHIRE OF KULIN

I refer to your memo dated 26 June 1998 and recent telephone conversation between your Miss Bathgate and Miss Duncan of this office concerning the abovementioned matter.

As discusssed, the letter from the Water and Rivers Commission to CALM was pre-emptive in that in the first instance I was simply seeking their confirmation and that of the Water Corporation that the listed reserves were surplus to requirements. The intention being that once I had received the responses of both organisations the list of available reserves would be updated as required and directed to CALM for comment.

As it is, the Water Corporation has advised that Reserves 18926, 22267 and 25777 are still required and accordingly they should be deleted from the list.

Reserve No. 16942 (Dudinin Lot 130) is currently managed by the Corporation for the purpose of "Water Supply". The Corporation have stated in their advice that the reserve is not required however as a precautionary measure I have sought confirmation on this reserve. I will contact you separately with regards to this reserve although it may be prudent to leave it on the list for assessment by your Regional offices.

Reserve No. 20012 has been deleted from the list following your helpful advice that it is actually situated in the Shire of Dumbleyung. The Shire of Kulin has been apprised of progress in this matter.
