ROADSIDE CONSERVATION AWARD 1995

JUDGING CRITERIA

All projects should demonstrate sympathetic treatment, management, preservation or restoration of the rail or roadside environment.

Project is defined in its broadest sense and may include any section of the rail or roadside where as a matter of policy, no action has been taken.

Projects submitted should have been established at least two years (24 months) prior to submission of the project.

Protection or restoration of the roadside environment:

- protection of existing endemic vegetation, use of endemic vegetation in rehabilitation, protection of habitat for endemic animals.
- preservation of areas of special scientific or biological interest.
- environmentally appropriate treatment of water courses, cut faces, batter slopes and contouring works.

Integration of natural elements in the design:

- use of existing plants in landscape plans, conformity of design to the natural landform, including balance between cut and fill.
- effect of alignment and profile of road upon the landscape in general.

ROADSIDE CONSERVATION AWARD 1995

GUIDELINES

The Roadside Conservation Award is open to individuals, groups or organisations within Western Australia.

The Award is made for projects that demonstrate sympathetic treatment, management or restoration of vegetation within the rail or roadside environment.

Nominations are to be made on the form provided and accompanying project description should not exceed 1000 words (3 typed A4 pages).

Maps or diagrams of the project should be of A4 size.

Projects can be nominated for one category only.

The judging panel shall consist of a panel of three persons nominated by the Roadside Conservation Committee.

The judges reserve the right to not make an award if no entry is considered of sufficient merit.

Winners of each category will be awarded a high quality sign to identify their project as an outstanding achievement of practical roadside conservation.

Winners or their representatives are asked to be present at the Award Ceremony which will be made at the Local Government Conference at the Burswood Showroom on 6th August 1995 at 5pm.

The Award will be presented by the Hon. Peter Foss MLA, Minister for the Environment and John Colwill of ABC Radio will host the Award Ceremony.

ENTRIES CLOSE 8TH JULY 1995.

CATEGORIES

Local Government Roads

- Projects in this category are restricted to projects on road reserves under the care and management of Local Government Authorities.

State Government Roads

- Projects in this category are restricted to projects on road reserves under the care and management of State Government agencies. eg Main Roads or CALM.

Gravel Pit Rehabilitation

- Projects in this category are for gravel pit restoration on all land tenures.
