#### **New Agreement for AWU Staff**

On 23 December 2010 the Western Australian Industrial Relations Commission issued an order registering the AWU (Western Australian Public Sector) General Agreement 2010.

This General Agreement replaces and cancels in their entirety the:

- Australian Workers' Union (Western Australian Public Sector) General Agreement (No. 45 of 2007),
- Australian Workers Union And Department Of Environment And Conservation Visitor Centre's Industrial Agreement 2007 (No. 50 of 2007),
- State Research Stations, Agricultural Schools and College Workers General Agreement 2007 (No. 42 Of 2007), and
- Midland Sale Yards Agreement 2007 (No. 34 of 2007).

The Agreement provides for a 3% increase on the first pay period on or after 23 April 2010 and a further 2.75% increase on the first pay period on or after 1 January 2011.
