INTRODUCTION

This is a summary of Training Courses available to staff of the Department of Conservation and Land Management.

The publication includes a Training Calendar for the period 1 July 1985 to June 1986, and a set of course outlines.

The Training Calendar (Part 1) is a month by month statement of those courses for which dates have been determined. The course serial number, in date sequence, will enable the course outline to be readily identified in Part 2. In brackets, after the course serial number, is the course code from the computerised training course summary.

The Catalogue is divided into two sections. The first section (Part 2) lists those courses for which there is a generally agreed training need, and for which dates, sometimes general, sometimes specific, have been determined. The second section (Appendix) lists courses which are available if a training need is confirmed but have not yet been programmed definitely.

This publication does not purport to be either definitive or complete. It is expected that further courses will be added and amendments made to courses already programmed.

Officers proposing further courses should:-

- 1. Establish the Training Need.
- 2. Check that the proposed new course does not conflict with courses already programmed.
- 3. Check that funds and other resources are available.
- 4. Fill in the Course Proposal Form (FD819) as described in Circular 6/85: Training Organisation and Procedures. The form should be sent to Regional Forester (Training) F.H. Pridham at Cadet School, Dwellingup.

Officers wishing to amend courses on the calendar should inform F.H. Pridham, Regional Forester (Training) at Cadet School, Dwellingup, who will amend the programme.

Responsibility for issuing course joining instructions lies with the Region, Branch, or Officer initiating the course. For some courses, trainees will already have been selected to attend and will be nominated in the joining instructions. For other courses, interested Departmental Staff will be invited to apply through their O.I.C's. If such staff do not obtain a course vacancy they should use the Staff Appraisal procedure to discuss with their O.I.C. their future participation in similar courses.

Officers conducting courses should endeavour to issue joining instructions so that participants have two months notice of programmed courses. Copies of all joining instructions should be sent to the Secretary of the Departmental Training Committee at Operations Headquarters, Como.

At the end of the course, the initiating officer should comply with Circular 6/85. Please complete and send in the Training Course Evaluation Form (FD 820) and the Course Record Form (FD 794). These forms are essential for the evaluation process, and for updating the central Training Register.

The Training Calendar and Course Outlines presented here are essentially concerned with courses applicable to the Department, lasting more than one day. They are not intended to inhibit local training by Regions and Districts, but to supplement it.
