The association endorse the executives action in applying for National Estate funding to allow delineation of the effect of any agricultural deve opment in the northern buffer zone on the park. Individual members to prepare documentation of aspects they feel should be included in such evaluation. 5. The association nominate the northern buffer zone for inclusion in the register of the National Estate and documentation of signifigance and photographs required to support the nomination be collected and collated (see also 6&7).

6. The association Audio visual on the park be updated to include the signifig ance of the northern buffer zone.

7. That efforts be made to have magazine articles prepared on the northern buffer zone, it's values and the present threat.

Individual members are urged to play their part by writing to the minister stating their views.

Congratulations to the committee on the work already done. May the fruits of your labour bear in the not too distant future.



"MEMU" FRUM K. BRAUBY AND A. CHAPMAN TO THEIR FELLOW EXECUTIVE MEMBERS

We are both concerned that continued Government unwillingness to spend money on developing a management plan for the FRNP, when coupled with Government willingness to spend money on capital works in the FRNP, may have detrimental long term effects on the (as yet unquentified) biological and recreational values of the Park.

We are particularly concerned that while perceived recreational and fire protection requirements have been extensively catered for since the FRNP's gazettal, management of the Park's biological properties has continued to be neglected.

This is not meant as a criticism of those putting NPA policy into practice as wisely and efficiently as possible given the limitations of that policy (or non-policy). It is a criticism of those who set NPA policy and expenditure priorities.

We feel that now is a more than appropriate time for the Association to adopt a firm stand on the matter. Two reasons for this are:

- 1. We see no urgent reasons for any further new capital works to be conducted in the FRNP.
- 2. Government is presently acting on the recommendations of a Report (Task Force on Land Resource Management, Jan.84) which identified the conflict between management for recreation and management for conservation in W.A. National Parks, using the FRNP as its specific example (p.32). Despite this it is planned to incorporate National Parks into the recreation section of the new Department of Natural Land Management.

Given these points we feel that now is a very appropriate time to press for the formulation of a FRNP Management Plan. To continue with further developments and capital works prior to the formulation of such a management plan would be unwise and may in the future be regretted or require expensive rehabilitation measures.

Accordingly we move that the FRNPA Committee resolve that:

"NO FURTHER DEVELOPMENTS INVOLVING EARTH WORKS, MECHANICALLY CONSTRUCTED FIREBREAKS OR IMPROVED VEHICLE ACCESS BE EFFECTED UNTIL A COMPREHENSIVE MANAGEMENT PLAN BASED ON KNOWLEDGE OF THE BIOLOGICAL PROPERTIES OF THE PARK HAS BEEN FORMULATED AND PUBLICLY DISCUSSED."
