Ecoplan update

- from EPA community involvement co-ordinator Margo O'Byrne

Ecoplan continues to attract attention and provide an opportunity for people in the community to join together and work to protect the environment.

I am encouraged by the enthusiasm of Ecoplan volunteers and the number of conservation projects staged in recent onths.

volunteers in the South East metro group have conducted Armadale EarthCare Week at their local shopping centre and had such a resounding success that the shopping centre management have asked them to conduct similar displays and activities at eight other centres throughout the metropolitan area.

Bayswater Greenwork continues to regenerate its piece of wetland on the Swan River foreshore. Work is taking place one Saturday morning each month and if anyone would like to help, please contact Linda Taman on 271 9832.

Parkerville Primary School has received an award for Educational Innovation for the work it has done developing a bush learning programme in the M22 reserve at Parkerville.

Congratulations to Brian Marshall and Bill Frost from the school. If anyone would like a copy of the programme, please give me a call.

Quentin Bligh and Robyn Hart have produced management plans for Yagan Reserve in Bull Creek. The plans are very comprehensive and both of these Ecoplan volunteers deserve congratulations for the supreme effort they have put into these plans. Again, if you would like to read the plans please give me a ring.

Carina Calzoni has produced a brochure on the future of wastewater management in Perth as part of her technology studies at Edith Cowan University.

This brochure ties in with the Perth's Coastal Waters study being done by the EPA and seeks to encourage people to think about the cost involved in wastewater treatment.

The Port Kennedy Land Conservation
District Committee has been undertaking
major preservation and restoration work
on the dune system at M106.

The committee has fenced large parts of the dune to keep trail bikes and fourwheel-drive vehicles off the dunes and has done work on dune restoration.

Many of you will remember the talks given by David Kaesehagen from APACE Aid about the work of bush regenerators in New South Wales.

Since then David has conducted courses in bush regeneration at APACE in North Fremantle and many Ecoplan volunteers have attended these courses.

There will be further courses in 1992 and anyone interested in taking part should contact Susan Lovell at APACE Aid on 336 1262.

In October and November last year we conducted a tour of the System 6 reserves in the South East and the North West regions together with local conservation groups which gave people valuable insights into the issues affecting local areas. These will happen again, when the weather cools down a little.

You will see from the calendar of events listed in this newsletter that there are many activities planned for Ecoplan in 1992.

The most significant is the training for new Ecoplan volunteers and as you will see this is planned to take place regionally, starting in the South East in February.

All volunteers, new and existing are welcome to attend. Please register your interest with me.

For those of you reading this newsletter who may wish to get involved in Ecoplan activities but you're not sure what you can do, there are a variety of activities you could join in either in your own district or for Ecoplan.

Lots of groups are busy working in reserves and if you would like to put some valuable time in just let me know.

Ecoplan has role in local strategies

Ecoplan volunteers have the opportunity to be involved in local conservation strategies which are emerging as a major thrust of environmental protection in Western Australia.

The Environmental Protection Authority will be a prime mover in encouraging local authorities and community groups to develop local conservation strategies.

This was part of the focus of a recent national conference on the role of local authorities in environmental management, staged in Melbourne by the Victorian Office of the Environment.

The EPA's urban conservation manager, Fiona Keating, attended the conference with about 220 other people from various local, state and federal government agencies.

Of particular relevance to the EPA's efforts in WA was a workshop on a Victorian-produced guide to preparing local conservation strategies.

The document — Looking Forward — is a comprehensive, step by step guide for community groups and local authorities to work together to develop strategies for managing their local environment.

System 6 — Ecoplan is a good example of this ethos at work and Fiona said the Looking Forward paper should be of interest to Ecoplan volunteers already working with their local authorities to look after metropolitan System 6 areas.

"They have found in Victoria that some councils have taken up the document

and followed it to the detail while others have picked up the principles and adapted them to their own needs," Fiona said.

"We are keen to have this model adopted here and EPA member Christine Sharp and I have been sorting out with local authorities exactly how this can best be achieved.

"Christine and I already have found that there are local authority initiatives in WA that are quite consistent with the Victorian approach so we are hoping to build on this."

While Ecoplan focussed on urban nature conservation, Ecoplan volunteers could work with local authorities and communities to develop conservation strategies dealing with a broader suite of environmental issues.

"Already some of the volunteers have expressed an interest in this approach and as a result I will be visiting the City of Bayswater to further discuss the concept with them," Fiona said.

"The Victorian guide spells out the value of local conservation strategies for councils, the community, for development activities and for conservation activities so that each part of the community can see the benefits."

Copies of the guide are available from the EPA's community involvement coordinator, Margo O'Byrne.

Coastal studies look to future

With Perth's population predicted to almost double from the current level of 1.1 million people to about 2 million people by the year 2021, the need to provide sound management of our marine environment has never been more urgent.

With accelerating urban and industrial development which accompanies population growth, the pressures on our nearshore marine waters during the coming decades from recreation and waste disposal will be greater than ever.

If we are to manage these waters successfully, we must understand how they function so that the implications of any activities that potentially threaten the health of Perth's marine environment can be anticipated and prevented.

The Southern Metropolitan Coastal Waters Study (1991-94) co-ordinated by the Environmental Protection Authority, will be conducted during the next three years off the southern metropolitan coast of Perth with the final objective being the development of an Environmental Management Strategy for Cockburn Sound and adjacent waters.

A parallel study in the northern metropolitan waters of Perth will be co-ordinated by the Water Authority of Western Australia in collaboration with the EPA.

Both studies have identical objectives and will provide the necessary information to determine the permissible levels of chronic pollutant loading (particularly nutrients) to these waters consistent with maintaining their long term health.

The results of these studies will be used to prevent a repetition of the problems that are now occurring in Sydney and in the marine environments of many of the major coastal cities of the world.

Ecoplan volunteer Carina Calzoni has produced a brochure on the future of wastewater management in Perth as part of her studies at Edith Cowan University.

Regional reports

Central Region

Linda Taman from the Ecoplan Central Region tells us that her group has had many successful Saturday mornings taming the weeds along the Bayswater Swan River foreshore (M51) during the past two months.

Working bees in future will be reduced to once a month due to time constraints of volunteers.

The working bees average out at about five people per session which has been very heartening, and much has been learned in this time, especially about the taming of Typha.

Japanese Pepper Trees and Pampas Grass are being encouraged into extinction by the volunteers.

Participation of those involved in mmunity Offender programmes is also being considered. School children are visiting the area.

North West Region

Suzanne Vaughan and Fay Mumme say that much is still in the planning stage at this time. Eight interested teachers have been contacted and some activities will be planned with these teachers for the future. These will largely depend on the resources of the teachers and Ecoplan volunteers.

The North West group, currently consisting of four volunteers, is hoping to recruit a few more helpers in the next couple of months.

Ourrent main concerns are with helping teachers already interested, as well as widening teacher interest in increasing knowledge on System 6 in the area.

Private development next to Careniup Swamp (M38) is causing concern because of debate over adequate buffer zones and Suzanne will be following up on the project through contacts at Stirling City Council.

She has also made contact with the Council's Stirling Scene publishing team and has organised for an article to be printed outlining issues in her locality.

The Wanneroo Times also has been approached to print an article letting people know about the Ecoplan Volunteer Scheme along with Fay's current interest in furthering the long term interests of Yellagonga Regional Park which will soon undergo development as a more heavily used recreational area for the fast growing North West Corridor.

South East Region

The South East region recently held an EarthCare Week at Armadale Shopping City and all concerned (shopping centre management included) found it to be an overwhelming success.

Activities such as bush art and recycled art were arranged and enjoyed by adults, school children and pre-schoolers.

Donations of resources by CALM, the local Wildflower Society and those who gave up their "rubbish" were greatly appreciated. Similar weeks are being arranged for other shopping centres.

One of the major positive outcomes was raising awareness among locals of the existence of Forrestdale Lake (M95).

Connections with the environment also were highlighted through the use of a Connector Inspector Kit which is owned by the Gosnells City Council.

An Ecoplan Database of handy literature (mostly free) is still being constructed by Brett Tizard (contributions welcome).

It also was suggested by Brett that Ecoplan volunteers have their names added to the Infolink database (see information section).

At Armadale EarthCare Week, local groups represented included Armadale Settlers' Common Advisory Committee, Armadale Recreation and Earth Discovery Scheme, Bungendore Park Management Committee, Friends of Forrestdale Lake, System 6 Ecoplan and the local branch of the Wildflower Society.

This diverse range of organisations provided professional displays of local interest and were an important drawcard for EarthCare Week.

The regional and Government organisations also provided a source of interest for the shoppers.

Topics such as recycling, groundwater bores, bush regeneration and alternative energy were covered by organisations such as the EPA, the Water Authority, Greening Western Australia and SECWA.

The hands-on activities for the general public included daily displays of papermaking, demonstrations on alternative household cleaners and videos on feral cats, heritage trails, jarrah dieback and the local environment.

Many other activities specifically catered to children.

To guarantee a professional standard for future EarthCare weeks all of the activities will be run by EnviroRec, an environmental/outdoor recreation consultancy.

The EarthCare Week Programme includes a substantial portion of Environmental Education.

The Earth Games and similar activities provide the opportunity for students to learn about the environment while having fun.

All teachers are provided with a classroom kit, including information from each display, posters, worksheets and other educational resources for post-excursion use in the classroom.

From the reports received during 1992, Armadale EarthCare Week this proved to be a valuable resource for the teacher.

The Armadale EarthCare Week in 1991 had at least 2300 members of the general public and 560 school children pass through the display.

Central South Region

Carina Calzoni hopes that a get together with other volunteers in the Fremantle area will be arranged shortly, with a view to planning local activities.

Letters

Conservation Council view

There was a glow of optimism when System 6 — Ecoplan was launched last April.

The implementation of the System 6 recommendations and the securing of a first-rate urban conservation estate was the goal.

Despite a strong effort from Ecoplan volunteers, the voluntary conservation movement and an enormous input from the EPA's community involvement coordinator Margo O'Byrne, the gains have been modest and the looming threats have not abated.

Firstly, to some of the advances:

- The Bayswater Greenwork group has continued its excellent rehabilitation work at the Swan River Saltmarshes (M51), downstream from the Garratt Road Bridge.
- Gosnells Council has released a draft management plan for Mary Carroll Park (M76) and has welcomed public submissions and involvement in implementing the plan.
- Peter Ducie an Ecoplan volunteer —
 has undertaken to form a Friends of
 Mary Carroll Park which will ensure that
 the conservation and passive
 recreation values are preserved and
 enhanced through the management
 plan and community support.
- The Ellenbrook Conservation Group has got off the ground and is doing excellent work. Currently the outstanding wetlands and woodlands of the Ellenbrook area are threatened by urban development. So too is the precious groundwater resource, known as the Lexia scheme.
- Residents in Yangebup concerned about the proposal for a large school and church development to be called the Beeliar Catholic College to be sited in the proposed Beeliar Regional Park near Lake Kogolup referred the development to the EPA for assessment. The EPA has taken their concerns into account and agreed to public input and formal assessment at the level of Consultative Environmental Review.

On the darker side — the Perth Airport wetlands and bushland (M52) are now directly threatened.

The Federal Airports Corporation which owns the land has produced a document entitled Land Use Development Plan, which proposes further development of the bushland, including a golf course, accommodation and industrial uses.

The Perth Airport bushland and associated wetlands are of even greater importance today than 10 years ago, due to the "scorched earth" policy which predominates most developments.

With almost no trace left of the original vegetation in most suburbs, remnant vegetation in the metropolitan area must now be seen as inviolable.

Nearby System 6 area M53 Reserve 29880, Forrestfield is also likely to be lost.

A works approval has been granted by the EPA to the WA Fire Brigades Board.
Clearing of parts of the site will be allowed to proceed subject to certain conditions.

Despite the approval given to a tourist complex in the sensitive Port Kennedy area (M106) which would see the establishment of a resort motel, a marina, holiday units and — yes, you may have guessed, two golf courses — there is some positive news.

The legislation which would permit this environmental vandalism to proceed has not yet passed through the West

Australian Parliament, and it is possible that it never will, as thankfully some of our political representatives are coming to recognise the folly of such a development.

Also the Minister for Agriculture, the Hon Ernie Bridge, recently officially established a Land Conservation District Committee for the Port Kennedy area.

The Land Conservation District Committee's work over the past two years has been miraculous.

Tracks have been closed, rubbish including old car bodies have been removed, dune rehabilitation work has been carried out — all by dedicated volunteers.

On that note, I would like to end.

I guess it is really up to us to keep up the fight if we want to preserve our priceless natural heritage.

I think we should all be inspired by the work of the Ellen Brook Conservation Group, Bayswater Greenwork, the Port Kennedy Land Conservation District Committee and all the others who haven't given up.

Group concern over Ellenbrook bushland

The proposed urban development project in the Shire of Swan at Ellenbrook Estate, Bullsbrook, includes plans to destroy approximately 950 hectares of wetlands and woodlands.

These wetlands support a rich diversity of flora species as well as the declared rare Southern Brown Bandicoot.

Other vegetation types include heath and banksia woodland and there is a significant mound spring area.

Six species of priority listed flora have been identified in this proposed estate and further studies may identify more threatened species. The banksia woodlands cover an extensive area and are in a healthy condition.

According to a 1986 CALM report, studies show that "only 7 per cent of the original 281,000ha of banksia woodlands * investigated was on conservation reserves".

Since the release of these figures, it is certain that more clearing has occurred, giving a lower percentage total of this woodland which is protected for conservation purposes.

The decline in genetic diversity is an increasing threat to the natural environment.

Species are rapidly being pushed to the edge of extinction. Prevention of this genetic decline must have first priority

40-year-old reserve needs protection

Kenwick Swamp (M69) — known also as the Yule Brook Reserve — has a long history.

This 34.6ha area on Bickley Road, Kenwick was bought by the University of WA in 1949 for research and teaching by members of the Botany Department.

Because of its special nature the reserve is listed in the West Australian Government Gazette and no development of the reserve is allowed without the approval of the State Planning Commission and the local authority.

The System 6 report recognises the significance of the area saying: "Kenwick Swamp is the only surviving area of its kind and its exceptional concentrations of

usual plants makes it very attractive to botanists. The association of plants which occur there are unique and several species are unknown outside the area."

It also recognises the potential threats from nearby developments including urbanisation and recommends (M69.3) that "ways and means of providing a protective buffer area around Kenwick Swamp be sought through planning procedures".

The question of "Landscape Protection Zoning" is now being addressed by the Department of Planning and Urban

Development but it may come too late to save the Kenwick Swamp.

Privately-owned land which directly abuts the Kenwick Swamp is being proposed for housing.

The impact of such a development on the System 6 area is likely to be severe.

The housing estate proposal is to be formally assessed by the Environmental Protection Authority and the proponent's Consultative Environmental Review, which has a four-week public submission period, was released on January 6.

Wanneroo System 6 sites toured

A tour of the System 6 areas in Wanneroo was held on Saturday, November 9. The tour was organised by the Quinns Rocks Environmental Group and the Coalition for Wanneroo's Environment together with the Environmental Protection Authority.

The tour allowed the participants, who included Ecoplan volunteers, members of conservation groups and the general public, to find out about and discuss local System 6 areas.

Visits were made to Lake Joondalup (M7)
— an important wetland area, Burns
Beach — which is on the coastal strip
(M2) and adjacent Marmion Marine Park
(M10), the Mindarie Rubbish Tip (in M6),
Neerabup National Park (M6), Lake
Jandabup (M8) — a key waterbird habitat,
and Lake Gnangara (M8).

Wanneroo includes many areas which are identified in the System 6 report as having high conservation value.

These sites face several threats: diatomite mining in Lake Gnangara; nutrient enrichment is a problem for many local wetlands; developments planned on the coastal strip including marinas, resorts and urban sprawl; limestone quarrying and planned arterial roads in Neerabup National Park and the Mindarie rubbish tip which is in a proposed addition to the national park.

The tour was part of the Ecoplan campaign — serving to promote community awareness and action to protect System 6 areas.

It is vital that people get involved to ensure that local conservation areas are protected and Ecoplan offers a positive opportunity for community action to this end.

Local effort on global concerns

"Global" came face to face with "local" during the launch last year of a strategy for world conservation.

The strategy — called Caring for the Earth — was launched in Perth in one of more than 60 similar gatherings around the world held on October 21.

The launch, by the Minister for the Environment, Mr Pearce, was on the Garratt Road foreshore where Bayswater Greenwork and Ecoplan volunteers are putting their concern for the local environment into action.

The volunteers have adopted their local System 6 area and as reported in the last Ecoplan news are hard at work rehabilitating the foreshore.

Their efforts are the grass roots "realisation" of the world conservation strategy.

The strategy was produced jointly by the World Conservation Union, the United Nations Environment Programme and the World Wide Fund for Nature and is the successor to the first world conservation plan, released in 1980.

Mr Pearce said Caring for the Earth was a comprehensive strategy which not only assessed current issues such as the population explosion, recycling and reducing CFCs, but also set out a plan of action and a timetable to reach goals.

"Hundreds of reports, conferences and committees have examined our environmental problems and a lot of valuable work has been done," Mr Pearce said.

"What Caring for the Earth does is put forward a world strategy, co-ordinating our individual efforts."

In Western Australia, the EPA is coordinating the State of the Environment report to help measure the goals of the Caring for the Earth strategy.

We have been very impressed with the standard of displays and the activities organised for the shoppers, to make it the success it has been.


We have found the traffic count through the Centre this week has risen sharply and we conclude this to be a direct result of this very successful Promotion.

CIRFS UP

What can they do? Short of ringing that fount of information, Margo O'Byrne, they can call the State Library and its INFOLINK service.

INFOLINK is a database of government and non-government institutions compiled by the Library and Information Service of WA.

It is based in the State Reference Library and contains all sorts of information on a wide range of groups.

Will you and your group be listed? Registration forms are available from INFOLINK and the listing is free.

Once you have been listed on INFOLINK you also are listed in the Perth Zoo's ENVIROLINK.

What does all this have to do with surfing? CIRFS or the Community Information Resource File Service provides community groups with a card index about the groups that interest you.

You receive a listing of the names and code numbers of the complete INFOLINK database (more than 700 listings).

Choose up to 500 organisations and the cards are sent to you. The information includes contact names and addresses, the aims of the organisation, membership, and meeting times.

You get regular updates as well as an additions list and the service is provided free.
