Swan River foreshore work

In February the Environment and Heritage Minister, Dr Judy Edwards, announced Riverbank funding for foreshore restoration work in the City of Subiaco and the Town of East Fremantle.

The City of Subiaco has repaired a 100metre section of walling at JH Abrahams Reserve. The work will end continual erosion of the shoreline behind the wall and reinstate the damaged pathway. The new wall ensures that public access and recreational use of this popular area will be maintained.

The Town of East Fremantle has started reshaping a 100-metre section of Norm McKenzie Reserve to increase the stability of the beach. The three-week project began on 20 February 2003. The area was reclaimed in the 1960s and has gradually eroded to a point where existing recreational infrastructure is at risk and continual erosion of the shoreline is occurring.

A section of existing carpark and riverwall has been removed to facilitate reshaping of the foreshore. The design minimises the amount of foreshore protection work required and will create a larger beach area. The project provides increased opportunity for public recreation in an already popular area.

The Trust contributed \$8 300 to the City of Subiaco and \$17 217 to the Town of

East Fremantle to match local government contributions.

The Riverbank program fulfils a preelection Government promise to address years of neglect of the riverbanks, with \$500 000 over four years being used to restore and protect the Swan, Canning and Lower Helena river foreshores.

SCCP SWAN-CANNING CLEANUP PROGRAM UPDATE Clean Up a great success

National Clean Up Australia Community Day, held annually on the first Sunday in March, once again prompted the Trust to clean up Point Walter Reserve for a successive third year. It was a great success with 100 volunteers picking

up 124 bags of rubbish. The unusual items found were a cash register, a brand new credit card and a mannequin's arm. Unfortunately the bulk of the rubbish was the ever present plastic bags, takeaway food containers, bottles, cans and broken glass.

This day followed the Trust's Clean Up Australia Business Day on 25 February 2003 when four members of the Perth Glory soccer team joined 30 volunteers from the Swan River Trust, Water and Rivers Commission and Department of Environmental Protection. The group headed down to the Canning River between Cloisters Boat Ramp and the Canning Bridge before work to collect rubbish along the river foreshore. Two hours and 52 bags later saw the area looking spectacular.


Swan-Canning catchment groups receive funding

As part of the Swan River Trust's Swan-Canning Cleanup Program, \$425 000 in direct funding is being provided to catchment groups in the Swan-Canning catchment for the coming year.

Environment and Heritage Minister Dr Judy Edwards said the continued support to catchment groups is a major part of the Cleanup Program working to reduce nutrients entering the Swan and Canning rivers. Now in its fourth year of Action Plan implementation, this financial support will fund salaries for coordinator, on-ground project and education officer positions as well as provide much needed additional support for eight catchment groups. These groups are in priority areas where nutrient problems are the worst and where the most work needs to be done.

"The Cleanup Program also distributed a further \$100 000 to community groups through the Swan Catchment Urban Landcare Program (SCULP). Dr Edwards said the Trust's Cleanup Program contribution complements the major contribution from Alcoa. This year over \$400 000 was provided to community groups for on-ground works. The cheques were presented at a ceremony on 6 February 2003.

"Community participation and the work of catchment groups is fundamental to the achievement of the Cleanup Program's goals.

City of Perth's irrigation project

There has been much activity on the Ozone Reserve near the Swan River foreshore in East Perth. The City of Perth's first stage of its irrigation and storage lakes project is in full swing.

The City of Perth is undertaking stage one as part of a larger project to establish an efficient, fully automated irrigation system for the river foreshore parklands area extending from the Esplanade Reserve to Heirisson Island.

The current irrigation system draws water from an artesian bore located at Langley Park. At present irrigation pipes must be moved manually. In the past the majority of irrigation occurred during the day resulting in high evaporative losses. Irrigation is done in the early morning but the pipes still need to be moved manually.

Water from the bore also has a high iron and manganese content which results in staining of footpaths, buildings and other infrastructure, and causes clogging of the irrigation pipes. The City of Perth plans to treat the bore water to remove iron and manganese to reduce the clogging of pipes and aesthetic problems, and to install an irrigation system that will enable a more reliable and efficient use of water.

Water will be pumped from the bore on Langley Park to a water treatment plant where it will be treated to remove dissolved iron and manganese. The treated water will then be pumped to the lake on

The site is currently an open reserve with very little vegetation. The addition of lakes landscaped with native reeds and vegetation will attract waterbirds, provide
