## **REASON FOR ACTION:**

Main Roads Western Australia requested the excision of 25.9951 hectares from State Forest No. 26 to facilitate upgrades to a 15 kilometre portion of Collie-Preston Road and to rationalise the tenure of portions of the road which had been constructed outside the designated road reserve.

Main Roads Western Australia will close portions of unconstructed road reserve for addition to State Forest, 2.1402 hectares is proposed to be added to State Forest No. 26.

An order was published in the Government Gazette on 27 March 2020 to finalise the excision.

The powers that may be exercised during the period by which the state of emergency declaration is extended are limited as follows: Nil.






- This declaration has effect from 12 am on 19 March 2020 and remains in force until—

  - (b) It is revoked under section 59 of the *Emergency Management Act 2005*.






