ACTION

Excision of Lot 503 on Deposited Plan 406933 from State Forest No. 36.

Total Area: 26326.97 to 26326.44 hectares

REASON FOR ACTION:

The Shire of Nannup and the owner of Lot 14497 on Deposited Plan 406932 are seeking to rationalise the boundaries of Lot 14497 and formalise the constructed access to this and the adjacent property. To facilitate the dedication of the constructed alignment of Ethel Road an excision of 0.5343 hectares was requested. The excisions will ensure that the constructed alignment is dedicated as road reserve. A 0.45 hectare portion of unconstructed road reserve is proposed to be added to the adjacent state forest once the unconstructed portions of the road are closed.

An order was published in the Government Gazette on 8 December 2017 finalising the excision from State Forest No 36.

Made by the Minister for Environment under section 9(3)(b) of the *Conservation and Land Management Act 1984*.

1. Citation

This order may be cited as the *Conservation and Land Management (Excision from State Forest) Order (No. 5) 2017*.

2. Commencement

This order comes into operation as follows—

- (a) clauses 1 and 2—on the day on which this order is published in the *Gazette*;
- (b) the rest of the order—on the day after that day.

3. Portions of State Forest No. 36 excised

The area described in Schedule 1 is ordered to be excised from State Forest No. 36.

Schedule 1—Land no longer part of State Forest No. 36

All that portion of land situated about 28 kilometres north-west of Pemberton and comprising of Lot 503 on Deposited Plan 406933.

Area: 0.5343 hectares

4. Purpose of excision

The area described in Schedule 1 is for the purpose of facilitating the dedication of a portion of Ethel Road constructed outside the road reserve.

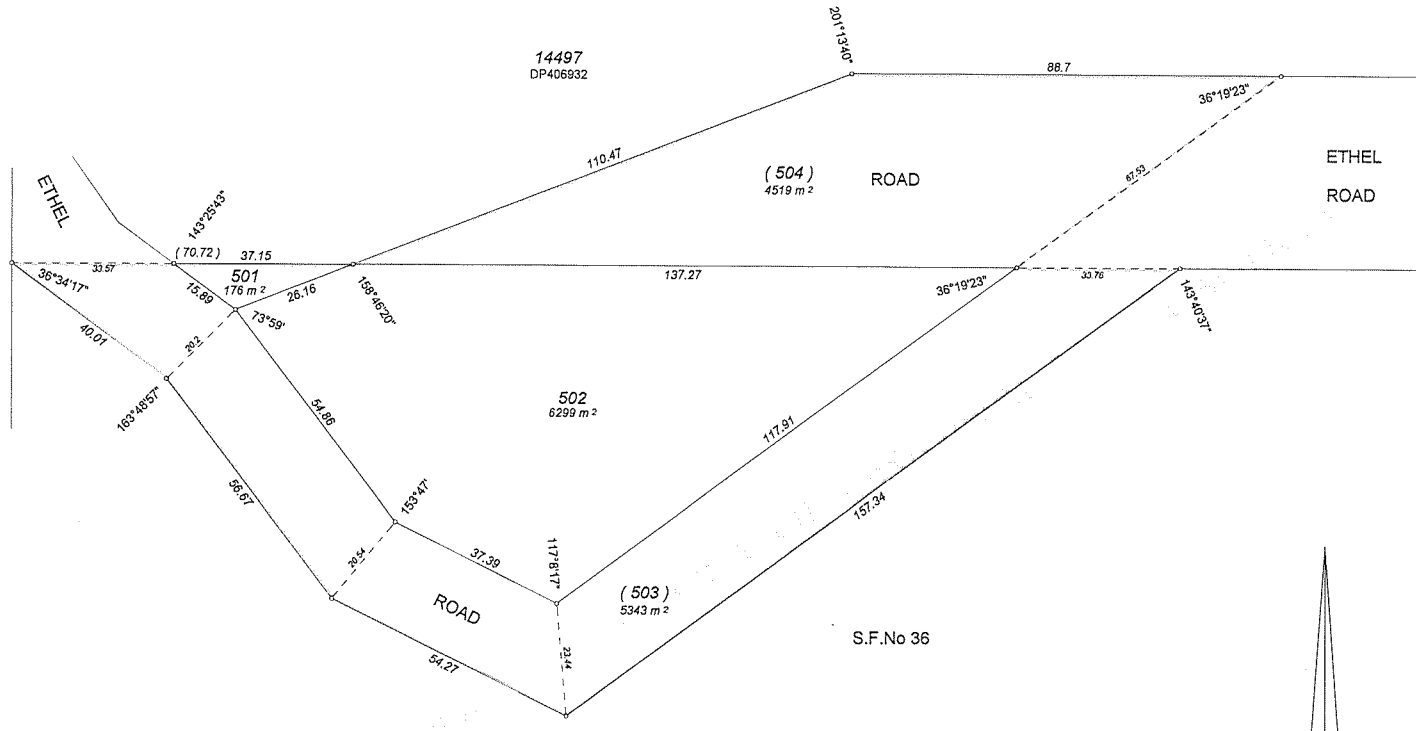

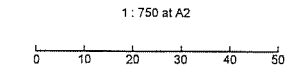
3. Variation of retail trading hours

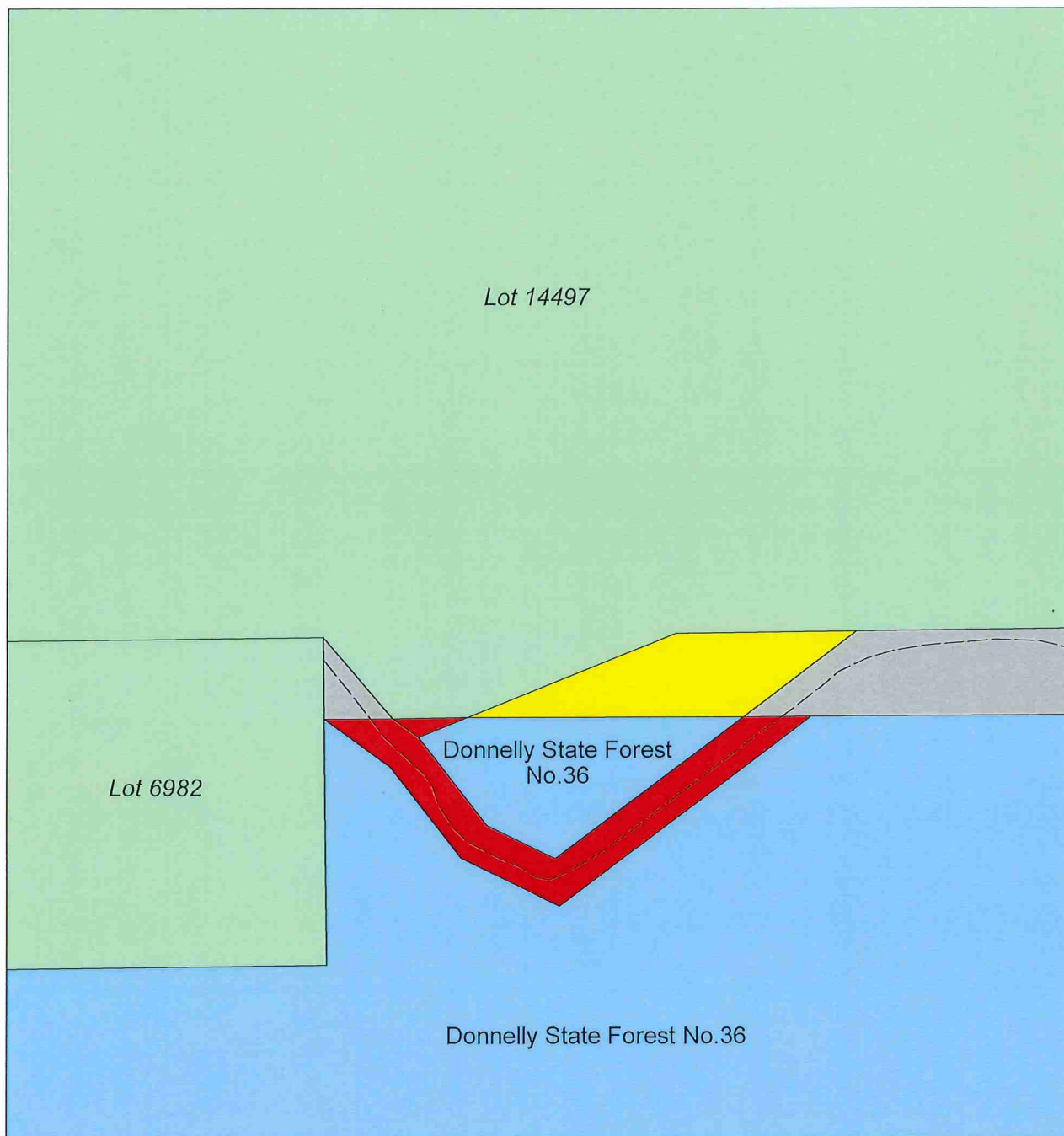
