REASON FOR ACTION

Palgarup Mill is currently leased by Australian Craftwood and Timbers who propose to sublease the site to Australian Peat Technologies (APT). APT propose to use the site to process peat extracted from a nearby peat mine at Lake Muir. To facilitate the sublease the Palgarup Mill site was excised from Timber Reserve 116/25 and created as a new separate CALM Act section 5(1)(h) reserve with the purpose of 'natural resource processing and ancillary purposes'.
