 - the amendment of Reserve No. 1017 (Victoria Location 9316) "Protection of Flora" to include Victoria Location 11565 and of its area being increased to 548.5286 hectares.
 - c) the purpose of Reserve No. 1017 (Victoria Locations 9316 and 11565) being changed from "Protection of Flora" to "Conservation of Flora and Fauna".
